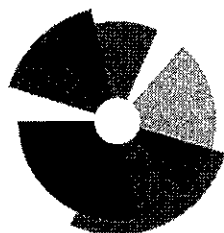

## INDEPENDENT AUDITORS' REPORT

To the Benefits Committee and Plan administrator of the  
Aya Healthcare Services, Inc. 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed audits of the financial statements of Aya Healthcare Services, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Aya Healthcare Services, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **NOTE 1 – PLAN DESCRIPTION**

The following description of the Aya Healthcare Services, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan's sponsor is Aya Healthcare Services, Inc. (the "Company" or the "Employer").

General

The Plan was initially adopted on January 1, 2002 and was amended and restated on January 1, 2022. The Plan is a defined contribution plan covering all eligible fulltime employees of the Company. Employees are eligible to participate in the Plan after attaining the age of 21 and completion of four consecutive months of employment with the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Participant Contributions

The 401(k) salary deferral option allows employees to defer a portion of their salaries for income tax purposes through contributions to the Plan. Participants may elect to defer up to 100% of their Plan year compensation each year up to the maximum amount permitted under the Internal Revenue Code (the "Code") (\$23,000 in 2024). Participants who have attained age 50 before the end of a calendar year are eligible to make catch-up contributions of \$7,500 (for a total of \$30,500 in 2024).

Rollover Contributions

The Plan allows for participants in a former employer's qualified plan to contribute direct rollovers to the Plan.

Employer Safe Harbor Matching Contributions

The Plan also allows for the Employer to make safe harbor matching contributions. Participants are eligible to participate in safe harbor matching contributions after completing one year of eligible service of 1,000 hours. During the year ended December 31, 2024, the Employer contributed safe harbor matching contributions equal to one dollar for each dollar that a participant elected to defer, up to 3% of compensation and an additional 50% of the next 2% of eligible compensation (including catch-up contributions) on a per pay period basis. Employer safe harbor matching contributions made to the Plan for the year ended December 31, 2024 totaled \$31,457,525.

Employer Discretionary and Matching Contributions

The Plan allows for the Employer to make discretionary and matching contributions. The Employer can make a contribution based on discretionary percentage of each participant's annual compensation. Participants are eligible to participate in discretionary and matching contributions after completing one year of eligible service. There were no discretionary and matching contributions made to the Plan for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with participant's contributions, Employer contributions and allocations of Plan earnings or losses and charged with an allocation of administrative expenses. Allocations are based on participant earnings or losses or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into various investment options offered by the Plan.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Participants are immediately 100% vested in all Employer safe harbor matching contributions. Vesting in the Employer's discretionary and matching contribution portion of their accounts is based on years of continuous service. The participant vesting schedule for the Employer's discretionary and matching are as follows:

Participants become 100% vested in Employer discretionary and matching contributions upon reaching retirement age, death or disability.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the value of their vested account balance on the loan date. Loan terms range from one to five years or up to 30 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the prevailing rate. The interest rates on outstanding participant loans were 4.25% to 9.50% at December 31, 2024 and 2023. Principal and interest are paid ratably through payroll deductions.

Forfeitures

Any participant who terminates employment prior to the normal retirement date for reasons other than death or disability, forfeits all non-vested Employer discretionary and matching contributions. Forfeitures of non-vested participant accounts can be used to first reduce Plan expenses and then to reduce future Employer contributions. At December 31, 2024 and 2023, the forfeited non-vested account balance totaled \$29,056 and \$31,497, respectively.

Forfeitures (continued)

There were approximately \$3,400 of forfeitures used to reduce Plan expenses during the year ended December 31, 2024.

Payment of Benefits

Upon disability, retirement, termination, death, or hardship, participants may elect to receive a distribution of their account (as defined) in lump sum, or defer distribution if the account exceeds \$5,000. However, if such a participant's vested account balance is less than \$5,000, the Plan administrator may roll the balance into an individual retirement account, unless the participant elects otherwise. Also, at its discretion, the Plan administrator may elect to distribute vested account balances.

Hardship Withdrawals

Participants may withdraw their vested contributions in the event of hardship as defined in the Plan agreement.

SECURE 2.0 Act of 2022

The Plan has implemented certain requirements of the SECURE 2.0 Act of 2022 ("SECURE 2.0"). The provision implemented in 2024 includes an increase in the required minimum distribution age from 72 to 73. Future provisions will be adopted at later dates, as necessary, to comply with the requirements of SECURE 2.0.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Payment of Benefits

Distributions to participants are recorded when paid. As of December 31, 2024 and 2023, there were no distributions payable related to terminated Plan participants.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded.

If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Administrative Expenses

The Company pays expenses incurred for the administration and operation of the Plan. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Other administrative fees associated with distributions and loans are paid by the participants. For the year ended December 31, 2024, administrative expenses paid by the Plan were \$2,185,116.

Investment Valuation and Income Recognition

Mutual funds are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9 for discussion of fair value measurements. Fixed annuities are fully benefit-responsive, and therefore, reported at contract value. See Note 8 for discussion of the group annuity contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends (if declared) are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold during the year as well as held at year end.

Subsequent Events

The Plan administrator has evaluated subsequent events, as defined by Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 855, Subsequent Events, through the date that the financial statements were available to be issued on July 29, 2025.

**NOTE 3 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Employer discretionary and matching contribution accounts. In the event of Plan termination, all amounts credited to accounts of participants shall be paid to each participant in accordance with the Plan agreement.

**NOTE 4 – RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC as of December 31, 2024 and 2023 and for the year ended December 31, 2024, who are the Custodians of the Plan and therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid to the Custodians totaled \$1,688,028 for the year ended December 31, 2024.

**NOTE 5 – TAX STATUS**

The Plan utilizes a Defined Contribution Volume Submitter Plan of a third-party administrator. The third-party administrator obtained its latest advisory letter on June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the document is designed and in compliance with the applicable requirements of the Code. Although the document has been amended and restated since receiving this determination letter, the Plan administrator, the Plan's trustee and third-party administrator believe the Plan is designed and currently operating in compliance with the applicable requirements of the Code; and therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 6 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and change in net assets available for benefits.

**NOTE 7 – INFORMATION CERTIFIED BY THE CUSTODIANS**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Empower Annuity Insurance Company of America and Empower Trust Company, LLC as of December 31, 2024 and 2023 and for the year ended December 31, 2024, the Custodians, have certified to the completeness and accuracy of all investments and related investment activity and notes receivable from participants and related activity in the accompanying statements of net assets available for benefits the statement of changes in net assets available for benefits, and the accompanying supplemental schedule of assets (held at end of year).

**NOTE 8 – FIXED ANNUITIES**

The Plan has a group annuity contract with Empower Annuity Insurance Company of America that invests contributions in the Key Guaranteed Portfolio Fund. The Key Guaranteed Portfolio Fund is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. Contract value approximates fair value.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest is based on a formula agreed upon with the issuer but may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following:

- (a) Amendments to the Plan document (including complete or partial Plan termination or merger with another plan),
- (b) Changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions,
- (c) Bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or
- (d) The failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

**NOTE 9 – FAIR VALUE MEASUREMENTS**

The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

- Level 1 - Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.
- Level 2 - Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:
  - Quoted prices for similar assets and liabilities in active markets
  - Quoted prices for identical or similar assets or liabilities in markets that are not active
  - Observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means
- Level 3 - Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include managements own assumptions about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methods used for assets measured at fair value. There was no change in the fair value methodology used at December 31, 2024 and 2023.

- Mutual Funds - The fair values of these securities are based on observable market quotations for identical assets and are priced on a daily basis at the close of business.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement.
