### Opinion

We have audited the financial statements of Conlin's Furniture, Inc. Employee Health Benefit Plan (Plan), an employee benefit plan subject to the Employee Retirement Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and benefit obligations of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and benefit obligations for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. ## **Note 1 - Description of Plan**

The following description of the Conlin's Furniture, Inc. Employee Health Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### **General**

The Plan was established as a fully insured plan by Conlin's Furniture, Inc. (Sponsor) beginning January 1, 2007. Effective January 1, 2018, the Plan's funding was changed to self-insure for certain benefits.

Generally, the Plan provides health and welfare benefits to full-time employees regularly scheduled to work 30 or more hours per week. Employees are eligible to apply for participation within 31 days of eligibility. If the application is made within 31 days of the date of hire or the date the employee first becomes eligible under the Plan, the effective date of coverage will be the first day of the month following 30 days of employment.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### **Benefits**

The Plan provides medical, pharmacy, dental, vision, life insurance, and voluntary life and accidental death and dismemberment benefits to eligible employees of Conlin's Furniture, Inc. and their covered dependents as defined by the Plan document. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

### **Insured Benefits**

The Plan fully insures the dental, vision, life insurance, and voluntary life and accidental death and dismemberment benefits through insurance contracts. Premiums for the fully insured benefits are recorded as premium payments in the accompanying statement of changes in net assets available for benefits.

### **Stop Loss Coverage**

The Plan has entered into a stop loss insurance arrangement in an effort to limit its exposure for self-insured benefits. The Plan is responsible for individual claims up to \$60,000 per year. The Plan also has aggregate stop-loss insurance which provides reimbursement up to annual limits in the event the aggregate losses exceed a predetermined amount during the year.

### **Self-Insured Benefits**

The Plan is "self-insured" for medical and pharmacy benefits up to individual and aggregate stop-loss limits. The claims for self-insured benefits are processed by the Plan's third-party claims processor under an administrative services only (ASO) arrangement. The claims processor pays claims directly to, or on behalf of participants, and is then reimbursed by the Plan. Despite the Plan's utilization of a third-party claims processor, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (PBM), which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

### **Contributions**

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. Participants pay the full cost of voluntary supplemental and dependent life insurance and supplemental accidental death and dismemberment insurance programs, based on the current group rate premium cost. The Sponsor pays the full cost of basic life insurance, basic accidental death and dismemberment insurance, and stop loss insurance.

The Sponsor makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Sponsor on a pay-as-you-go basis.

### **Plan Termination**

Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to modify the benefits provided to and contributions required of active employees, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA. In the event of termination of the Plan, remaining plan assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Sponsor or be used for purposes other than for the exclusive benefit of the Plan's participants.

## **Note 2 - Significant Accounting Policies**

### **Basis of Accounting**

The accompanying financial statements have been prepared using the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect reported amounts of assets, liabilities, benefit obligations, and changes therein and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

### **Payment of Benefits**

Premiums paid by the Plan are recorded as premium payments in the accompanying statement of changes in net assets available for benefits.

Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processor that have yet to be reimbursed by the Plan are recorded as due to claims administrator in the accompanying statements of net assets available for benefits. These payments are recorded as claims paid in the accompanying statement of changes in net assets available for benefits.

### **Stop Loss**

Premiums for stop loss insurance are included in premium payments in the accompanying statement of changes in net assets available for benefits. Stop loss refunds totaling \$370,529 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

### **Refunds**

Refunds due from the Plan's PBM are recorded when earned. Pharmacy rebates totaling \$60,968 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

### **Receivables and Allowance for Credit Losses**

The Plan has tracked historical loss information for its receivables and determined that all receivables are fully collectible and no allowance for credit losses is needed.

Management believes that the historical loss information it has compiled is a reasonable base on which to determine expected credit losses for receivables held at December 31, 2024 and 2023, because the composition of the receivables at those dates is consistent with that used in developing the historical credit expectations (i.e. the similar risk characteristics of its receivables). Additionally, management has determined that the current and reasonable and supportable forecasted economic conditions are consistent with the economic conditions included in the historical information. As a result, the historical loss rates have not been adjusted for differences in current conditions or forecasted changes. Accordingly, the allowance for credit losses at December 31, 2024 and 2023, is \$-0-.

### **Investment Valuation and Income Recognition**

The Plan's investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies and procedures utilizing information provided by investment advisors and custodians. See Note 3 for discussion of fair value measurements.

Interest income is recorded on the accrual basis.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to difference reporting requirements on Form 5500.

**Expenses**

Administrative expenses incurred in the administration of the Plan that are paid by the Plan include medical claim administrative fees, accounting, and advisory fees. These expenses are recorded as deductions in the accompanying statement of changes in net assets available for benefits. Expenses that are paid by the Sponsor are excluded from these financial statements.

**Benefit Obligations**

Plan obligations at December 31, 2024 and 2023, for medical and pharmacy claims incurred by participants but not reported at that date and claims payable are estimated based on an analysis of these claims paid subsequent to the Plan year end. The benefit obligations as of December 31, 2024 and 2023, have been reduced by approximately \$32,000 and \$36,000, respectively, in stop loss reimbursements associated with the benefit obligation claims to reflect the estimated ultimate cost to the Plan of settling such claims. Such estimated amounts are included in the accompanying statements of benefit obligations in the amounts currently payable.

**Subsequent Events**

The Sponsor has evaluated subsequent events through July 30, 2025, the date which the financial statements were available to be issued.

**Note 3 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritized the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market deposit accounts – Valued at carrying value, which approximates fair value, based on the amount of net contributions plus any investment earnings allocated to the account.

### Note 4 - Tax Status

No trust has been established for the optional employee post-tax contributions to the Plan. These funds are of a conduit nature wherein the Sponsor receives the contributions in order to pay the insurance premiums. Per Internal Revenue Code Regulation 301.7701-6(b)(2), as there is no management of these funds, this arrangement is more of an agency relationship and no Form 1041 fiduciary income tax return is required.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 5 - Party-in-Interest Transactions

As described in Note 1, the Plan has arrangements with service providers. These transactions are party-in-interest transactions under ERISA.

**Note 6 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The estimated liability for claims incurred but not reported and claims payable is based on historical trend information, which is subject to change. Due to uncertainties inherent in the estimation and assumption process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

**Note 7 - Concentration of Credit Risk**

The Plan maintains cash and money market deposit accounts, the balances of which are periodically in excess of federally insured limits. Accounts are guaranteed by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000 per depositor, per insured bank, for each account ownership category. At December 31, 2024 and 2023, the Plan had approximately \$487,000 and \$588,000, respectively, in excess of FDIC-insured limits.

**Note 8 - Reconciliation of Financial Statements to Form 5500**
