### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Hudson Technologies 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). ### 1. Description of the Plan

The following description of the Hudson Technologies 401(k) Savings Plan (the Plan) provides only general information. Participants of the Plan should refer to the Plan document for a complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan that became effective July 5, 1996 and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan covers all eligible employees of Hudson Technologies Company and its subsidiaries, Hudson Holdings, Inc. and Hudson Technologies, Inc. (collectively, the Company), who are age 20 or older. There is no minimum service requirement to enter the Plan. Entry date is the date when the employee meets the age requirement. The Board of Trustees oversees governance of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees.

Effective January 1, 2023, the Plan was restated and adopted a pre-approved plan design with Qualified Automatic Contribution Arrangement.

#### *Administration of the Plan*

Empower Trust Company, Empower Life & Annuity Company of New York, and Empower Annuity Insurance Company of America and its subsidiaries, including Empower Retirement LLC (collectively, Empower) are the recordkeeper and trustee of the Plan. The administrator of the Plan is the Company. The trustee holds all assets of the Plan in accordance with the service provider contract with the Company.

#### *Contributions*

Each year, participants may elect to contribute up to 100% of their annual eligible compensation, as defined in the Plan document, not to exceed amounts prescribed by the Internal Revenue Service (IRS). Participants are automatically enrolled in the Plan at the default rate set at 4% of eligible compensation. This rate will increase on January 1<sup>st</sup> each year by 1%, not to exceed 15% of eligible compensation. Current eligible participants whose salary deferral rate is less than the default rate will automatically be increased to the automatic deferral rate unless the participant enters a new salary deferral election on or after the effective date of the automatic deferral provisions. Participants with a salary deferral rate of 0% are re-automatically enrolled on January 1<sup>st</sup> annually. Participants who are eligible to make elective deferrals under the Plan, and who have attained age 50 before the close of the Plan year, are eligible to make catch-up contributions, not to exceed amounts prescribed by the IRS. Participants may contribute eligible amounts representing distributions from other qualified defined contribution plans and defined benefit plans. Effective January 1, 2024 the Plan allows for Roth contributions.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, common collective trusts, and a guaranteed interest account as investment options.

Effective January 1, 2023, the Plan provides Safe Harbor matching contributions equal to 100% of participant deferrals up to 1% of the participant's compensation, as defined in the Plan document,

plus 50% of participant deferral in excess of 1% but not in excess of 6% of the participant's compensation. Additionally, the Plan allows for discretionary Non-Elective Contributions of a uniform percentage of a participant's compensation. There were no discretionary Non-Elective Contributions for 2024.

### ***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Company's contributions, and an allocation of Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon.

As of January 1, 2023, the Plan adopted a two-year cliff vesting schedule related to Safe Harbor matching contributions made relating to pay periods after January 1, 2023. Participants are 100% vested following two years of service, and 0% vested prior to two years of service.

Non-Elective Contributions relating to pay periods after January 1, 2023 are vested as follows:

### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Participants may have two loans outstanding at any time. The notes are secured by the balance in the participant's account. Interest rates are based on the prime interest rate plus 1%. Principal and interest are paid ratably through payroll deductions with a maximum term of five years. If the note is used to purchase a primary residence,

then a longer repayment term is permitted. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the Internal Revenue Code (IRC).

### ***Payment of Benefits***

On termination of service, participants will receive an amount equal to the value of the participant's vested interest in their account. Participants become 100% vested upon death, disability, or retirement, in accordance with provisions in the Plan document. If the vested account balance upon termination is less than \$1,000, a participant will automatically receive the value of the vested interest in their account, as soon as administratively practicable. If the vested account balance upon termination is between \$1,000 and \$5,000, the vested balance will be automatically rolled over to an Individual Retirement Account (IRA) selected by the Plan for the participant's behalf, as soon as administratively practicable, unless the participant elects to receive a lump-sum distribution or to have the balance rolled over to another IRA or qualified retirement plan. If the vested account balance upon termination is over \$5,000, the participant must consent to the distribution of the vested value in their account and may elect to receive the balance as a lump-sum cash distribution, in installments over a specified period not to exceed the life or life expectancy of the participant, or the participant may roll it over to an IRA or qualified retirement plan. Effective April 1, 2024 the \$5,000 limit was increased to \$7,000.

Additionally, during 2024 the Plan also adopted certain special distribution rules related, to Qualified Disaster Recovery Distributions, Terminal Illness Penalty Tax Exceptions, and Domestic Abuse Distribution in accordance with the Secure Act 2.0, no formal amendment of the Plan was required.

Hardship withdrawals are permitted as described in the Plan document.

### ***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$48,761 and \$47,629, respectively. These accounts can be used to reduce future employer contributions or to pay administrative expenses. \$42,599 of forfeited funds were used to pay administrative expenses and \$63,637 were used to fund employer contributions during 2024.

## **2. Summary of Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies. See Note 4 for a discussion of fair value measurements.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded when received rather than on an ex-dividend basis and the effect is not material to a fair presentation. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

### ***Payment of Benefits***

Benefits are recorded when paid.

### ***Administration Expenses***

Administrative expenses of the Plan are paid by the Company, except for certain expenses that are charged to participant accounts. Certain investment expenses that are charged within investments are presented net of the appreciation in fair value of investments. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. All other expenses of the Plan for the year ended December 31, 2024 were paid by the Company and are excluded from these financial statements.

## **3. Certified Investment Information**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024, related to total investments and notes receivable from participants held as of December 31, 2024 and 2023, and net investment income and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower, a qualified institution.

### 4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds* - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Investment Trusts (CITs)* - CITs are valued at the NAV of units of a collective trust fund. The NAV, as provided by the trustee of the CIT, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The CITs provide for daily redemptions by the Plan at reported NAV with no advance notice. There are no unfunded commitments related to these investments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of

## **5. Investment Contract with Insurance Company**

The Massachusetts Mutual Life Insurance Company (MassMutual) Guaranteed Interest Account (Account) is a fully benefit-responsive investment contract with MassMutual. The Account is made available to the Plan through a group annuity contract. Contributions are deposited and are invested in a broadly diversified portfolio within MassMutual's general account. Investments in the general account are managed by Barings LLC, a subsidiary of MassMutual. The Account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The Account is included in the financial statements at contract value as reported to the Plan by MassMutual. MassMutual guarantees to repay the principal plus accrued interest.

Because the Account meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Account. The Account is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by MassMutual, represents contributions made to the Account, plus earnings, less participant withdrawals and administrative expenses. Participants may direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of MassMutual or otherwise. The contract value of the Account as of December 31, 2024 and 2023 was \$1,216,260 and \$891,081, respectively.

Certain events limit the Plan's ability to transact at contract value with MassMutual. Such events include the following: (a) amendments to the Plan documents; (b) distributions resulting from employer-initiated events, such as complete or partial Plan termination; (c) merger, layoffs, and early retirement incentive programs; (d) changes to the Plan's prohibition on competing investment options; (e) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (f) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

MassMutual was acquired by Empower during 2022; there was no change in the contract.

### **6. Related Party Transactions and Party-in-Interest Transactions**

Certain Plan investments are shares of mutual funds managed by the Plan's recordkeeper; therefore, these transactions qualify as party-in-interest transactions. Participant loan and distribution processing fees are paid to Empower by participants. The Plan also issues loans to participants that are secured by the vested balance of the participants' accounts.

These party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

### **7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

### **8. Tax Status**

The IRS has determined and informed Empower by a letter dated June 30, 2020 that its Volume Submitter Profit Sharing Plan with Cash or Deferred Arrangement (CODA) is designed in accordance with applicable sections of the IRC. The Plan adopted Empower's Volume Submitter Profit Sharing Plan with CODA. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment

securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **10. Prohibited Transactions**

As reported on the supplemental Schedule H, Line 4a - Schedule of Delinquent Participant Contributions for the year ended December 31, 2024, during the years ended December 31, 2022 and December 31, 2021, certain participant loan repayments were not remitted to the Plan within the period prescribed by DOL regulations. These transactions constitute non-exempt party-in-interest transactions or prohibited transactions as defined by ERISA. The related lost earnings were remitted to the Plan during 2024.

### **11. Subsequent Events**

The Plan evaluated the accompanying financial statements for subsequent events through July 30, 2025 and transactions on the date these financial statements were available for issue.
