## Independent Auditor's Report

To the Participants and Plan Administrator of the

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Fort Worth Transportation Authority Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statements of changes in net assets available for benefits for the years ended December 31, 2023 and 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the years ended December 31, 2023 and 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

## Notes to Financial Statements

### Note 1. Description of the Plan

The following description of the Fort Worth Transportation Authority Retirement Plan (f/k/a McDonald Transit, Inc. 401(k) Retirement Plan) (the Plan) provides only general information. Participants should refer to the *Plan document* for a more complete description of the Plan's provisions, which is available from Plan management.

#### General

The Plan is a defined contribution plan covering all non-highly compensated employees of McDonald Transit Inc. and Fort Worth Bike Sharing, Inc. (Bike Share) (collectively, the Company) who have reached the age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Fort Worth Transportation Authority dba Trinity Metro (Trinity Metro) has contracted with McDonald Transit, Inc. to provide all of the employees necessary to provide fixed route bus, paratransit, and maintenance operations and with Bike Share to provide maintenance for equipment and bicycles for operation of a bicycle-sharing program. Plan management is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Plan was amended with an effective date of January 1, 2022 to change the plan sponsor from McDonald Transit, Inc. to Trinity Metro. Bike Share was removed as a related participating employer as a result of this amendment. The Plan was amended with an effective date of March 22, 2022 to change the plan sponsor from Trinity Metro to McDonald Transit, Inc.

Effective October 2, 2023 the Plan was amended to change the plan from a 401(k) plan to a 401(a) plan. As a result of this change, the plan name changed from McDonald Transit, Inc. 401(k) Retirement Plan to Fort Worth Transportation Authority Retirement Plan. The employer was changed from McDonald Transit, Inc. to Trinity Metro. The Plan covers all leased employees and residents of Puerto Rico of Trinity Metro and Metro Area Transit System Corporation who have reached the age eighteen or older.

## Notes to Financial Statements

### Contributions

Participants direct the investment of their contributions into various investment options offered by the Plan. Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also designate some of their contributions as after tax contributions to a Roth 401(k) option. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan includes an auto-enrollment provision whereby all newly eligible employees except Bike Share employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. The auto-enrollment provisions also apply to active participants who have not made a salary deferral election or who have elected not to contribute to the Plan unless such election was made within the six months preceding the solicitation date. Automatically enrolled participants have their deferral rate set at 4 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The automatic deferrals will increase by 1 percent annually up to a maximum deferral rate of 9 percent. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make discretionary nonelective contributions and/or discretionary matching contributions. For each of the years ended December 31, 2023 and 2022, the Company made a discretionary contribution of three percent and a matching contribution of 100 percent of the first one percent of eligible compensation that a participant contributes to the Plan, an additional contribution of one percent of eligible compensation for participants that contribute between two and three percent of their eligible compensation to the Plan, and an additional one percent of eligible compensation for participants that contribute four percent of their compensation to the Plan. The Company contributions are invested as directed by the participant. Contributions are subject to certain limitations.

Effective October 2, 2023, participants may contribute voluntary after-tax contributions to the Plan. Other participant contributions are not permitted as of the effective date. Company discretionary and matching contributions are based on a participant's elective deferrals to the Fort Worth Transportation Authority Deferred Compensation Plan.

### Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## Notes to Financial Statements

### Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Prior to October 2, 2023, vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

Effective October 2, 2023, participants are vested immediately in the employer contributions plus actual earnings thereon.

### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by Plan management. Principal and interest are paid ratably by participants directly to the trustee. Effective October 2, 2023, there are no minimum loan amounts and bear interest rates set at 2% above the prime rate, as defined.

### Payment of Benefits

Upon retirement, death, disability or termination of employment, a participant (or the participant's beneficiary, if applicable) may elect to receive a lump sum distribution, or an annuity providing their vested account balance exceeds \$5,000. Participants may receive a hardship distribution from their vested account balances subject to certain limitations, as defined in the Plan document.

### Forfeited Accounts

At December 31, 2023 and 2022, forfeited nonvested accounts totaled \$1,051 and \$152,636 respectively. These accounts will be used to reduce future Company contributions and to pay Plan expenses. During 2023 and 2022, Company contributions were reduced by \$330,232 and \$327,348, respectively, to pay Plan expenses. During 2023 and 2022, Plan expenses were reduced by \$6,797 and \$26,832, respectively, to pay Plan expenses.

### Note 2. Summary of Significant Accounting Policies

#### Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

#### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (US GAAP) requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded at the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 and 2022. Delinquent participant loans are recorded as distributions when a distributable event, such as termination, death, or disability, has occurred.

#### Payment of Benefits

Benefits are recorded when paid.

#### Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

#### Subsequent Events

The Plan has evaluated subsequent events through January 29, 2025, the date the financial statements were available to be issued.

### Note 3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplementary information, including investments and notes receivable from participants held at December 31, 2023 and 2022, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (Fidelity), the trustee of the Plan.

### Note 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

## Notes to Financial Statements

Collective trust fund: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

### **Note 5. Related Party Transactions and Party in Interest Transactions**

Certain Plan investments are shares of mutual funds and a collective trust fund provided through Fidelity and its affiliates. Fidelity is the record keeper and trustee for the Plan and, therefore, these transactions qualify as party in interest transactions. All investment fund earnings or losses posted to each Plan participant's account are net of investment management fees charged by each investment fund under the Plan. The Plan has a number of service providers. Such providers are parties in interest under ERISA.

### **Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their Company contributions.

### **Note 7. Tax Status**

Effective November 1, 2011, the Plan adopted a nonstandardized prototype defined contribution profit sharing plan with Internal Revenue Code Section 401(k) Cash or Deferred Arrangement (CODA) which received a favorable opinion letter from the Internal Revenue Service (IRS) dated March 31, 2014. The Plan has been amended since the date of the last amendment covered by the above mentioned determination letter. However, Plan management believes that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Effective March 22 2022, the Plan adopted a nonstandardized prototype defined contribution profit sharing plan with Internal Revenue Code Section 401(k) Cash or Deferred Arrangement (CODA) which received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020. The Plan has been amended since the date of the last amendment covered by the above mentioned determination letter. However, Plan management believes that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that some changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Effective October 2, 2023 the employment of all active participants in the McDonald Transit, Inc. 401(k) Retirement Plan (the “Plan”) was transferred from McDonald Transit, Inc., a Texas business corporation to Fort Worth Transit Authority, a Texas Regional Mobility Authority, established by statute enacted by the Texas Legislature. Fort Worth Transportation Authority is a governmental employer. Contemporaneously, sponsorship of the Plan (formerly known as the McDonald Transit, Inc. 401(k) Plan) was assumed by Fort Worth Transportation Authority.

The Plan was amended and restated to change the Plan Sponsor and to freeze contributions under the 401(k) feature of the Plan.

Effective as of January 1, 2024, the Plan became exempt from filing Form 5500 by reason of its sponsoring employer for the entire plan year being a governmental employer.
