INDEPENDENT AUDITOR'S REPORT

To the Plan Administrators
Predicate Logic, Inc. 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Predicate Logic, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and 2023, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

1. Description of the Plan and Significant Accounting Policies:

The following description of the Predicate Logic Inc. 401k Profit Sharing Plan ("Plan") is provided for general information purposes only. Reference should be made to the Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution savings plan under Section 401(k) of the Internal Revenue Code, which covers all full-time non-union employees of Predicate Logic, Inc. ("Company"). Participants must be over 21 years of age. If the participant is over the age of 21, the plan entry date is the hire date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants: Participants may contribute up to 100 percent of their salaries to the Plan, up to the Internal Revenue Service ("IRS") annual maximum limit of \$23,000 for 2024. The Plan also allows participants age 50 and older an additional "catch-up" contribution up to the IRS annual maximum limit of \$7,500.

Employer: The Company may make discretionary contributions to the plan. During the years ended December 31, 2024, and 2023, the Company made total discretionary contributions in the amounts of \$719,474 and \$707,659, respectively.

Participant Accounts and Vesting

Each participant's account is credited with their contribution and an allocation of Plan earnings. The benefits to which a participant is entitled are the benefits that can be provided from their account. Participants are immediately vested in their voluntary contributions and contribution earnings. Vesting in the employer's matching contribution is attained ratably over four years of service (defined as 1,000 hours of service) and immediately upon death or permanent disability.

Forfeited Accounts

Forfeitures of non-vested Company contributions are used to reduce future Company contributions. During 2024 and 2023, forfeitures of \$66,190 and \$13,650 respectively were used to reduce Company contributions.

Investment Valuation and Income Recognition

The Plan's investments in registered investment companies are stated at fair values reported by Voya Retirement Insurance and Annuity Company, the Custodian of the assets. Net appreciation and depreciation in the fair value of investments consists of the realized gain or loss on disposition of investments, plus the unrealized increase or decrease in the fair value of investments held from the beginning of the Plan year or date of purchase, whichever is later. Dividends are also included in net appreciation and are recorded on the ex-dividend date.

The Plan's investments in the insurance general account are stated at fair values reported by Voya Retirement Insurance and Annuity Company, the Custodian of the assets. The general account consists of guaranteed investment contracts.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum of \$50,000, not to exceed 50 percent of the vested interest of the participant's balance. The balance in the participant's account secures the loans. Principal and interest are paid ratably over the term of the loan through payroll deductions (not to exceed 5 years). Loan terms range from one to five years unless the loan is used for the purchase of a principal residence. The loan bears interest at the prime rate plus 1%, as determined by the plan administrator on the first day of the month the loan is originated. The rate of interest will be constant throughout the term of the loan.

Administrative Expenses

The Company pays most of the Plan's administrative expenses. Loan fees are paid by the participants who have outstanding loans with the Plan.

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

1. Description of the Plan and Significant Accounting Policies (continued):

Receivables

Receivables are recorded for employer contributions and participant deferrals for the years ended December 31, 2024 and 2023, for amounts that are remitted to the Custodian subsequent to year end. Receivables are presented in the statement of net assets available for benefits, net of the allowance for doubtful accounts. There are no credit terms or collateral. The Plan's Trustees determined that there was no need to record an allowance for doubtful accounts as of December 31, 2024, and 2023.

Excess Contributions Payable

Excess contributions payable consist of participant deferrals in excess of amounts allowed under the Actual Deferral Percentage Test and are refunded to the participant. At December 31, 2023, there were excess deferrals in the amount of \$10,848.

Payment of Benefits

Upon termination of service, participants receive the value of their account in the form of a lump-sum payout or substantially equal installments. Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements, in conformity with accounting principles generally accepted in the United States of America, requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

Subsequent Events

The Plan has evaluated subsequent events through July 30, 2025, the date on which the financial statements were available to be issued.

3. Fair Value Measurements:

The fair value measurement and disclosure topic of FASB ASC, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active market for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Valued at the net asset value (NAV) of share held by the plan at year end.

Guaranteed investment contracts: Valued at the net asset value (NAV) of share held by the plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Transactions with Party-in-interest:

Certain Plan investments are shares of registered investment companies. These investments were managed by Voya Retirement Insurance and Annuity Company; therefore, these transactions qualify as party-in-interest transactions. Participant loans also qualify as party-in-interest transactions.

5. Income Taxes:

The Plan is a prototype plan, which the Internal Revenue Service has determined is in compliance with the applicable requirements of the Internal Revenue Code. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.
