### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of the CTC TRADING GROUP, LLC 401K PLAN AND RETIREMENT TRUST (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 1—PLAN DESCRIPTION**

CTC Trading Group, LLC 401(k) Plan and Retirement Trust (the “Plan”) is a defined contribution plan offered by CTC Trading Group, LLC (the Company), designed to operate under the provisions of Section 401(k) of the Internal Revenue Code (“IRC”). The Plan was amended effective as of July 29, 2022. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The following description of the Plan provides only summary information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**ELIGIBILITY**

Employees age 21 or older (other than those covered by a collective bargaining agreement, non-resident aliens who do not receive any earned income from the Company which constitutes United States income, and interns) are eligible to participate in the Plan.

**CONTRIBUTIONS**

Each year, participants may elect to contribute pre-tax and/or after-tax Roth annual compensation as defined in the Plan to a maximum of \$23,000 for 2024 and \$22,500 for 2023. Participants who are at least age 50 may make additional “catch-up” contributions to a maximum of \$7,500 for 2024 and 2023. Participants may also roll over amounts representing distributions from other qualified plans. Participants may also make after-tax voluntary contributions not to exceed \$10,000.

Based on the discretion of the Board of Directors, the Company may, subject to certain limitations, make a matching contribution to the Plan for each participant in accordance with the terms of the Plan document. For 2024 and 2023, the Company made a matching contribution of 50% of a participant’s deferral on compensation, not to exceed 5% of eligible compensation for each eligible participant. For 2024, the match was capped at \$8,625. In order to receive a matching contribution, an employee must have worked at least 1,000 hours during the year and have been employed on the last day of the year.

The Company may also elect to make a discretionary profit-sharing contribution based on the class of each participant. Company’s discretionary profit-sharing contributions (net of forfeitures used) were \$4,053,668 for 2024 and \$9,156,417 for 2023. In order to receive a profit-sharing contribution, an employee must have worked at least 1,000 hours during the year and have been employed on the last day of the year.

**PARTICIPANT ACCOUNTS**

Each participant’s account is credited with the participant’s contribution, the Company’s discretionary matching contribution, and an allocation of the Company’s discretionary profit-sharing contribution, if applicable, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant contributions, plan compensation, or account balances, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants direct the investment of their accounts into various options offered by the Plan.

**VESTING**

Participants are 100% vested in their elective deferral contributions plus actual earnings thereon. Vesting in the Company’s contributions portion of their accounts, plus actual earnings thereon, is based on years of continuous service. A participant receives vesting of 25% per year of service and is 100% vested after four years of credited service.

**NOTE 1—PLAN DESCRIPTION (Continued)**

NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loans bear a reasonable rate of interest as determined by the Plan Administrator based on prevailing interest rates at the times the loans are taken. Principal and interest are paid ratable through payroll deductions.

PAYMENT OF BENEFITS

Upon termination of service due to retirement, disability or death, a participant may elect to receive a lump-sum payment equal to the value of the participant's vested interest in his or her account or in partial withdrawals. Participants may receive distributions from their accounts while they are still employed by the Company under certain circumstances such as financial hardship and required minimum distributions.

FORFEITURES

Forfeited non-vested accounts are used to reduce future employer contributions. During 2024 and 2023, employer contributions were reduced by \$163,874 and \$19,011, respectively. Forfeitures available for future use are \$365,980 as of December 31, 2024 and \$187,569 as of December 31, 2023.

**NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

BASIS OF ACCOUNTING

The accompanying financial statements have been prepared using the accrual basis of accounting.

USE OF ESTIMATES

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

The Plan's investments at December 31, 2024 and 2023 were held by Fidelity Management Trust Company ("Fidelity"). All investments are valued at market value as of December 31, 2024 and 2023.

Purchases and sales of securities are reflected on a trade-date basis. Realized gains and losses on the sale of securities are computed on a specific identification basis.

Interest income is recognized on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation on investments held represents the change in market value of the investments from the beginning of the Plan year (or date the investments were purchased, if later) to the end of the Plan year.

**NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**NOTES RECEIVABLE FROM PARTICIPANTS**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**PAYMENT OF BENEFITS**

Benefits are recorded when paid.

**ADMINISTRATIVE EXPENSES**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

**NOTE 3—FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**NOTE 3—FAIR VALUE MEASUREMENTS (Continued)**

*Level 1 Fair Value Measurements*

Mutual funds are valued at quoted net asset values of the shares held by the Plan at year-end.

*Level 2 and Level 3 Fair Value Measurements*

Level 2 and Level 3 fair value measurements are not applicable to the Plan for 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while management believes the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4—INFORMATION CERTIFIED BY TRUSTEE AND CUSTODIAN**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C). Accordingly, Fidelity, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and schedule is complete and accurate.

- a. Investments, as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- b. Investment income, as shown in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- c. The schedule of assets (held at end of year) as of December 31, 2024, as shown on Schedule H - Line 4i.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**NOTE 5—RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Company provides certain accounting and administrative services to the Plan for which no fees are charged. In addition, the majority of the expenses of the Plan are paid by the Company.

Plan investments are managed by Fidelity, the trustee of the Plan. Various fees are paid to Fidelity for these services, some of which are deducted from plan earnings. The Plan's investment advisor was also paid various fees from the Plan. Both Fidelity and the investment advisor are parties-in-interest.

**NOTE 6—PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan at any time subject to the provisions of ERISA. If the Company should decide to terminate the Plan, participants would become 100% vested in the Company contribution portion of their accounts.

**NOTE 7—TAX STATUS**

Effective as of July 29, 2022, the Plan adopted a Fidelity pre-approved defined contribution plan. The Internal Revenue Service (IRS) has informed Fidelity by a letter dated June 30, 2020, that the form of the Plan is acceptable for use by employers for the benefit of their employees under IRC Section 401. The Plan Administrator and the Plan's tax counsel believe that the Plan is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8—RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9—SUBSEQUENT EVENTS**

Management has evaluated subsequent events through July 28, 2025, the date which the financial statements were available for issue. There were no subsequent events which require disclosure.
