As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Plan Description

General

The following description of the AMVETS Department of California Service Foundation 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

The Plan, as amended, is a defined contribution plan established for the benefit of AMVETS Department of California Service Foundation (the “Foundation”) employees. The Foundation is the Plan’s sponsor, serves as the Plan administrator and is responsible for the day-to-day administration and operation of the Plan. The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (“IRC”) and similar state tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan agreement was restated on November 21, 2019 (Note 6). Great-West Life & Annuity Insurance Company (“Great-West”) is the asset custodian of the Plan and is responsible for the custody and management of the Plan’s assets.

Eligibility

Employees of the Foundation who have completed six months of service are eligible to participate in the Plan. However, contracted employees are excluded from Plan participation. Plan entry dates are January 1st, April 1st, July 1st, and October 1st.

Contributions

Participants are automatically enrolled in the Plan after becoming eligible to participate. Unless the participant elects to change the deferral percentage or chooses not to make any deferral contributions, each participant is automatically enrolled to make deferral contributions to the Plan at 3% of their compensation as of the participant’s entry date. Unless the participant chooses a different deferral percentage, the deferral percentage is automatically increased at the beginning of each Plan year by 1% up to a maximum percentage of 5% of the participant’s compensation, as defined in the Plan agreement. Participants direct the investment of their contributions into various investment options offered by the Plan.

Contributions (continued)

Each year, participants may contribute up to the maximum allowed by law of pre-tax annual compensation, as defined in the Plan agreement. For 2024, the contribution limit was \$23,000. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to \$7,500 in 2024. The Foundation may elect to make a discretionary matching contribution, subject to certain statutory limits. All employer contributions are invested in the same manner that the participant directs his or her investments. There were no matching contributions made during the year ended December 31, 2024. Participants may also rollover amounts representing distributions from other qualified defined benefit or contribution plans.

Participant Accounts

Each participant's account is credited with the participant's contributions, and allocations of (a) the employer's discretionary matching contributions, if any, (b) investments earnings or losses, and (c) administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. The portion of the participant's account attributable to the Foundation's matching contributions, plus earnings, becomes 20% vested every year following a full year of service, as defined in the Plan agreement, and continues to vest at the rate of 20% for each successive year of service until 100% vested after five (5) years of service. Participants who are still an employee of the Foundation upon reaching the normal retirement age, as defined in the Plan agreement, become 100% vested in their employer contributions and earnings thereon. Additionally, a participant's employer contributions and earnings thereon, become 100% vested in the event that a participant dies or becomes disabled.

Benefit Payments

On termination of service due to death, disability, termination or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or a rollover of the account balance into another qualified account. However, if the participant's vested account balance is \$5,000 or less, the Foundation can elect to cash out the account balance by establishing a separate IRA outside of the Plan.

In addition, the Plan provides for qualified reservist distribution, as defined in the Plan agreement, for participants ordered or called to active duty for a period of more than 179 days or for an indefinite period. Additionally, under certain circumstances of financial hardship, participants are allowed to have hardship distributions from their accounts. Hardship distributions are subject to income taxes and may be subject to additional tax based on early withdrawal.

Forfeitures

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures are retained in the Plan and may be used to pay Plan expenses or used to reduce future employer contributions. As of December 31, 2024 and 2023, there were no unallocated forfeitures available.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting periods. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments in mutual funds are stated at fair value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the asset custodian. See Note 4 for discussion of fair value measurements.

The Plan invests in a guaranteed insurance contract, which is a group annuity contract valued at contract value. Contract value reflects the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan and is the relevant measure for the portion of assets attributable to the fully benefit-responsive guaranteed insurance contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments consists of both the realized and unrealized gains and losses.

Contributions

Participant contributions are recorded by the Plan in the year withheld from participant earnings. Contributions to the Plan by the Foundation, if any, are recorded in the year which they become obligations of the Foundation.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Foundation. Expenses that are paid by the Foundation are excluded from the accompanying financial statements. Investment related expenses are included in net appreciation of fair value of investments.

3. Information Certified by the Plan's Asset Custodian

The Plan's investments were held by Great-West. The following investment information was certified by Great-West, as applicable, to be complete and accurate within the meaning of 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- Interest and dividend income from investments and net appreciation in the fair value of investments reflected on the accompanying Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- Investments reflected on the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and on the accompanying Supplemental Schedule, Schedule of Assets (Held at End of Year), as of December 31, 2024.

4. Fair Value Measurements

GAAP establishes a framework for measuring investments at fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under GAAP are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology are observable, other than Level 1 prices, such as quoted prices for similar assets or liabilities; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the asset or liabilities.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

4. Fair Value Measurements (continued)

The mutual funds held by the Plan are measured at fair value. Mutual funds are valued at the daily closing price as reported by the respective fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded, and therefore are classified within the Level 1 of the valuation hierarchy.

The Plan is a party to a fully benefit-responsive guaranteed insurance contract with Great-West. The guaranteed insurance contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Because the guaranteed insurance contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for plan benefits. The guaranteed insurance contract is presented on the face of the accompanying Statements of Net Assets Available for Benefits at contract value. Contract value, as reported to the Plan by Great-West, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Foundation or other Foundation events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

Although Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the value of certain financial instruments could result in a different value measurement at the reporting date. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

5. Plan Termination

Although it has not expressed any intent to do so, the Foundation has the right under the Plan agreement to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their portion of any employer contributions.

6. Income Tax Status

Effective November 21, 2019, the Plan adopted a non-standardized pre-approved profit sharing plan sponsored by Empower Retirement, LLC. The non-standardized pre-approved profit sharing plan obtained its latest opinion letter dated November 14, 2022, in which the Internal Revenue Service (“IRS”) stated that the non-standardized prototype plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has not received a determination letter specific to the Plan. The Plan administrator believes the Plan is currently designed and is being operated in compliance with the applicable provisions of the IRC. Therefore, the Plan administrator believes that the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

7. Party-in-Interest Transactions

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. The Foundation paid certain administrative expenses of the Plan. In addition, certain Plan investments are managed by affiliates of the asset custodian. These transactions qualify as party-in-interest transactions for which a statutory exemption exists.

8. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the accompanying Statements of Net Assets Available for Benefits.

9. Subsequent Events

The Plan administrator evaluated subsequent events through August 1, 2025, the date the financial statements were available to be issued.
