### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of Fresenius Kabi USA, LLC Savings and Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

### Note 1 - Plan Description

The following description of Fresenius Kabi USA, LLC Savings and Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering eligible employees of Fresenius Kabi USA, LLC (the "Company"). The Plan is administered by the Company.

Employees are eligible to participate in the Plan beginning on the first day of the first month following the date of hire with the Company. Eligible employees can participate in the Plan if they are not (i) subject to a collective bargaining agreement, (ii) a nonresident alien, or (iii) a leased employee. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

Once eligible, the employee automatically becomes a participant in the Plan. Beginning on the date of automatic enrollment in the Plan, the participant's compensation is reduced by 4 percent and the compensation reduction amount is treated as a before-tax contribution. This 4 percent contribution level continues until the participant elects a different percentage or elects not to participate in the Plan. A participant may elect to defer from 0 percent to 80 percent of his or her compensation, as defined, each pay period, subject to Internal Revenue Service (IRS) annual limitations. In addition, an eligible employee may make a rollover contribution from another qualified plan.

The Plan includes an automatic escalation provision for pretax deferrals. Participants who defer between 1 percent and 14 percent of compensation as a pretax deferral will see an automatic 1 percent increase to their election each January until they make an election to cancel the automatic escalation feature.

The Company makes a qualified nonelective contribution to the Plan each pay period in the amount of 3 percent of eligible compensation. A deferral by the employee is not required in order to receive the employer contribution as the employer is making a 3 percent safe harbor contribution to the Plan.

In the event that a participant has not provided investment direction, the participant and employer contributions will be invested according to the Service and Expense Agreement between the Company and the custodians.

#### **Investment Options**

Upon enrollment, a participant may direct employee and company contributions to any of the Plan's fund investment options. The Plan also provides a self-directed investment feature whereby participants may direct a portion of their current account balance, subject to certain restrictions, to various mutual funds, bonds, and stocks.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) the plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participants' earnings or account balances, as defined.

#### **Forfeitures**

Forfeitures all relate to employer contributions prior to January 1, 2005, when such contributions were not fully vested under the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Forfeitures are used to offset employer contributions and pay plan expenses, as allowed by the plan document.

### Note 1 - Plan Description (Continued)

#### ***Participant Notes Receivable***

Participants may obtain notes from their account balances of a minimum of \$1,000 up to a maximum of 50 percent of their vested account balances or \$50,000, whichever is less. Such notes bear interest at fixed rates, calculated as the prime rate at the inception of the note plus 1 percent, and are due and payable in full if regular repayments cease, the participant terminates employment with the Company, or the participant dies. Participant notes receivable are secured by the participant's account. Participant notes receivable are repaid over a five-year period (or longer in cases where the note was obtained for the purchase of a principal residence) through payroll deductions. Participant notes receivable are stated at their outstanding balance, which is equivalent to amortized cost.

#### ***Vesting***

Participants' and qualified nonelective employer contributions and earnings thereon are always fully vested.

#### ***Benefit Payments***

Benefits are payable upon normal, early, or late retirement, as defined by the plan document and upon disability, death, and termination. Participants may elect various payment options, including installment, lump-sum payments, and annuity payments. A participant may withdraw all or a portion of his or her account for hardship reasons before benefits become payable, as permitted under current tax law.

#### ***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Empower Annuity Insurance Company (EAIC). EAIC is the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

#### ***Plan Termination***

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of the Plan and ERISA. In the event of plan termination, participants are already 100 percent vested in their accounts and will be entitled to their entire account balances.

### Note 2 - Summary of Significant Accounting Policies

#### ***Investment Valuation and Income Recognition***

Investments are stated at contract value and fair value. Investments stated at fair value are based on quoted market prices or redemption prices reported by the issuer. Redemption prices generally are based on the fair values of the fund's underlying investments. See Note 4 for additional information.

Purchases and sales of investments are recorded on the trade date. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Plan Assets***

##### **Mutual Funds**

Shares of mutual funds are valued at quoted prices in active markets.

##### **Unallocated Contract**

The unallocated contract is a group annuity contract with EAIC that invests in the general assets of EAIC. EAIC considers this contract to be benefit responsive and is stated at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

**Pooled Separate Accounts**

Shares of the pooled separate accounts (PSA) are valued at the net asset value of the pooled separate accounts, which is based on the fair value of the funds' underlying net assets. There are no redemption restrictions or unfunded commitments on these investments.

**Self-directed Brokerage Account**

Investments within the self-directed brokerage account are valued at fair value. The fair value of the shares is based on prices in active markets. Self-directed brokerage accounts invest approximately 74 percent and 61 percent of net assets in common stocks at December 31, 2024 and 2023, respectively.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Participant Notes Receivable**

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

**Benefit Payments**

Benefits are recorded when paid.

**Administrative Expenses**

Substantially all external plan administration fees incurred in the administration of the Plan, except management fees and loan processing fees, are paid by the Company.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Subsequent Events**

The financial statements and related disclosures include evaluation of events up through and including July 24, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Certified Information**

Empower Annuity Insurance Company and Empower Trust Company, LLC have certified the completeness and accuracy of information as of December 31, 2024 and 2023 related to investments reflected in Note 4, the investments and participant notes receivable in the statement of net assets available for benefits; investment and participant notes receivable income in the statement of changes in net assets available for benefits for the year ended December 31, 2024; and supplemental schedule of assets held at end of year. Empower Annuity Insurance Company has provided certification with regard to Empower financial products, and Empower Trust Company, LLC (e.g., mutual funds) has provided certification with regard to participant notes receivable and non-Empower financial products.

**Note 4 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, and other inputs such as interest rates and yield curves that are observable at commonly quoted intervals.

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management’s own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan’s assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The Plan’s policy is to recognize transfers between levels of the fair value hierarchy as of the end of the reporting period. There were no transfers among the levels during the year ended December 31, 2024.

#### Note 5 - Investment Contracts

The Plan has a benefit-responsive investment contract with EAIC. EAIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a semiannual basis for resetting but may not be less than 1.50 percent. When establishing interest crediting rates for this product, EAIC considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.

#### Note 6 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.
