### *Independent Auditors' Report*

To the Retirement Committee of

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

## 1. Description of Plan

The following description of the Assurance Technology Corporation 401(k) Savings Plan (the Plan) of Assurance Technology Corporation and its affiliates, ATC Power Systems, Inc. and New England Sports Management, Inc. (collectively, the Company), provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

### *General*

The Plan is a defined contribution plan covering substantially all full-time employees of the Company who are age 20 or older and all part-time employees who are age 20 or older and have completed 1,000 hours of service in a 12-month consecutive period beginning on the date of hire (or in a calendar year, if 1,000 is not attained in the initial 12 months of employment). The Retirement Committee is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Retirement Committee.

The Plan is subject to the provisions of the Internal Revenue Code of 1986, as amended (IRC) and the Employee Retirement Income Security Act of 1974 (ERISA).

### *Setting Every Community Up for Retirement Enhancement (SECURE) Act*

The SECURE Act and the SECURE 2.0 Act had various provisions in effect during the year ended December 31, 2024. The most significant change required including long-term part-time (LTPT) employees who attained 500 or more hours of service in three consecutive 12-month eligibility computation periods beginning in 2021 as eligible employees for participant contributions. The Plan is required to be formally amended on or before December 31, 2025 for the SECURE Act and on or before December 31, 2026 for the SECURE 2.0 Act.

### *Contributions*

Non-highly compensated participants may contribute between 1% and 75% percent of their annual eligible compensation as pre-tax and Roth contributions. Highly compensated participants may contribute up to 10% of their annual eligible compensation as pre-tax and Roth contributions. All participants may contribute up to an additional 10% of their annual eligible compensation as after-tax contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company provides for discretionary employer matching contributions for all eligible participants. For the year ended December 31, 2024, the discretionary employer matching contribution was 50% of the first 8% of eligible compensation that each participant contributes to the Plan as pre-tax and Roth contributions, excluding catch-up and after-tax contributions. Contributions and compensation are subject to certain Internal Revenue Service (IRS) limitations.

### *Participant Accounts*

Each participant's account is credited with the participant's contributions, discretionary employer matching contributions, and an allocation of the Plan's earnings or losses, and charged with an allocation of administrative expenses that are paid by the Plan. The allocation of earnings or losses is based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### *Notes Receivable from Participants*

The Plan permits its participants to obtain loans against their account balances. A participant may borrow from his or her account a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 reduced by the highest outstanding loan balance within the last 12 months or 50% of his or her vested account balance. With the exception of loans used to purchase a primary residence that have loan terms limited to a maximum of 15 years, loan terms are limited to a maximum of five years. Notes receivable from participants are secured by the vested balance in each participant's account and shall bear interest at the prime rate plus 1% (8.50% December 31, 2024) at the date the loan application is processed. A participant may only have one loan outstanding at any given time. Principal and interest are paid ratably through regular payroll deductions for actively employed participants.

The Plan Administrator will treat a loan in default if any scheduled payment remains unpaid beyond the last day of the calendar quarter following the calendar quarter in which the participant missed the scheduled payment; however, the participant will have the opportunity to repay the loan or resume current status of the loan by paying any missed payment plus interest. Upon termination of employment, a participant may continue to repay the outstanding portion of the note receivable subject to the terms and conditions of the underlying provisions of the promissory note.

Certain other restrictions may apply to notes receivable from participants, as defined in the plan document.

As of December 31, 2024, the rates of interest on outstanding notes receivable from participants ranged from 4.25% to 9.50%, with various maturities through 2036.

### *Vesting*

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Each participant vests in discretionary employer matching contributions and New England Sports Management, Inc. (NESM) profit sharing contributions based on years of continuous service, as defined, and become fully vested after five and seven years of credited service, respectively. Each participant will become immediately vested in all discretionary employer matching and NESM profit sharing contributions if employed upon reaching normal retirement age (65), disability, or death.

### *Forfeitures*

Forfeitures represent the nonvested portion of terminated participant account balances plus related earnings. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$18,757 and \$47,390, respectively. These accounts can be added to any discretionary employer matching contributions and allocated in the same manner, used to reduce any discretionary employer matching contribution, added to any discretionary employer matching contribution and allocated as an additional matching contribution, allocated to all participants in the same proportion that each participant's compensation for the plan year bears to the compensation of all participants for such year, or to pay administrative expenses. During the year ended December 31, 2024, forfeited nonvested balances of \$53,236 were used to reduce discretionary employer matching contributions related to the year ended December 31, 2024.

### *Payment of Benefits*

Withdrawals may be made from a participant's account at retirement, death, disability, termination of employment, the tenth anniversary of the year in which the participant commenced participation in the Plan, or attainment of the age of 59 ½. If a participant terminates service, any portion of the vested amount in his or her account may be distributed or rolled over into another qualified plan, as directed by the participant. The Plan can elect to distribute funds out of the Plan to an individual retirement account when a participant terminates employment and has a vested balance in the Plan less than \$5,000.

### *Payment of Benefits...continued*

Required minimum distributions (RMDs) shall be made, by law, to an eligible participant who has terminated employment (or a 5% owner of the Company regardless of whether he or she has been terminated) from his or her vested account no later than the participant's attainment of age 73. Otherwise, the participant's vested account shall be distributed to the participant (or to the participant's beneficiary in the event of the participant's death) in a single lump-sum payment or partial payments, subject to certain restrictions as defined in the plan document.

The minimum amount for an in-service distribution is \$500. Distributions from a participant's rollover contribution account or voluntary contribution account may be made at any time. Participants who are eligible for a hardship withdrawal may elect to withdraw all or a portion of their accounts.

All distributions are subject to the applicable provisions of the Plan.

### *Investment Elections*

Each participant shall direct the investment of his or her account and shall select among various mutual funds, a common collective trust fund, and a guaranteed interest account held with an insurance company. Each participant has the ability to change his or her investment allocations at any time.

## 2. Summary of Significant Accounting Policies

### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting. The financial statements have been prepared in accordance with accounting standards set by the Financial Accounting Standards Board (FASB). The FASB sets generally accepted accounting principles in the United States of America (GAAP) to ensure net assets available for benefits and changes in net assets available for benefits are consistently reported. References to GAAP issued by the FASB in these notes are to the FASB Accounting Standards Codification (ASC).

### *Use of Estimates*

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

The Plan's mutual funds and common collective trust fund are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by investment advisers and the trustee. See Note 4 for discussion of fair value.

A guaranteed investment contract held by a defined contribution plan is reported at contract value as provided by the insurance company. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to a fully benefit-responsive investment contract because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

The statements of net assets available for benefits present the contract value of a fully benefit-responsive investment contract. See Note 3 for discussion of the fully benefit-responsive investment contract.

### *Investment Valuation and Income Recognition...continued*

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest from notes receivable from participants is recorded on an accrual basis. As of December 31, 2024 and 2023, accrued, but unpaid interest has been deemed insignificant to the Plan. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the note receivable from the participant to be a distribution, the balance of notes receivable from participants is reduced and a benefit payment is recorded within the statement of changes in net assets available for benefits.

### *Payment of Benefits*

Benefits are recorded when paid.

### *Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants, investment advisory expenses, and other fees related to participant directed transactions are charged directly to the participant's account and are included in administrative expenses. The trustee also funds a service credit into the Plan, which is netted against administrative expenses, net of service credits on the accompanying statement of changes in net assets available for benefits.

## 3. Investment Contract with Insurance Company

The Plan is party to a traditional fully benefit-responsive guaranteed investment contract with New York Life Insurance (NYLI) that maintains the Plan's contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. NYLI is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The crediting rate is based on a formula established by NYLI, but cannot be less than zero, and is reviewed on a semiannual basis for resetting. The guaranteed investment contract does not permit NYLI to terminate the agreement prior to the scheduled maturity date.

The contract for the Plan's guaranteed interest account specifies certain conditions under which distributions from the account would be payable at amounts below contract value. Such circumstances of the contract include events initiated by the Company including, but not limited to, plan termination, mergers, spinoffs, layoffs, or early retirement incentives.

The contract does not specify the circumstances under which the issuer may terminate the contract other than a written notice to the contract holder 30 days prior to the intended termination date. Currently, management believes that the occurrence of an event that would cause the Plan to transact with participants at less than contract value is not probable.

## 4. Fair Value Measurements

The Plan discloses the fair value of investments in accordance with FASB ASC Topic No. 820, *Fair Value Measurements* (ASC 820). The framework under ASC 820 provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means; or
  - If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds* - Valued at the daily closing price as reported by each fund. Mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission, which are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust fund* - Valued at the NAV of units of the common collective trust. The NAV, as provided by John Hancock Trust Company LLC (John Hancock), the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Transactions of investments or withdrawals may occur on a daily basis and there are no redemption restrictions on the fund. There were no unfunded commitments as of December 31, 2024 and 2023.

## 5. Information Prepared and Certified by Plan's Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly John Hancock has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023 and Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024 and the related investment and notes receivable from participants activity reflected in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

## 6. Tax Status

The Plan has adopted a volume submitter plan that the IRS has determined, by an opinion letter dated June 30, 2020, that the volume submitter plan is designed in accordance with applicable sections of the IRC. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of the Plan's termination, participants will become fully vested in their accounts.

## 8. Party-in-Interest Transactions

Certain investments of the Plan are shares of a guaranteed interest account managed by affiliates of John Hancock. Therefore, these transactions qualify as party-in-interest transactions as that term is defined in Section 3(14) of ERISA. In addition, the Plan issues notes receivable to participants, which are secured by the balances in participant accounts, which also constitute party-in-interest transactions.

John Hancock funds a service credit to the Plan based on the amount of service revenue that John Hancock receives pursuant to arrangements with investment option issuers, if such amount exceeds a percentage of the Plan's total assets as defined in the agreement between John Hancock and the Plan. Such amounts may be used to pay the Plan's administrative expenses or be allocated to the accounts of participants. During the year ended December 31, 2024, the service credit funded by John Hancock totaled \$35,672 and was included as a reduction in administrative expenses, net of service credits on the accompanying statement of changes in net assets available for benefits.

During the year ended December 31, 2024, the Plan funded administrative fees, including \$42,000 paid to an investment advisor, \$6,423 paid to the Plan's financial statement auditor, and \$82,467 paid to John Hancock.

## 9. Risk and Uncertainties

The Plan invests in various investment securities that are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

## 10. Subsequent Events

The Plan has evaluated subsequent events for potential disclosure or recognition through July 18, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the SECURE 2.0 Act expanded LTPT provisions to include employees who attained 500 or more hours of service in two consecutive 12-month eligibility computation periods beginning in 2021 as eligible employees for participant contributions. Further, participants from ages 60 to 63 will be allowed to contribute catch-up contributions equal to 150% of the standard limit.
