Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

Basis for Opinion on the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”), and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors’ Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they could reasonably be expected to influence the economic decisions users made based on these financial statements.

Accordingly, no such opinion is expressed, (d) evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements, and (e) conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule H, line 4i – schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1: Description of Plan

The following description of the Wente Family Estates 401(K) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution 401(k) profit sharing plan established August 1, 1976, amended and restated on March 1, 2022, which provides benefits to all members of Wente Bros. Inc. DBA Wente Vineyards (the “Company”). The Plan also covers employees of Wente Land and Cattle, Ivan Tamas Wines, LLC, and Cresta Blanca Golf, LLC, as participating employers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and section 401(a) of the Internal Revenue Code (“IRC”).

The Plan is administered by its sponsor, the Company, who retained the services of Empower Annuity Insurance Company of America and Empower Trust Company, LLC (“Empower”) as the trustee of the Plan’s assets, the Plan’s record keeper and third party administrator through December 31, 2024.

Eligibility: Except for excluded employees, all employees who have reached twenty-one years of age and have worked a minimum of 1,000 hours during the first six months of service become eligible to participate in the Plan. Those who do not reach 1,000 hours during the first six months, but who meet the minimum age requirement, become eligible to participate in the Plan after one year of service. Upon meeting eligibility requirements, employees are auto-enrolled into the Plan at a deferral rate of 3% of the participant’s eligible compensation. After auto-enrollment, deferral rates automatically increase by 1% each Plan year up to a max of 10%, unless elected otherwise. Employees may elect to not participate in the Plan.

Participant contributions: Participants may defer a portion of their eligible compensation into the Plan including Roth deferrals subject to certain anti-discriminatory tests and with annual additions subject to the statutory limits. Participants age 50 or older are allowed to make “catch up” contributions during the Plan year, subject to statutory limits. Eligible participants may, in certain circumstances, “rollover” funds accumulated under plans in which they previously participated. The Company does not make any matching contributions on rollover funds received.

Employer contributions: The Company’s matching contribution is 25% of the participant’s salary reduction, subject to a maximum of 6% of eligible compensation. The employer matching contribution is calculated based on each pay period. Matching contributions are made on all eligible compensation earned through a participant’s last day of employment. Contributions are subject to certain limitations.

The Plan includes employer safe harbor contributions at a rate of up to 3% of eligible compensation. For the year ended December 31, 2024, the Company contributed approximately \$529,000 of safe harbor contributions in addition to employer matching contributions.

Participant accounts: Each participant's account is credited with the participant's contribution and allocations of: (a) the Company's matching and safe harbor contributions, and (b) Plan earnings and losses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment options: The Plan provides for investments to be directed by participants into a number of investment options held by the trustee. Some Plan investments are units of funds managed by the third party administrator, therefore, these investments and most investment transactions are party-in-interest transactions. Earnings of each investment fund are allocated to participants' accounts in proportion to each participant's share of that fund. Participants may change their investment options at their own discretion and are responsible for their own investment decisions.

Vesting: Participants are immediately fully vested in their contributions as well as all earnings on those contributions. The Company's matching contributions vest based on years of service, not the date of the employer contributions. Vesting on these contributions occur at a rate of 20% per year of service starting in the second year of service. Participants are fully vested in all employer contributions after six years of service has been achieved. Safe harbor contributions are 100% vested upon contribution.

Forfeited accounts: Forfeitures are used primarily to reduce future employer contributions. They can also be used to pay administrative expenses of the Plan. Forfeitures at December 31, 2024 and 2023, and applied during the year ended December 31, 2024 were immaterial.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, but may not exceed five years, except for loans used for a purchase of a primary residence, which may be repaid over a longer period of up to ten years. Participants are limited to one active loan at a time. The notes are secured by the vested balance in the participant's account and bear interest at rates commensurate with local prevailing rates. Principal and interest is paid ratably through monthly payroll deductions each pay period.

Benefits paid to participants: The Plan provides for the payment of benefits to the participant (or, if applicable, the beneficiary) at retirement, disability, death, financial hardship (as defined in the Plan), or termination of employment. In service distributions of a participant's vested account balance are permitted, provided the participant has attained normal retirement age (age 59 1/2). Upon termination, the participants or beneficiaries may elect to leave their account balance in the Plan, or withdraw any portion of the vested interest in their account. Unless otherwise instructed by the participant, participants with vested account balances of \$1,000 or less upon separation will receive a lump sum cash payout. Any participant with a vested balance greater than \$1,000, but less than \$5,000, has the option to receive a lump sum payment or have their balance rolled over into an individual retirement plan designated by the Plan administrator or participant upon separation.

Administrative expenses: Substantially all administrative expenses are paid by participants of the Plan. Administrative expenses recorded in the Plan represent custodial fees, other recordkeeping fees paid directly from the Plan to the Plan's trustee and the cost of communications to the participants. Loan fees, distribution fees, and any special handling costs are deducted directly from participants' accounts.

Note 2: Significant accounting policies

Basis of accounting: The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP"). Contributions from participants are recorded when withheld from the participant. Benefit payments to participants are recorded when paid.

Use of estimates: The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements, accompanying notes, and schedule. Actual results could differ from those estimates.

Investment valuation and income recognition: The Plan's investments in all of the funds, except the investment contract, are presented at fair value, based on quoted market prices of the underlying securities within each fund as of December 31, 2024 and 2023. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The investment contract is fully benefit-responsive and is reported at contract value, which approximates fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's realized gains and losses on investments bought and sold as well as unrealized gains and losses on investments during the year.

Fair value measurements: The Plan performs fair value measurements in accordance with Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, Fair Value Measurements and Disclosures. Refer to Note 3 for the fair value measurement disclosures associated with the Plan’s investments.

Net appreciation (depreciation) in fair value of investments: The earnings, expenses, realized gains or losses, and unrealized appreciation (depreciation) in registered investment companies and other investments are recorded in the accompanying financial statements as net appreciation (depreciation) in fair value of investments.

Subsequent events: The Plan has evaluated subsequent events through the date that the financial statements were made available to be issued which is the date of the independent auditors’ report.

Note 3: Fair value

The Plan performs fair value measurement in accordance with ASC 820 which defines fair value as the price that would be received from selling an asset in an orderly transaction between market participants at the measurement date. The accounting guidance for fair value measurement requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The standard establishes a fair value hierarchy based on the level of independent, objective evidence surrounding the inputs used to measure fair value. A financial instrument’s categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The fair value hierarchy is as follows:

- Level 1: quoted prices in active markets for identical assets or liabilities;
- Level 2: inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or
- Level 3: unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4: Investments

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Empower, the trustee of the Plan, as complete and accurate, except for comparing such information to information included in the Plan's financial statements and supplemental schedule.

The following information included in the financial statements and supplemental schedule was provided by and certified by the Plan's trustee as complete and accurate:

- Investments as shown in the Statement of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Notes receivable from participants as shown in the Statement of Net Assets Available for Benefits as of December 31, 2024 and 2023.

Note 5: Investment contract with insurance company

In 2017, the Plan entered into a fully benefit-responsive investment contract with Mass Mutual. In 2021, Mass Mutual was acquired by Empower. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attributed for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value as reported to the Plan by Empower is equal to contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

As of December 31, 2024 and 2023, there were no reserves against the contract value for credit risk of the contract issuer or otherwise. Certain events limit the ability of the Plan to transact at contract value with the contract issuer. However, the Plan's management is not aware of the occurrence or likely occurrence of any such events.

Note 6: Party-in-interest transactions

At December 31, 2024 and 2023, the Plan held for investments approximately \$1,495,000 and \$1,623,000 in Empower investment accounts, respectively. Empower serves as the Plan's trustee and third party administrator.

Note 7: Plan termination

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all non-vested account balances would become 100%.

Note 8: Income tax status

The prototype plan adopted by the Plan sponsor obtained its latest opinion letter on November 14, 2022, in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has not received a separate opinion letter however the Plan administrator believes that the prototype plan, as adopted by the sponsor, is operating in compliance with the requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 9: Risks and uncertainties

The Plan provides for investments in various investment securities which, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits and participant account balances.
