RE: Reasonable Cause Statement for Late Filing of Form 5500-SF

Dear Sir or Madam,

I am submitting this Reasonable Cause statement in connection with the late filing of Form 5500-SF for the Cheshire Impact LLC 401(k) Plan (EIN#45-2846104)(Plan #001) for the plan year ending December 31, 2021, under the Department of Labor's Delinquent Filer Voluntary Compliance Program (DFVCP).

Cheshire Impact LLC ceased business operations in 2021. The company's 401(k) plan, administered by John Hancock with third-party administration by CWM Retirement Plan Services (a firm that has since gone out of business), was officially terminated effective September 3, 2021. All plan assets were fully distributed to participants during that year, and no participants or assets remained in the plan by the end of 2021.

Unfortunately, CWM Retirement Plan Services subsequently went out of business following the criminal conviction of its principal for fraud, which severely disrupted access to plan records and administrative continuity. As a result of both the company's closure and the administrator's collapse, we were unaware that the final Form 5500-SF had not been properly filed. This filing oversight was inadvertent and due to circumstances beyond our control, including the dissolution of both the business and its key service provider.

Upon discovery of the missed filing, I immediately began taking steps to bring the plan into compliance. I am now submitting the final Form 5500-SF through DFVCP along with supporting documentation confirming the plan's termination and the complete distribution of assets.
