1. Description of the Plan

The following is a brief description of the Sandy Alexander, Inc. Retirement Savings Plan (the "Plan") is provided for general purposes only. Participants should refer to the Plan document, related adoption agreement and individual statements provided to each Plan participant for a more complete description of the Plan's provisions.

General

The Plan is a qualified defined contribution pension plan covering eligible employees who are members of a controlled group which includes Sandy Alexander, Inc. and affiliated companies (collectively, the "Company"). The Plan provides deferred compensation benefits and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan's investments are administered and held in a trust by the Plan's trustee, John Hancock Trust Company LLC (the "Trustee"), which also serves as the recordkeeper and custodian of the Plan. The Trustee is qualified institution in accordance with 29 CFR 2520.103-5 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. The Plan administrator is responsible for overseeing and ensuring compliance with the Plan document. The Trustee, the record-keeper and the Plan administrator are appointed by the Company.

During 2024, there were transfers into the Plan amounting to \$1,095,561 relating to Abbott Communications Group, a participating employer of the Plan, which was acquired by the Company, effective January 1, 2024.

Eligibility

The Plan is available to all employees of the Company. The Plan excludes those employees who are: (1) Part-time, seasonal and temporary employees, (2) Employees covered by a collective bargaining agreement, unless the collective bargaining agreement provides for their coverage, and (3) Residents of Puerto Rico. Employees may enter the Plan on the first day of the month coinciding with or the next following date requirement.

1. Description of the Plan

Participant Contributions

The employees make voluntary contributions, of between 1% and 90% of compensation, of on a before-tax basis, up to the maximum contributions allowed under the Internal Revenue Service Code (“IRC”), as discussed below, to be placed into a trust fund for their benefit. The Plan includes an automatic enrollment feature and contribution arrangement. The automatic deferral amount is 2% of their eligible compensation, as defined, and will increase by 1% of compensation per year, up to the maximum of 5%, unless the participants opt out of the Plan or change the deferral percentage. Employees rehired on or after May 1, 2022, are subject to the automatic deferral provisions. Compensation per the Plan document means wages, tips, and other compensation on Form W-2. Compensation is adjusted to exclude fringe benefits, expense reimbursements, moving expenses, deferred compensation, and welfare benefits. Roth 401(k) contributions are not permitted.

For 2024, the maximum amount of compensation that may be considered for deferral purposes by participants and employer contributions is \$345,000. For 2024, total participant contributions are limited to a maximum of \$23,000. Additionally, for 2024, individuals who are at least 50 years of age can make a “catch-up” contribution not to exceed \$7,500. The maximum annual addition for 2024 that may be contributed or allocated to a participant’s account under the Plan shall not exceed the lesser of 100% of a participant’s compensation or \$69,000 for employees under age 50 and \$76,500 for employees over the age of 50.

Employer Contributions

The Company may make a discretionary matching contribution to the Plan based on a discretionary percentage of each eligible participant’s elective deferral contribution, up to \$500 per participant. The Company did not make a discretionary match for the 2024 Plan year.

In addition, the Company may make a discretionary profit-sharing contribution to those participants who have completed one year of service during the Plan year and be employed on the last day of the Plan year. For commissioned sales employees, the maximum compensation considered for profit-sharing contributions is \$50,000. The Company did not make a profit-sharing contribution for the 2024 Plan year.

Rollover Contributions

An eligible employee may make a transfer to the Plan of a benefit from a qualified retirement plan of another employer, referred to as rollover, with certain restrictions. In-Plan Roth rollover contributions are not permitted.

1. Description of the Plan

Investments

Participants, in accordance with the Plan document, direct the Trustee to invest their contributions into various investment options offered by the Plan.

Vesting

Participants are fully and immediately vested in their voluntary and rollover contributions and Plan earnings thereon. Participants vesting in their employer contributions, are as follows:

Participant Accounts

The Plan administrator establishes and maintains a separate account for each participant, which is credited for rollover and voluntary contributions the participants make, Company contributions, and Plan earnings and expenses. Income earned and net appreciation or depreciation on Plan investments, for a given investment, are allocated in proportion to the participant's account balances in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Each participant may borrow up to the lesser of: (1) 50% of the present value of the participant's vested interest in the account, or (2) \$50,000, less currently outstanding notes receivable. The notes are secured by the vested balances in the participant's account. No note shall be less than \$1,000 and only one note at a time is allowed. The notes shall bear a reasonable rate of interest as determined by the Plan administrator. At December 31, 2024, the outstanding notes bear interest ranging from 4.25% to 9.50% per annum. Any such borrowings are to be repaid within five years, unless the note is for the purchase of a principal residence for which a repayment period may not extend beyond 15 years. A note becomes immediately due and payable upon a participant's termination of employment, death or disability.

1. Description of the Plan

Forfeitures

Upon termination of employment participants forfeit their non-vested balances. These accounts may be used to reduce future Company contributions or to pay the administrative expense of the Plan. At December 31, 2024 and 2023, there were \$73,217 and \$61,288, respectively, of forfeited non-vested account balances. There were no forfeited amounts used to reduce administrative expenses or future Company contributions during the year ended December 31, 2024.

Retirement

The normal retirement age is defined as when the participant reaches the age of 65. At the normal retirement date, the participant is entitled to 100% of their vested balance. Early retirement is not permitted.

Distributions of Benefits

Distributions to participants are available upon the following events: retirement, termination of employment, the attainment of age 59 ½ or death. A participant's benefit consisting of his/her entire vested account balance can be paid in the form of either lump sum distribution, partial withdrawal or substantially equal installments basis. A participant with an account balance in excess of \$5,000 may elect to defer payment until the attainment of the normal retirement age of 65. A participant's written consent will be required because of termination of employment for any distribution before age 65 if his/her vested account balance is greater than \$5,000. If the balance is \$1,000 or less, and the Participant makes no elections, then the amount will be automatically rolled over to an IRA provide the amounts are at least \$.01. The Plan also provides for hardship withdrawals to participants meeting certain requirements as described in the Plan document. Participants must begin receiving Required Minimum Distributions, under IRS guidelines, upon reaching the age of 73.

Administrative Expenses

Administrative expenses may be paid out of the Plan or by the Company. The Company incurred certain administrative expenses relating to the Plan without charge to the Plan during 2024.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

2. **Summary of Significant Accounting Policies**

Use of Estimates and Assumptions

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion on fair value measurements. Purchases and sales of securities are reflected on a trade date basis. Dividend income is recorded on the ex-dividend date. Interest income is accrued when earned. The Plan presents, in the Statement of Changes in Net Assets Available for Benefits, the net appreciation(depreciation) of the fair value of its investments, which includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan documents. No allowance for credit losses has been recorded as of December 31, 2024, or 2023.

Payment of Benefits

Benefit payments to participants or beneficiaries are recorded when paid.

Risks and Uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks including, but not limited to, interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances, and the amounts reported in the Statements of Net Assets Available for Benefits.

2. Summary of Significant Accounting Policies

Income Tax Status

The Plan is an adoption of a prototype standardized plan that received an Internal Revenue Service (“IRS”) opinion letter on June 30, 2020, stating that the prototype plan, as then designed, was then in compliance with the applicable requirements of the IRC. An employer adopting this prototype plan is considered to have a plan qualified under Section 401(a) of the IRC. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualified status. The Plan administrator and the Plan’s legal counsel believe that the Plan is designed and is currently operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the trust established under the Plan is tax-exempt. No provision for income taxes has been included in the financial statements since the Plan has no unrelated business income tax.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the DOL or the IRS. The Plan administrator has analyzed the tax position taken by the Plan and has concluded that as of December 31, 2024, and 2023, there are no uncertain positions taken, or expected to be taken, that require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the DOL or the IRS, however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through July 31, 2025, which is the date the financial statements were available to be issued.

3. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants would become 100% vested in their employer contributions.

4. Investments

For the year ended December 31, 2024, the Plan's investments appreciated (including gains and losses on investments bought and sold, as well as held during the year) in value by \$2,267,847.

5. Fair Value Measurements

The Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

5. Fair Value Measurements

Below is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts: Valued at the NAV of units of the Trustees, common collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. There are currently no redemption restrictions or unfunded commitments on these investments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
