INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Opinion

1. Description of the Plan

(the Company and Employer) established the Real-Time Innovations, Inc. 401(k) Plan (the Plan), effective March 1, 1998, to provide participants with a means to fund their retirement on a tax-deferred basis. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan under the related provisions of the Internal Revenue Code (the Code) and applicable state laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company is the Plan sponsor and Plan administrator. The Plan is administered by Company employees, who are responsible for selecting investment options offered under the Plan and monitoring investment performance and Plan compliance. Ascensus Trust Company (Ascensus) serves as the Plan's trustee. Ascensus holds, invests, and reinvests the Plan assets in the interest and direction of the participants and their beneficiaries. Vanguard Retirement Plan Services (Vanguard) is the recordkeeper and has outsourced recordkeeping services to Ascensus, Inc.

Eligible Participants:

Employees, as defined by the Plan agreement, age 21 years or older, may participate in the Plan immediately upon date of hire.

Contributions:

Participants may make contributions to the Plan through pre-tax salary reductions or Roth post-tax deductions up to 100% of annual compensation, as defined, subject to certain limitations under the Code. Participants who have reached the age of 50 may also elect to withhold additional catch-up contributions under the Code. Participants may also contribute amounts representing distributions from other qualified plans (rollovers), subject to Code regulations.

The Company may make discretionary matching contributions or profit-sharing contributions to the Plan at the option of the Company's Board of Directors. In 2024, the Company elected to make matching contributions equal to 50% of participant contributions, up to 6% of their total eligible compensation, per pay period. Compensation is defined by the Plan agreement.

Contributions are subject to Code regulations.

1. Description of the Plan (continued)

Participant Accounts:

Participant accounts are credited with the participant contributions, Company contributions, if any, and an allocation of earnings (less any losses) thereon. Allocations are based on participant earnings or account balances, in accordance with Plan provisions. The benefit to which participants are entitled is the benefit that can be provided from participant accounts.

Participants may elect to invest their accounts in a variety of participant-directed investment options offered by the Plan that are designed to provide the participants with a wide range of investment options. Participants may authorize transfers among investment options at any time.

In addition, participants can choose to invest in and manage a broader range of investments through participant-managed Schwab self-directed brokerage accounts. Investment choices offered to participants in these self-directed brokerage accounts include most equity securities listed on major domestic stock exchanges, additional mutual funds and over-the-counter stocks, bonds, and other fixed-income securities.

Vesting:

Participants are immediately vested in their contributions, plus allocated earnings (less any losses) thereon. Vesting in Company contributions, plus allocated earnings (less any losses) thereon, is based on years of continuous service. Participants become 25% vested after one year of service, 50% after two years of service, 75% after three years of service and fully vested after four years, or upon retirement, disability, Plan termination, or death.

Forfeitures:

The forfeited non-vested portion of participant account balances may be used to reduce Company contributions or pay administrative expenses. Forfeitures of \$32,794 were used to reduce employer contributions in 2024. At December 31, 2024 and 2023, there were \$8,784 and \$0 forfeitures available for future use.

1. Description of the Plan (continued)

Notes Receivable from Participants:

Participants may borrow up to one-half of their vested account balance, not to exceed \$50,000, for a period not to exceed five years, except for notes used to purchase a primary residence for which a longer term may be granted. Participant notes are evidenced by a written note, bear a rate of interest 1% above the prime rate as specified in The Wall Street Journal and are collateralized by the vested participant account balance. Participants may only have one note outstanding at any time. The interest rates on notes outstanding at December 31, 2024 ranged from 4.25% to 9.50%. Repayment of principal and interest is generally made through payroll deductions.

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan agreement.

Payment of Benefits:

Upon termination of service, participants may elect to leave their account balance in the Plan or receive their benefits in a lump sum amount equal to the value of their vested account, or in partial payments. Terminated participant accounts below \$7,000 may be automatically distributed directly to participants without participant approval. The Plan also allows for certain in-service and hardship payments of benefits to current employees. Benefits are recorded when paid.

Administrative Expenses:

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and, thus, are not separately disclosed in the financial statements. Certain account maintenance fees are charged to the Plan and allocated to participant accounts. All other administrative expenses related to the Plan are paid by the Company and are not reflected in the Plan's financial statements.

Risks and Uncertainties:

Participants may invest their account balances in a variety of investment options offered by the Plan. Investments are exposed to various risks, such as interest rates, market fluctuation and credit risks. Due to the level of risk associated with certain investment options offered by the Plan, it is at least reasonably possible that changes in risk in the near term could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and to terminate the Plan at any time, subject to the provisions of ERISA. In the event of a Plan termination, participants would become fully vested in their accounts and distributions would be made to participants, as described in the Plan agreement.

2. Summary of Significant Accounting Policies

Basis of Accounting:

The Plan's financial statements are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates:

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investments:

Investments consist of mutual funds, a money market fund, and participant-managed retirement accounts. These investments are reported at fair value and accounted for as follows:

Mutual Funds and Money Market Fund: These funds are valued at the net asset value (NAV) of shares held by the Plan at year end based on quoted prices in active markets.

Participant-Managed Retirement Accounts: These accounts are comprised of participant-managed Schwab self-directed brokerage accounts, which consist of shares in various interest-bearing cash accounts, mutual funds, money market funds, over-the-counter equity securities, bonds and other fixed-income securities valued based on quoted prices in active markets.

2. Summary of Significant Accounting Policies (continued)

Fair Value Measurement:

The Plan uses a three-level hierarchy for fair value measurement based on the nature of inputs used in the valuation of an asset or liability at the measurement date. The three-level hierarchy prioritizes, within the measurement of fair value, the use of market-based information over entity-specific information. Fair value focuses on an exit price and is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The inputs or methodology used for valuing financial instruments are not necessarily an indication of the risk associated with those instruments.

The three-level hierarchy for fair value measurement is defined as follows:

Level I: Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.

Level II: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.

Level III: Inputs to the valuation methodology, which are significant to the fair value measurement, are unobservable.

A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The Plan's investments are classified as Level I within the fair value hierarchy at December 31, 2024 and 2023.

Income Recognition:

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual method of accounting. Dividends are recorded on the ex-dividend date. Net appreciation includes gains and losses on the Plan's investments bought, sold, or held during the year.

3. Information Prepared and Certified by the Qualified Institution

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus, the qualified institution of the Plan, has certified to the completeness and accuracy of the:

- investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- net appreciation in fair value of investments, dividends and interest, and interest on notes receivable from participants on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- investment information included in the footnotes and on the supplemental schedule of assets (held at end of year) as of December 31, 2024.

4. Income Tax Status

The Plan administrator has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable provisions of the Code. The Plan document has been amended and restated since receipt of the letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and related state statutes and is, therefore, qualified, and the trust that forms a part of the Plan is exempt from federal and state income taxes.

GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded, as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

5. Party-In-Interest Transactions

Certain Plan investments are managed by Vanguard. As Vanguard is the Plan's recordkeeper, purchases and sales of the Plan's investments qualify as party-in-interest transactions. Notes receivable transactions with participants qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

6. Nonexempt Prohibited Transactions

In 2024 and 2023, the Plan sponsor did not timely remit participant contributions and note repayments of \$588,248 and \$265,225, respectively, as required by the Department of Labor (DOL), due to administrative errors attributed to the Plan's recordkeeper. The Company remitted estimated lost earnings to the Plan in 2024 to correct these delinquent remittances. These late remittances are considered nonexempt prohibited party-in-interest transactions by the DOL, which would jeopardize the Plan's tax-exempt status.

7. Subsequent Events

Subsequent events have been evaluated through July 22, 2025, which is the date the financial statements were approved by the Plan administrator and available to be issued.
