To the Plan Administrator

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of PCF/RCT 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of PCF/RCT 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of PCF/RCT 401(k) Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule, as listed in the table of contents, as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Plan Description

The following description of the PCF/RCT 401(k) Profit Sharing Plan (the Plan) (formerly the Pacific Coast Fruit Company 401(k) Profit Sharing Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions. The most recent restatement of the Plan is effective July 14, 2021.

General

The Plan is a defined contribution plan covering all employees of Pacific Coast Fruit Company, Inc.; Pacific Coast Trading Company LLC; Rose City Transportation, Inc.; Alloro Vineyard, Inc.; and Alloro Agricultura, LLC (collectively referred to as the Company), excluding collective bargaining (union) employees. Employees who have completed one year of service and are age 21 or older are eligible for profit sharing contributions. Employees who have completed three consecutive months of service and are age 21 or older are eligible for deferral contributions. A participant may enter the Plan on the first day of the calendar quarter upon reaching eligibility. The Plan Administrator and investment committee oversee governance of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan includes automatic enrollment for newly eligible employees. The Company will automatically deduct 3 percent of a participant's compensation (as defined in the Plan Agreement), on a pre-tax basis. Participants have the option to change their rate of contribution, elect Roth contributions or decline participation entirely. Total annual deferrals may not cause the participant's total contributions to exceed limitations provided by the Internal Revenue Code (IRC). Additionally, employees age 50 or older are eligible to contribute "catch-up" contributions up to Internal Revenue Service (IRS) limits. The Plan has also implemented an auto escalation feature which increases by 1 percent each year, on the participant's anniversary date, up to a maximum of 6 percent of compensation. Participants may also contribute amounts representing rollover distributions from other qualified defined contribution plans.

The Company may make discretionary nonelective (profit-sharing) contributions. Participants must complete 1,000 hours of service in the Plan year and be employed on the last day of the year to share in an allocation of Company profit-sharing contributions. All contributions are limited to the applicable amounts as prescribed by the IRC. For the years ended December 31, 2024 and 2023, the Company made a profit-sharing contribution of 3 percent and 2 percent, respectively, of the participants' eligible compensation for all employees of Rose City Transportation and made a profit-sharing contribution of 1 percent of the participants' eligible compensation for employees of all other participating employers.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contribution, (b) the Plan's investment earnings or losses, and (c) certain Plan administration costs not covered by the Plan Sponsor. The benefit to which a participant is entitled is the accumulated vested balance of the participant's account.

1. Plan Description, continued

Vesting

Participants are immediately vested in their elective deferrals and rollover contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant becomes 100 percent vested after three years of credited service, with no graded vesting occurring prior to three years of credited service.

Forfeitures

The non-vested account of a participant will be forfeited if a participant is terminated. Nonvested accounts forfeited during the years ended December 31, 2024 and 2023 totaled \$5,451 and \$10,276, respectively. Forfeited accounts can be used to reduce employer profit share contribution or pay administrative expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$18,832 and \$22,737, respectively. Forfeitures of \$9,357 and \$3,111, net of earnings, were used to offset employer contributions for the years ended December 31, 2024 and 2023, respectively.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. Loan terms range from 1 to 5 years or up to 15 years for the purchase of a primary residence. The loans are secured by the vested balance in the participant's account and bear interest at a rate of 1 percent plus the prime rate. Principal and interest installments are paid ratably through payroll deductions. Participants may have no more than one loan outstanding with the Plan.

Payments of Benefits

On termination of service, death, disability, or retirement, a participant or beneficiary may elect to receive an amount equal to the value of the participant's vested interest in their account in a lump-sum amount, annuity, or direct rollover to an eligible retirement plan. Participants may take an in-service distribution upon reaching age 59½. Withdrawals from the Plan may also be made upon circumstances of financial hardship in accordance with provisions specified in the Plan. If a participant has an immediate and heavy financial need, hardship withdrawals are allowed under the Plan in an amount not to exceed the lesser of the participant's elective deferrals and vested employer contributions or the amount of the financial need.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

2. Summary of Significant Accounting Policies, continued

Investment Valuation and Income Recognition

The Plan's investments in registered investment companies are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment in common/collective trusts, which are not considered to be fully benefit responsive at the Plan level, are valued at fair market value which approximates contract value. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. Related fees are charged directly to the borrowing participants account and are included in administrative expense when incurred. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Plan administrative expenses, excluding certain transaction fees and quarterly asset fees paid by the Plan from Plan assets, are paid by the Company or may be paid from participant forfeitures. Expenses paid by the Company are excluded from these financial statements. Investment related expenses are included in, or as a reduction from, investment income. Quarterly asset and transaction fees associated with distributions are included in administrative expenses and charged directly to the participant's account.

Revenue Sharing

The Plan contains a revenue sharing expense offset arrangement where the Plan is credited a fixed, monthly amount which is used to pay investment advisory expenses. \$20,000 was credited to the account and used to pay investment advisory expenses for the years ended December 31, 2024 and 2023. There was no ending balance in the Plan's revenue sharing account as of December 31, 2024 and 2023.

Recent Accounting Standard Adopted

On January 1, 2023, the Plan adopted Accounting Standards Update (ASU) 2016-13 Financial Instruments – Credit Losses (Topic 326): *Measurement of Credit Losses on Financial Instruments*, and all related amendments (ASC 326), which replaced the incurred loss methodology for recognizing credit losses with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. CECL requires an estimate of lifetime expected credit losses to be recognized for financial assets based on historical experience, current conditions, and reasonable and supportable forecasts, and for the financial assets to be presented at the net amount expected to be collected on the statements of net assets available for benefits. The financial assets held by the Plan that are subject to ASC 326 is employer contributions receivable.

The Plan adopted ASC 326 effective January 1, 2023. There was no impact to the financial statements as a result of adopting this standard.

3. Information Prepared and Certified by the Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC, acting as the trustee of the Plan, has certified the following data included in the accompanying financial statements and supplemental schedule is complete and accurate as of and for the years ended December 31:

4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of full or partial Plan termination, affected participants would become 100 percent vested in their Company contributions.

5. Tax Status

The Company has adopted a Non-Standardized Pre-Approved Profit Sharing plan with CODA sponsored by Empower Retirement, LLC. The Internal Revenue Service issued an opinion letter on November 14, 2022, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

6. Related Party Transactions

Certain Plan investments are maintained and managed by Empower Insurance Annuity Company (formerly Great-West), an affiliate of the trustee. The Plan's investments are also managed by Empower Advisory Group, LLC, an affiliate of the trustee. Empower is the fiduciary and the trustee of the Plan. Fees paid to Empower were \$130,569 and \$117,571 for the years ended December 31, 2024 and 2023, respectively. These party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

7. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

7. Fair Value Measurements, continued

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to their fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common/collective trust: Units held in the common/collective trusts are valued using the net asset value (NAV) of the fund. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. Participant transactions (purchases and sales) may occur daily at NAV. Pursuant to Accounting Standards Update (ASU) 2015-07, *Fair Value Measurements*, the common/collective trusts measured at NAV have not been classified in the fair value hierarchy. All common/collective trusts investments held by the Plan have no unfunded commitments, and the investments may be redeemed by participants on a daily basis with no required notice period.

Registered investment companies: The Plan's investments are units of mutual funds held within a group annuity contract. These funds are valued at the daily closing price as reported by the fund. All mutual funds held by the Plan are open-end mutual funds that are registered with the SEC and are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
