Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Haven for Hope 403(b) Thrift Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Responsibilities of Management for the Financial Statements

NOTE A – SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation: The financial statements of 403(b) Thrift Plan for the Employees of Haven for Hope of Bexar County (“Plan”) are prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles.

Recognition of Income: The basis of investments held by the Plan is adjusted annually to closing market values and unrealized gains and losses are recorded as part of this adjustment. Realized gains and losses on investments are computed using adjusted basis. Security transaction expenses are considered in computing realized gains and losses on investments. Interest income from the interest accumulation account is recognized as it is earned and credited to the account. Gains and losses (realized and unrealized) are reported in net appreciation in fair value of investments in the statement of changes in net assets available for benefits.

Investments: Investments are carried at fair value, as determined by quoted prices. Purchases and sales of securities are recorded on a trade-date basis. Dividends are considered when the fair value is determined.

Participants’ Notes Receivable: Participants’ notes receivable are stated at their unpaid principal balance plus any accrued interest. An allowance was not considered necessary at year end. Interest on participants’ notes receivable are recorded on the accrual basis. If a participant ceases to make a loan payment and the Plan Administrator deems the participant note to be in default, the loan balance is reduced and a benefit payment to the participant is recorded.

Benefit Payments: Benefits are recorded when paid.

Subsequent Events: Subsequent events have been evaluated by management through the date of the independent auditor's report.

Use of Estimates: The preparation of financial statements in conformity with U. S. generally accepted accounting principles requires estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Concentration of Credit Risks: The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statement of net assets available for plan benefits.

NOTE B – DESCRIPTION OF THE PLAN

The following description provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan, established September 1, 2008, covering virtually all employees of Haven for Hope of Bexar County (“Sponsor”). There are no minimum age or service requirements to make salary reduction contributions. The Plan is for the exclusive benefit of its participants and their beneficiaries. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Amendments and Restatement: The Plan was restated effective January 1, 2022 to adopt a volume submitter 403(b) Plan under Ascensus, LLC. Additionally, the Plan operationally implemented certain changes permitted by the Coronavirus Aid, Relief, and Economic Security Act (the CARES Act) and the Setting Every Community Up for Retirement Enhancement Act of 2019 (the SECURE Act), which changes the Plan to allow certain eligible individuals to receive coronavirus-related distributions, suspend required minimum distributions, and delay the commencement date for require minimum distributions. Written amendments to the Plan to reflect these operational changes and formally adopted in January 2023.

The plan was restated effective January 1, 2023 to adopt an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation and their contributions are invested in a designated fund until changed by the participant. If a participant does not choose a different amount (including zero), the percentage will be automatically increased each January 1st by 1% up to a maximum of 6%.

Contributions: Participants may contribute up to 100% of their compensation either on a pretax or after-tax Roth basis, subject to the limitations of IRC section 402(g). Participants may also contribute amounts representing distributions (“rollovers”) from other qualified defined benefit or contribution plans. As required by the Plan, the Sponsor contributes a non-elective 6% of a participant’s eligible compensation for all participants who have reached the age of 18.

Participant Accounts: Each participant's account is credited with their contribution and allocations of a) the Plan Sponsor contributions, b) Plan earnings, and c) charged with an allocation of administrative expenses. Allocations are based on the participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are always 100% vested in their voluntary contributions and any earnings thereon. Vesting in Sponsor matching contributions is based on years of service as follows:

Less than one year	0%	3 years	60%
1 year	20%	4 years	80%
2 years	40%	5 years or more	100%

Forfeitures: Forfeitures are retained in the Plan and may be used to pay for administrative expenses or allocated as employer matching contributions. For the years ended December 31, 2024 and 2023, forfeitures of \$28,785 and \$10,658 were used to offset the Plan Sponsor matching contributions.

Participants' Notes Receivable: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1 to 5 years. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits: Payment of the vested account balance is immediate when the participant reaches normal retirement age, dies or terminates employment. If the total vested account balance is less than \$1,000, the participant will receive a single lump sum payment. If the vested account balance is equal to or greater than \$1,000, various payment options are available and are described more fully in the Plan agreement. Hardship withdrawals are available to participants upon approval.

Administrative Expenses: Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Plan Termination: Although it has not expressed intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE C – INVESTMENTS CERTIFIED BY THIRD PARTY (unaudited)

As permitted by Department of Labor CFR 2520.103-8, investments and participants' notes receivable at December 31, 2024 and 2023, and the related investment earnings and interest on participants' notes for the years then ended, were certified and held by Ascensus Trust Company, the Trustee, and were not audited by the independent auditor.

NOTE D – TRANSACTIONS WITH PARTIES-IN-INTEREST

The Plan's administrative expenses are paid either by the Plan or the Plan Sponsor as allowed by the Plan document. Expenses paid directly by the Plan Sponsor are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation of fair value of investments.

NOTE E – INCOME TAX STATUS

The Plan Sponsor adopted the Volume Submitter 403(b) Plan of the Custodian, Ascensus, which has been accepted under section 403(b) of the Internal Revenue Code. The Plan received a favorable opinion letter from the Internal Revenue Service on January 1, 2018.

The Plan has been amended since receiving the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Management is not aware of any tax positions that would have a significant impact on its financial position. Its federal annual returns for the last four years remain subject to examination.

NOTE F – FAIR VALUE MEASUREMENTS

In accordance with U.S. generally accepted accounting principles, the Plan utilizes a fair value hierarchy that prioritizes the inputs for the valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets
 - quoted prices for identical or similar assets or liabilities in inactive markets
 - inputs other than quoted prices that are observable for the asset or liability
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means
 - if the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Money Market Funds: Valued at cost plus accrued interest.

Mutual Funds: Valued based on quoted prices in an active market.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
