INDEPENDENT AUDITORS' REPORT

To the Trustees and Participants of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of **G & F Industries Inc. Profit Sharing Retirement Plan**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits - modified cash basis as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits - modified cash basis for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of **G & F Industries Inc. Profit Sharing Retirement Plan** financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- the information in the statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. Profit Sharing Retirement Plan** and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. Emphasis of Matter — Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements and supplementary schedule are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with modified cash basis of accounting, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Notes to Financial Statements
For the Years Ended December 31, 2024 and 2023

1. Description of the Plan

The following description of the G & F Industries Inc. Profit Sharing Retirement Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of G&F Precision Molding Inc. (the “Company”) following satisfaction of eligibility requirements and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Company has appointed two executives as trustees of the Plan. They are responsible for oversight of the Plan, determining the appropriateness of the Plan’s investment offerings and monitoring investment performance.

Effective June 1, 2022, the Plan was restated to comply with the Internal Revenue Service requirement that all Plans using pre-approved documents are required to complete a document update every six years (Cycle 3 Restatement).

On December 29, 2022, President Biden signed into law the Consolidated Appropriations Act of 2023, which includes the package of retirement provisions referred to as “SECURE 2.0”). These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting more participants into the retirement system, finding ways for them to accumulate more assets, and then ensuring they get connected with those assets when retirement comes. Many of the provisions of the SECURE 2.0 are effective on January 1, 2023, and beyond and will require significant changes to plan administration and recordkeeping.

Eligibility

Substantially all employees of the Company who have reached the age of 21 are eligible to participate in the Plan on the first day of the month following the date on which an employee meets the eligibility requirements, which is completion of three months of service.

Participant Contributions

Each year, participants may elect to contribute to the Plan on a pre or post tax basis, up to 85% of eligible compensation. Participants may also rollover amounts representing distributions from other eligible retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 3% of eligible compensation. The Plan also includes annual automatic deferral increases of 1% (not to exceed 6% of compensation) for each active participant enrolled through automatic enrollment.

1. Description of the Plan (Continued)

Employer Contributions

The Company will make matching contributions to the account of each eligible participant in an amount equal to 40% of the amount of the participants' elective deferrals that do not exceed 6% of the participants' compensation. The Plan also provides for the Company to make a discretionary profit-sharing contribution on an annual basis. For the years ending December 31, 2024 and 2023, there were no discretionary profit-sharing contributions.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, employer match, and an allocation of the Company's discretionary contributions, if any, and Plan earnings. Allocations are based on participant earnings or account balances, as defined.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants vest 20% per year after the second year in the Company's matching contribution and discretionary profit-sharing contributions. The participants are 100% vested in the Company's matching contribution and discretionary profit-sharing contributions after six years.

Investment Elections

Participants direct the investment of their contributions, any Company matching contributions and any profit-sharing contributions into investment options offered by the Plan. Each participant has the ability to change his or her investment allocations at any time.

Benefit Payments and Plan Withdrawals

Upon termination of employment, retirement, disability, or death, the participant or his or her beneficiary, is entitled to receive a distribution of the participant's entire vested balance. Participants who have attained age 59 1/2 may withdraw any portion of the vested balance in their account.

The Plan allows for hardship withdrawals. A hardship withdrawal is allowed for certain financial hardships that result from extraordinary medical expenses, educational expenses, expenses to purchase a principal residence, or costs to prevent eviction from or foreclosure on a principal residence.

Forfeited Accounts

Forfeitures represent the non-vested portion of terminated participants' account balances. Forfeitures occur in the Plan year that participants receive distributions of their entire vested accounts or after five consecutive breaks (years) in vesting service. Forfeitures may be used to offset plan expenses and to reduce future employer contributions. The Plan recorded forfeitures of \$19,881 and \$10,080 in plan years 2024 and 2023, respectively. At December 31, 2024 and 2023, \$12,231 and \$5,561, respectively, were used to reduce employer contributions. At December 31, 2024 and 2023, there were \$13,605 and \$5,647, respectively, of unallocated forfeitures.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements have been prepared on the cash basis of accounting modified to allow for investments to be valued at fair value, unrealized gains and losses to be recorded and to record other liabilities, which consists of distribution stale checks returned to the Plan as the Plan Sponsor searches for the participant. Under this basis, contributions are recognized when received rather than when withheld or determined, interest and dividends are recognized when received rather than when earned and expenses are recognized when paid rather than when the obligation is incurred. This basis differs from the accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (Note 4), except for the stable value fund, which is reported at net asset value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine valuation policies using information provided by the investment advisors and Reliance Trust Company. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest and dividends are recorded when received. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Concentration of Credit Risk

Financial instruments that potentially subject the Plan to concentrations of credit risk are part of the holdings in Plan's investments. Management believes that the Trustee maintains the Plan's investments with high credit quality institutions and attempts to limit the credit exposure to any particular investment.

Payments of Benefits

The Plan records benefit payments to withdrawing participants when paid. Under the rules for preparation of Form 5500, the Plan's Form 5500 will reflect an accrual for the amount to be paid to participants who withdrew from the Plan prior to year-end, and who had requested a distribution which was approved but not yet paid at period end, if any. There were no unpaid distributions at December 31, 2024 or 2023.

Plan Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Administrative expenses incurred by the Plan include distribution fees charged directly to the participants' accounts and investment management fees that are netted against investment returns.

3. Information Prepared and Certified by the Trustee (Unaudited)

The Plan's investments were held in trust and administered by Reliance Trust Company (the trustee of the Plan). All investment information presented in the accompanying financial statements and supplementary schedules, including investments held and net appreciation in fair value of investments and interest and dividends, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Trustee.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Unadjusted quoted prices in active markets that are accessible at the measurement date for identical assets or liabilities.

Level 2 – Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly.

Level 3 – Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

When more than one level of input is used to determine fair value, the financial instrument is classified as level 1, 2 or 3 according to the lowest level input that has a significant impact on the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the SEC. These funds are required to publish their daily net asset value and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

- Stable value collective trust fund is a stable value fund that is composed primarily of fully benefit responsive investment contracts that are valued at the net asset value of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investments for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12-month notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Gains and losses included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023 are reported in net appreciation in fair value of investments.

The Plan's policy is to recognize transfers between levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no transfers between Levels 1 and 2 and no transfers into or out of Level 3.

5. Reversal of Stale-Dated Check

During the year, previously issued distribution checks amounting to \$22,668 were not cashed by participants within the allowable timeframe and were returned to plan assets as investments. These amounts remain plan assets until the checks are cashed or otherwise resolved.

6. Tax Status of the Plan

The Plan has adopted a prototype plan document and is relying on the prototype sponsor's advisory letter from the Internal Revenue Service dated October 6, 2020. The letter states that the prototype and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the prototype plan has been amended since receiving the advisory letter, the prototype sponsor and the plan administrator believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Modified cash basis of accounting requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

7. Risks and Uncertainties

The Plan utilizes various investment instruments, including mutual funds. Investment securities are exposed to various risks, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the financial statements.

8. Termination

Although it is the Company's intention that the Plan will be continued indefinitely, the Company may terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

9. Subsequent Event

Effective March 3, 2025, the Plan changed its name from G & F Industries Inc. Profit Sharing Retirement Plan to G & F Precision Molding, Profit Sharing Retirement Plan. The financial statements for the years ended December 31, 2024 and 2023 have been prepared using the plan name in effect during that period.

The Plan Administrator has evaluated subsequent events through July 25, 2025 the date which the financial statements were available to be issued.
