Note 1 - Plan Description

The following description of Applied Control Equipment 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time and part-time employees of Applied Control Management, Inc. (the "Company") and all full-time and part-time employees of Applied Control Equipment, LLLP, established on August 1, 1996 and subsequently restated on February 18, 2022. The Plan is available to employees who have completed three months of service, excluding leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The board of directors of Applied Control Management, Inc. administers the Plan. Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal) serves as the trustee, manages plan assets, and maintains the Plan's records.

Contributions

The Plan provides for employee salary deferral contributions up to a maximum of 100 percent of annual eligible compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants are automatically enrolled in the Plan to defer 5 percent of their compensation upon meeting eligibility requirements, unless the participant elects otherwise. Eligible employees who have reached age 50 during the plan year may elect to make catch-up contributions, as limited by the Internal Revenue Service (IRS). Employee contributions to the Plan are made through regular payroll deductions.

The Plan allows participants to contribute up to 100 percent of their annual eligible compensation on an after-tax basis. A participant's combined pretax and Roth 401(k) contributions cannot exceed the maximum amount allowed by law. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan is operating pursuant to the safe harbor provisions of Internal Revenue Code Section 401(k)(12). The Company's safe harbor matching contributions will equal 100 percent of elective deferrals up to 3 percent of compensation deferred by the participant and 50 percent of elective deferrals between 3 percent and 5 percent of compensation deferred by the participant. Matching contributions are determined on each pay period based on participant elective deferrals. Additionally, the Company may make discretionary nonelective and additional discretionary contributions on deferrals. Nonelective and additional discretionary contributions will be allocated in proportion to the participant's eligible earnings. Participants are eligible to receive nonelective contributions if they are employed on the last day of the plan year and have completed 1,000 hours of service during the plan year. The employer contributions are funded on a payroll basis. The Company did not make any discretionary nonelective contributions or discretionary matching contributions during the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Note 1 - Plan Description (Continued)

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances and may have up to two notes outstanding at any one time. The notes receivable are secured by the balance in the participant's vested account and bear interest at rates that range from 4.25 percent to 10.50 percent, which are commensurate with local prevailing rates determined periodically by the plan administrator. Principal and interest are paid ratably through biweekly payroll deductions.

The plan administrator will fix the term for repayment of any loan; however, in no instance may the term of repayment be greater than 5 years, unless the loan is used to purchase a principal residence, which will be repaid over a longer period, not to exceed 30 years, as established by the plan administrator at the time of the loan.

Vesting

Participants are immediately 100 percent vested in employee salary and rollover contributions, any income or loss thereon, and safe harbor matching contributions.

The Company's discretionary contributions, if any, vest according to the following schedule:

A participant's account becomes 100 percent vested upon death, attaining normal retirement age (age 65) while an employee, retirement due to disability, or termination of the Plan.

Payments of Benefits

Distributions are payable upon retirement, death, disability, termination of employment, or attainment of 59½ years of age in the form of a lump-sum amount equal to the vested balance of a participant's account or annual installments over a period not to exceed a participant's assumed life expectancy. If a participant reaches age 59½, the participant may withdraw all or a part of his or her vested account balance at any time, up to two times in a plan year.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures can be used to pay plan expenses, reduce employer matching contributions, or can be reallocated to participants. The Company allocates forfeitures to participants based on the participant's compensation, as defined. Allocations of forfeitures are considered additional company contributions and are subject to the vesting provisions of company contributions. During the year ended December 31, 2024, forfeitures of \$53,109 were used to offset employer matching contributions. At December 31, 2024 and 2023, the forfeited account balances were insignificant.

Note 1 - Plan Description (Continued)

Related Party and Party-in-interest Transactions

Certain plan assets are in investment funds managed by Principal or its affiliates. Principal is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines. In addition, the Plan provides for participant notes receivable, which are party-in-interest transactions, that are exempt from the prohibited transaction rules.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Mutual funds are recorded at quoted market values. The collective investment trust funds are valued at net asset value per share (NAV) or its equivalent of the funds, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are secured by the balances in the participant's account and are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Note 2 - Summary of Significant Accounting Policies (Continued)

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Additionally, some investments held by Principal are invested in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks included devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those of securities of comparable U.S. companies.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including July 31, 2025, which is the date the financial statements were available to be issued.

The Plan was amended effective January 1, 2025 to update certain provisions. The amendment reduced the maximum loans outstanding for a participant at any one time from two to one and allows for super catch-up contributions not to exceed 150 percent of the standard catch-up contribution limit for participants that are eligible in accordance with the SECURE 2.0 Act.

Note 3 - Certified Information

Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

Note 4 - Fair Value Measurements (Continued)

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan’s assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
