INDEPENDENT AUDITORS' REPORT

To the Trustees of
Bennett Mt. Kisco Chevrolet 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Bennett Mt. Kisco Chevrolet 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Bennett Mt. Kisco Chevrolet 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Note A

Description of Plan

The following description of the Bennett Mt. Kisco Chevrolet 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General:

The Plan is a multiple employer plan sponsored by CHV Egg Harbor, Inc. dba Bennett Chevrolet. During 2022, substantially all of the assets of Dodge City, Inc., Condor LLC, d.b.a. North Hills Toyota and Milenium, Inc. were sold. As a result, effective November 1, 2023, Dodge City, Inc. resigned as the Employer Plan Sponsor and CHV Egg Harbor, Inc. dba Bennett Chevrolet was designated as the Employer Plan Sponsor and the Plan Administrator of the Plan. The Plan is a defined contribution plan covering substantially all employees of Dodge City, Inc., Milenium, Inc., - T/A Sport Hyundai Dodge; Condor, LLC - T/A North Hills Toyota; Condor Mount Kisco, LLC dba Mount Kisco Chevrolet, Mount Kisco Cadillac; and CHV Egg Harbor, Inc. dba Bennett Chevrolet (the "Company" or "Employer"). Effective November 1, 2023, the Plan was amended to modify the Plan name from Dodge City, Inc. 401(k) Plan to Bennett Mt. Kisco Chevrolet 401(k) Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Administrative Committee is responsible for oversight of the Plan.

Plan Amendments:

Effective January 1, 2024, the Plan was amended to modify the vesting for participants credited with at least 1 hour of service on or after January 1, 2024, to be fully vested in matching and non-elective contributions.

Eligibility:

Provided that the employee is not an "Excluded Employee", the employee may begin participating under the Plan once the employee has satisfied the eligibility requirements and reached the entry date. Employees are eligible to participate and make elective deferral contributions and receive employer matching contributions once they have attained the age of 21 with six months of service. Elective deferral and employer matching contribution entry date is the first day of the Plan year month coinciding with or next following the date the employee satisfies the eligibility requirements. If the employee is a member of a class of employees identified below, the employee is considered an excluded employee and is not entitled to participate in the Plan for the purpose of pre-tax and Roth salary deferrals, employer matching contributions and employer profit-sharing contributions. The excluded employees are:

- Employees covered by a collective bargaining agreement, if retirement benefits were the subject of good faith bargaining, and if the collective bargaining agreement does not provide for participation in this Plan;
- Certain non-resident aliens who have no earned income from sources within the United States;
- Leased employees and individuals not reported on payroll records of the Employer as a common law employee.

Description of Plan (Continued)

Additionally, for purposes of the employer profit-sharing contributions, an employee becomes eligible to participate once they have attained the age of 21 with completion of one year of service. However, to be eligible to receive an allocable portion of an employer profit sharing contribution, participants must reach the applicable employer profit-sharing entry date and be employed on the last day of the Plan year. Profit-sharing contribution entry date is the first day of the Plan year or the first day of the seventh month of the Plan year coinciding with or next following the date the employee satisfies the eligibility requirements.

Contributions:

Eligible employees who have reached the entry date may elect to participate in the Plan by completing a Plan enrollment form and salary deferral agreement to begin contributing pre-tax and/or Roth salary deferrals into the Plan. Each year, participants may contribute compensation, as defined in the Plan document, subject to the maximum amount allowed by the Internal Revenue Code, and make contributions to the Plan with certain limitations as defined by the Plan. For participants who have attained age 50, catch-up contributions are also allowed by the Plan. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). The Company may make discretionary matching contributions, to be determined by the Company, of the participant's salary deferral. For the year ended December 31, 2024, the Company elected to match 25% of the first 4% of base compensation that a participant contributed. Additional profit sharing amounts may be contributed at the discretion of the Company. The Company made no profit sharing contributions for the year ended December 31, 2024. Participants direct the investment of their contributions into various investment options offered by the Plan.

All eligible employees who have not elected a deferral percentage or opted out of the Plan, will automatically have compensation deferred at a rate starting at 3%, with no escalation provision. Employees may affirmatively elect a different percentage or elect not to make a deferral.

Participant Accounts:

Each participant's account is credited with the participant's contributions and the participant's allocation of the Company's contributions and is reduced for loans, withdrawals, and benefit distributions. Participant accounts are further credited or charged with their pro rata share of earnings or losses of the total investments in each investment account and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Description of Plan (Continued)

Notes Receivable from Participants:

Participants may borrow against their investment account balances a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested balance, whichever is less. Generally, loans can be made for a period not exceeding five years; however, in certain circumstances, terms can be extended beyond five years, as defined by the Plan. The loans are collateralized by the vested balance in the participant's account and bear interest at Prime plus 1%. Principal and interest are paid ratably through payroll deductions.

Vesting:

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service. Effective January 1, 2024, the Plan was amended to modify the vesting for participants credited with at least 1 hour of service on or after January 1, 2024, to be fully vested in matching and non-elective contributions.

Payment of Benefits:

Participants may elect to receive either a lump-sum amount equal to the value of their vested interest or annual installments or partial payments as defined in the Plan document upon retirement, termination of service, death, or disability. A terminated employee with a balance of less than \$5,000 may be automatically paid out by the Plan upon termination. Distributions may be made at the participant's election prior to termination upon attainment of age 59 ½ or hardship, as defined in the Plan document.

Forfeitures:

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account represents a forfeiture. Forfeitures may be used to reduce Company contributions or to pay Plan expenses. As of December 31, 2024 and December 31, 2023, forfeiture accounts totaled \$14,008 and \$13,813, respectively. During the year ended December 31, 2024, no forfeitures were used to reduce Company contributions or to pay Plan expenses.

Note B
Significant Accounting Policies

Basis of Accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment Valuation and Income Recognition:

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Administrative Committee determines the Plan's valuation policies. See Note G for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Plan Expenses:

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Company personnel perform various administrative services for the Plan. The payroll and related overhead costs associated with these services are not included as plan expenses. Fees related to participant recordkeeping and specific participant transactions are charged directly to each participant's account and are included in administrative expenses.

Risk and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the financial statements.

Significant Accounting Policies (Continued)

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and the note receivable from participant is recorded as a benefit payment based on the terms of the Plan document.

Contributions:

Participant contributions and the related Company matching contributions are recognized in the period the participant contribution is withheld from compensation.

Payment of Benefits:

Benefit distributions, determined in accordance with provisions of the Plan, are recorded when paid.

Use of Estimates:

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Excess Contributions Payable:

As of December 31, 2024 and 2023, amounts payable to participants totaling \$22,965 and \$10,518 for contributions in excess of amounts allowed by the IRS, as required to satisfy the relevant nondiscrimination provisions of the Plan, are recorded as excess contributions payable, with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025. The Plan distributed the 2023 excess contributions to the applicable participants prior to March 15, 2024.

Note C

Information Certified by the Plan's Trustees

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and December 31, 2023, net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the trustees of the Plan.

Note D

Income Tax Status

On June 30, 2020, the Internal Revenue Service ("IRS") stated that the non-standardized profit-sharing plan with CODA adopted by the Plan, as then designated, qualifies under Section 401(a) of the IRC. The Plan administrator timely adopted the approved Plan. The Plan administrator believes that the Plan is currently being operated in accordance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

During 2024, the Company identified operational errors related to the failure to automatically enroll certain eligible participants in the Plan, as required under the Plan's provisions. In accordance with the Internal Revenue Service's Self-Correction Program ("SCP") under the Employee Plans Compliance Resolution System ("EPCRS"), the Company implemented corrective actions on behalf of the Plan. As part of the correction, the Company funded a Qualified Non-Elective Contribution ("QNEC") of approximately \$66,000 to restore affected participants' benefits. This amount was contributed to the Plan during 2024. Management believes that all necessary steps were taken under the SCP to preserve the Plan's tax-qualified status.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits in progress for any tax periods.

Note E

Related Party Activity

Empower Annuity Insurance Company of America and Empower Trust Company, LLC are the trustees of the Plan; therefore, fees paid to the trustees by the Plan qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited rules of ERISA. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note F

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

The Sponsor announced an agreement to sell substantially all of the assets of Condor LLC, d.b.a. North Hills Toyota on June 1, 2022, and an agreement to sell substantially all of the assets of Dodge City, Inc. on August 22, 2022. As a result, approximately 98% of the employees of Condor LLC and Dodge City Inc. were terminated effective with the sales of the assets of these companies and the Plan will be considered partially terminated. All participants who were terminated during the plan year 2022, the period in which the partial termination occurs, were fully vested in their Plan accounts.

Note G

Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has ability to access.
- Level 2 Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and December 31, 2023.

Mutual funds: Valued at the quoted net asset value of shares traded in active markets and held by the plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note H

Guaranteed Interest Accounts

The Plan has a group annuity contract, the Empower Investments Fixed Account - Series I, with Empower Annuity Insurance Company. This contract is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the general account, subject to a minimum interest crediting rate, and prevailing market conditions. The interest crediting rate is reset quarterly. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract since the contract was determined to be fully benefit-responsive. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Participants may transfer their account balance in the Empower Investments Fixed Account to any other investment option offered under the Plan at any time with no restrictions or penalties, because the contract is designed to be a Plan's only guaranteed/stable value/money market investment. In order to provide the participant with liquidity (100% for participant transfers), there cannot be any actively competing guaranteed/stable value/money market investments in the Plan. Bond funds of durations longer than three years are permitted. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Guaranteed Interest Account (Continued)

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest is based on a formula agreed upon with the issuer but may not be less than zero percent. Such interest rates are reviewed on a quarterly basis for resetting. Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following:

- (a) amendments to the Plan document (including complete or partial Plan termination or merger with another plan),
- (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions,
- (c) bankruptcy of the Company or other Company events that cause a significant withdrawal from the Plan or,
- (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

The Plan Administrator does not believe that any such events are probable of occurring. Upon termination of the group annuity contract, distributions may be subject to conditions set forth in the contract, which may include a market value adjustment. Participant accounts may remain in the contract under certain circumstances.

Note J

Subsequent Events

Effective January 1, 2025, the Plan was amended to revise the automatic enrollment provisions to define a covered employee as any eligible employee who has not made a deferral election. Additionally, the amendment limits participants to one hardship withdrawal within any 12-month period.

Subsequent events have been evaluated through July 30, 2025, which is the date the financial statements were available to be issued.

Note K

Prohibited Transactions

During the year ended December 31, 2022, the Company failed to remit to the Plan's trustee certain participant contributions and loan payments within the period prescribed by Department of Labor regulations. Consequently, the Plan is considered to have engaged in non-exempt transactions with a party-in-interest. The Company is required to rectify the matter by paying lost earnings on the participant contributions that were remitted late. Lost earnings were deposited during 2024.
