Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audit of the financial statements of Guest Services, Inc. Retirement and Benefit Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 26, 2024 (liquidation basis) and the statements of accumulated plan benefits as of September 26, 2024 and December 31, 2023 (liquidation basis), and the related statement of changes in net assets available for benefits for the period ended September 26, 2024 (liquidation basis) and statements of changes in accumulated plan benefits for the period and year ended September 26, 2024 and December 31, 2023 (liquidation basis), respectively, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Guest Services, Inc. Retirement and Benefit Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the period ended September 26, 2024 (liquidation basis), stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Guest Services, Inc. Retirement and Benefit Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As described in Note 8 to the financial statements, the plan sponsor approved a termination of the plan on May 10, 2023, with an effective date of July 31, 2023. However, the plan termination and liquidation was not imminent until the plan was amended for termination on January 6, 2024. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors’ Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error,

as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Their report dated October 10, 2024 indicated that (a) the amounts and disclosures in the 2023 financial statements (going concern basis), other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the united states of america, and (b) the information in the 2023 financial statements (going concern basis) related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Notes to Financial Statements

For the Period Ended September 26, 2024 (liquidation basis)

1. Description of Plan

The following description of the Guest Services, Inc. Retirement and Benefit Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a noncontributory defined benefit plan established effective January 1, 1947, as restated January 1, 2015. Prior to the plan freeze, the Plan covered all employees, excluding those considered highly compensated under the Internal Revenue Code (the IRC), of Guest Services, Inc. (the Company or Plan Sponsor). Effective May 31, 2008, an amendment to the plan agreement was made to add the following conditions of eligibility: no employee hired on or after January 1, 2008, can enter the Plan as an active participant, and no hourly employee can enter the Plan on or after May 31, 2008. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Plan’s Retirement Plan Committee, appointed from the Company’s senior management, determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Company’s Board of Directors.

Effective May 31, 2020, the Plan was amended to freeze the Plan so that no additional benefits shall accrue after the effective date and no employee, former employee, or inactive participant will become an active participant after such date.

On May 10, 2023, the Retirement Plan Committee of the Plan Sponsor approved a plan to terminate the plan effective July 31, 2023. See note 8 to the financial statements for additional information.

Funding Policy

The Plan’s funding policy is for the Company to contribute an annual amount which will allow the Plan to meet or exceed the ERISA minimum funding requirement. As the Plan exceeded the ERISA minimum funding requirement prior to making a contribution, the Company did not contribute to the Plan for the period ended September 26, 2024 (liquidation basis).

Pension Benefits

Benefits under the Plan were frozen as of May 31, 2020. Plan participants are entitled to their plan benefits after terminating employment with vested rights. Participants become vested in the Plan upon completion of at least 5 or attainment of the normal retirement age (65), although the Plan does allow for early retirement at the age of 55. If employees terminate before rendering the required years of service, they forfeit the right to receive the portion of their accumulated plan benefits attributable to the Company’s contributions.

Notes to Financial Statements

1. Description of Plan (Continued)

Existing benefits under the Plan as of May 31, 2020 provided to salaried and hourly employees are defined separately. The hourly accrued benefit will be a monthly annuity payable for 60 months to either the participant or the participant's beneficiary if the participant's death occurs prior to the 60th payment. The salaried accrued benefit for each participant who retires on or after the age of 65 will equal the sum of 1.2% of such participant's average monthly compensation, plus 0.65% of average monthly compensation in excess of covered compensation, multiplied by the participant's years of benefit service, limited to 30 years. The salaried accrued benefit will be a monthly annuity payable for the lifetime of the retired participant. For both salaried and hourly employees, after the participant exceeds age 65, the benefit will be the greater of the participant's accrued benefit on his or her late retirement date or the normal retirement date benefit increased by 3% per year.

Upon termination of employment, pension payments are normally paid in the form of a monthly annuity payable for their lifetime or, if married, in the form of a qualified joint or survivor annuity.

If an active employee dies at age 55 or older, a death benefit equal to the value of the employee's accumulated pension benefit is paid to the employee's beneficiary. In the event of the death of an active participant, or a former participant who has a vested right to an accrued benefit, and who has been married throughout the year preceding the participant's death, the surviving spouse will receive an annuity for life equal to 50% of the participant's benefit determined as if the participant had retired on the date preceding the participant's death under an actuarially equivalent 50% joint survivor form. If the participant, or former participant, is not eligible for an early retirement benefit at the participant's date of death, the benefit will be based on the accrued vested benefit at the participant's date of death and payment will be deferred to the participant's earliest retirement date, with reductions for early commencement.

Active employees who become totally disabled receive annual disability benefits that are equal to the equivalent normal retirement benefit they have accumulated as of the time they become disabled. Disability benefits are paid until normal retirement age, at which time disabled participants will receive the normal retirement benefit computed as though they had been employed to normal retirement age, with their annual compensation remaining the same as at the time they became disabled. Active hourly employees who become totally disabled receive a disability benefit payable equivalent to an early retirement benefit reduced for the first 180 months as an early retirement with an additional reduction for each additional month by which payments commence before the normal or early retirement, as appropriate.

2. Summary of Accounting Policies

Basis of Accounting

The 2024 financial statements of the Plan have been prepared on the liquidation basis of accounting. The 2023 financial statements had been prepared on the ongoing basis of accounting.

2. Summary of Accounting Policies (Continued)

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein; disclosure of contingent assets and liabilities; and the actuarial present value of accumulated plan benefits at the date of the financial statements, and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Prior to the Plan's termination, Investments were reported at fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determined the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits payments to participants were recorded upon distribution.

Administrative Expenses

The Plan's expenses were paid either by the Plan or the Company, as provided by the plan document. Expenses that were paid directly by the Company were excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that were paid by the Plan were recorded as deductions in the statement of changes in net assets available for benefits. In addition, certain investment related expenses were included in net appreciation (depreciation) in fair value of investments in the statement of changes in net assets available for benefits.

Subsequent Events

Subsequent events were evaluated through July 30, 2025, the date the financial statements were available to be issued. There were no subsequent events that require recognition or disclosure in these financial statements.

3. Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments, including lump-sum distributions, that are attributable under the Plan's provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. Benefits under the Plan are based on employees' compensation during each year of credited service. The accumulated plan benefits for active employees will equal the accumulation, with interest, of the annual benefit accruals as of the benefit information date. Benefits payable under all circumstances, such as retirement, death, disability, and termination of employment, are included, to the extent they are attributable to employee service rendered to the valuation date. Benefits to be provided via annuity contracts excluded from plan assets are excluded from accumulated plan benefits.

The actuarial present value of accumulated plan benefits is determined by the Plan's independent actuary and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

On May 10, 2023, the Retirement Plan Committee of the Plan Sponsor approved a plan to terminate the plan effective July 31, 2023. The Plan was amended for termination on January 6, 2024, with an effective termination date of July 31, 2023. As a result of the amendment, the Plan changed its measurement date to December 31 from January 1 and adopted the liquidation basis of accounting. See note 8 to the financial statements for additional information.

The significant actuarial assumptions used in the actuarial valuations as of December 31, 2023 (liquidation basis) and January 1, 2023 (going concern basis) of the Plan are as follows:

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value as of December 31, 2023

Investments measured at net asset value: Consisting of pooled separate accounts, valued at the net asset value ("NAV") of unit prices of actual purchase and sale transactions occurring as of or close to the financial statement date. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the pooled separate accounts, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

5. Transfers Into or Out of the Plan

Plan liabilities were settled in 2024 through a combination of lump sum payments, an annuity purchase and the transfer of remaining obligations to the Pension Benefit Guaranty Corporation (PBGC) through a standard plan termination process.

6. Information Certified by Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA for 2024 (liquidation basis). Accordingly, Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, the Trustee of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of September 26, 2024 (liquidation basis) and December 31, 2023 (going concern basis) and the investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the period ended September 26, 2024 (liquidation basis).

7. Related-Party and Party In Interest Transactions

The Plan’s investments are administered under a contract with Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, the Trustee of the Plan. Contributions are held and managed by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, who invests cash received, interest and dividend income and makes distributions to participants. These transactions are party in interest transactions under ERISA.

As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to various service providers. Additionally, certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. These transactions are party in interest transactions under ERISA.

8. Plan Termination

On May 10, 2023, the Retirement Plan Committee of the Plan Sponsor approved a plan to terminate the Plan by July 31, 2023. The Plan was amended for termination on January 6, 2024 with an effective termination date of July 31, 2023. Upon termination of the Plan, participants became 100% vested in their benefits and plan assets will be allocated in a manner consistent with Section 4044 of ERISA. On August 25, 2023, the Plan filed Form 5310, Application for Determination for Terminating Plan, with the IRS, and approval was received on March 11, 2025. Additionally, the Plan filed Form 500 with Pension Benefit Guaranty Corporation (PBGC) on January 26, 2024, stating their intention to liquidate the Plan subject to a 60-day review period for the PBGC to provide feedback. On March 26, 2024, the review period lapsed and the PBGC had not provided any feedback, thus Plan assets were permitted to be distributed at any time within a 180-day period ending September 22, 2024. Accordingly, accumulated participant benefits were distributed as lump sum payments and annuity purchases as arranged by the Plan Sponsor with an insurance carrier in April 2024 and July 2024 for a total amount of \$24.1 million. The remaining balance of excess plan assets was distributed between the plan sponsor and plan participants in July 2024 and September 2024.

9. Tax Status

The Plan adopted a volume submitter plan offered by the Principal Life Insurance Company. The volume submitter plan received an IRS Opinion Letter dated March 30, 2018, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since the date of the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
