### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Phoenix Air Group, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Phoenix Air Group, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note H to the financial statements, is complete and accurate.

#### NOTE A. DESCRIPTION OF PLAN

The following description of the Phoenix Air Group, Inc. 401(k) Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### General:

The Plan is a defined contribution plan covering all employees of Phoenix Air Group, Inc. (hereafter "the Employer") who are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All required Plan restatements have been completed, and Secure Act 2.0 plan amendment took effect January 1, 2024.

##### Contributions:

Each year, participants may elect to contribute a minimum of 1 percent of pretax annual compensation as defined in the Plan. Participants direct the investment of their account into various investment options offered by the Plan. The Plan currently offers several mutual funds and one common trust fund as investment options for participants. Employer provides a discretionary matching contribution for employees who are employed on the last day of the year. The discretionary match is 50% of the first 6% of participant deferrals. Forfeitures are used to lower the Employer's cost of the match. Additional profit sharing amounts may be contributed at the option of the Employer's board of directors. Contributions are subject to certain limitations. There were no additional profit sharing contributions in 2024 or 2023.

##### Participant Accounts:

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Vesting:

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is fully vested after six years of credited service.

#### NOTE A. DESCRIPTION OF PLAN (Continued)

##### Payment of Benefits:

On termination of service with a vested account balance less than \$5,000, the participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Those terminated participants with a vested account balance of more than \$5,000 may elect to receive a lump sum equal to the vested value of their account, or by payment in monthly, quarterly or annual installments over a fixed reasonable period of time, not exceeding the life expectancy of the participant, or the joint life and last survivor expectancy of the participant and their beneficiary.

##### Forfeited Accounts:

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$28,752 and \$15,582, respectively. These accounts will be used to reduce future employer matching contributions. In 2024, employer contributions receivable were reduced by \$0 from forfeited nonvested accounts.

#### NOTE B. SUMMARY OF ACCOUNTING POLICIES

##### Estimates:

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

##### Basis of Accounting:

The Plan's financial statements are prepared on the accrual basis of accounting.

##### Investment Valuation and Income Recognition:

Plan's investments are stated at fair value. Quoted market prices are used to value investments. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year end.

##### Investment Valuation and Income Recognition:

Investments in common/collective trusts are stated at estimated fair values, which have been determined based on the unit values of the funds. The bank sponsoring such funds determines unit values. Investments in common/collective trusts are limited primarily to bonds and notes, which are payable upon demand, and common stocks. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

##### Payment of Benefits:

Benefits are recorded when paid.

#### NOTE C. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Funds:* Valued using pricing models maximizing the use of observable inputs for similar securities. Galliard Stable Return Fund is the only Common Collective Fund held by the Plan. The net asset value (NAV) is available to current and prospective investors, and NAV is the basis for current transactions.

#### NOTE E. FEDERAL INCOME TAX STATUS

Phoenix Air 401(k) Plan is an adoption of a Principal Life Insurance Company 401(k) Prototype Plan. The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

#### NOTE F. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

Should the plan terminate at some future time, its net assets generally will not be available on a pro rata basis to provide participants' benefits. Whether a particular participant's accumulated plan benefits will be paid depends on both the priority of those benefits and the level of benefits guaranteed by the Pension Benefit Guaranty Corporation (PBGC) at that time. Some benefits may be fully or partially provided for by the then existing assets and the PBGC guaranty while other benefits may not be provided for at all.

#### NOTE G. RELATED-PARTY TRANSACTIONS

Certain plan investments are shares of mutual funds and interests in common collective funds managed by Principal Life Insurance Company. Principal Life Insurance Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$37,324 for the year ended December 31, 2024. IRA Group provides investment advisory services to the Administrative and Investment of the Phoenix Air Group 401(k) Plan. Fees paid by the Plan for the investment advisory services amounted to \$19,994 for the year ended December 31, 2024. Phoenix Air Group, Inc. absorbs significant costs of plan administration. For the 2024 plan year, these expenses totaled \$17,870.

#### NOTE H. INFORMATION CERTIFIED BY THE TRUSTEE (UNAUDITED)

The Plan's investments were held by the Trustee, Principal Trust Company. Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments held as of December 31, 2024 and 2023 and covered by the certification, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, a member of the Principal Financial Group.

The fair value of investments at December 31, 2024 as reported by the Trustee are indicated on the Schedule of Assets (Held at End of Year). This information was certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, a member of the Principal Financial Group.

The investment income reported in the statement of changes in net assets available for benefits for the twelve months ended December 31, 2024 was certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, a member of the Principal Financial Group.

#### NOTE I. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### NOTE J. SUBSEQUENT EVENTS

Management has evaluated events through July 24, 2025, the date the financial statements were made available to be issued.
