Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Maher Terminals LLC Profit Sharing and 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Maher Terminals LLC Profit Sharing and 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS

1. Description of plan

The following description of the Maher Terminals LLC Profit Sharing and 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time salaried employees of Maher Terminals LLC and its affiliates (collectively, the "Company") who are not part of a collective bargaining agreement. The assets of the Plan are maintained in a trust by John Hancock Trust Company LLC (the "Trustee"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Eligibility

Full-time salaried employees may enter the Plan on the first day of the month following their date of hire. Any employee making a deferral contribution to the Plan is eligible for employer matching contributions the first day of the calendar month following their first day of employment. All full-time salaried employees are eligible for discretionary profit sharing contributions provided they were hired prior to July 1 of that year and still employed on the last day of the Plan year, except for terminations occurring due to disability, death or retirement. Additionally, all full time salaried employees hired on or after January 1, 2009 who are not participants of the Company's Pension Plan are eligible for a non elective contribution provided they were hired prior to July 1 of that year and still employed on the last day of the Plan year.

Contributions

Participants may elect to make contributions between 1% and 80% of their pre-tax and/or post-tax annual compensation, up to the legal maximum allowable as defined by the IRS. Under the current Plan, participants are automatically enrolled at a deferral rate of 6% of compensation. This deferral rate is automatically increased by 1% each year up to a maximum of 15%. In 2024, participants could contribute up to a maximum of \$23,000 with an additional \$7,500 catch-up contribution for employees 50 years old and over. For the year ended December 31, 2024, the Company matched 25% of the first \$23,000 of the participant's elective deferral contributions to the Plan. The Company also contributes to the Plan a percentage of its current profits and makes a non elective contribution, at the discretion of the Company's Board of Directors. The Company declared a profit sharing contribution of 10% of eligible compensation for each eligible participant and declared a non elective contribution of 5% of eligible compensation for each eligible participant for the Plan year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution, the employer's matching contribution (if eligible), profit sharing and non elective contributions (if eligible), investment earnings (or charged with losses), distributions and forfeitures. Participants direct participant and employer contributions to be invested in any of the investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully vested in their contributions and actual earnings thereon, immediately. Any employee making deferral contributions is eligible for employer matching contributions, and becomes 100% vested in the match upon completing six months of employment. The Company's discretionary profit sharing contributions and non elective contributions are subject to 100% forfeiture until the participant completes three years of service, at which time the participant is fully vested in such contributions and earnings thereon.

1. Description of plan (continued)

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant or a designated beneficiary may elect to receive the vested portion of their account balance in a lump-sum payment or substantially equal periodic installments over a period equal to the life expectancy of the participant or their designated beneficiary or roll over the balance into another qualified plan. Participants may withdraw their vested account balance upon demonstrating hardship or attaining age 59.5.

Forfeited Accounts

Forfeited non-vested amounts at December 31, 2024 and 2023 were \$2 and \$19,955, respectively. These amounts include \$12,377 and \$20,142 forfeited during the Plan years ended December 31, 2024 and 2023, respectively. Such forfeitures may be allocated among the accounts of eligible participants, may be used to pay administrative expenses, or may be used to reduce the amount of contributions which would otherwise be made by the Company. The Company allocated forfeitures in the amount of \$9,530 among the accounts of eligible participants during the year ended December 31, 2024.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 or up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as transfers between the investment fund and the participant loan fund. Loan terms range from one to five years. The loans bear interest at a rate commensurate with prime interest rates prevailing at the time of the loan. Only one loan is permissible at a time per participant. Outstanding loans at December 31, 2024 bear interest at a rate within the range of 3.25% - 8.50% per annum. Principal and interest are paid ratably through biweekly payroll deductions.

2. Summary of significant accounting policies

Basis of Accounting

The accompanying financial statements have been prepared in compliance with the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA and the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Investment Valuation

Investments held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit responsive investment contracts (FBRIC) because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's investments in mutual funds and common collective trusts are reported at fair value. See Note 3 – Fair value measurements. The Plan's investment in the group annuity contract, a FBRIC, is reported at contract value. See Note 5 – Group annuity account investment.

2. Summary of significant accounting policies (continued)

Use of Estimates

The preparation of the Plan financial statements in accordance with GAAP and the DOL's Rules and Regulations for Reporting and Disclosure under ERISA requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, at the date of the financial statements and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Income

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) of investments consists of unrealized gains and losses on investments and realized gains and losses during the year. Certain investment related expenses have been reflected in investment income and are not readily determinable.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Under the administrative service agreement with the Trustee, the base administration fee can be satisfied through the revenue sharing agreement. Investment revenue received by the Trustee in excess of the required revenue shall be deposited into the Plan's suspense account. For the year ended December 31, 2024, the Plan received \$79,511 related to the revenue sharing agreement. If the investment revenue received is less than the required revenue for the year, the deficient amount will be paid by utilizing funds in the Plan's suspense and/or forfeitures account, or be paid by the Company.

Notes Receivable from Participants

Notes receivable from participants are valued at their unpaid principal balance plus any accrued but unpaid interest. Interest income from notes receivable is recorded when earned. If a participant ceases to make loan repayments, the loan will be considered in default, and a taxable distribution would be recorded.

3. Fair value measurements

Fair Value

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (i.e., the "exit price") in an orderly transaction between market participants at the measurement date.

In determining fair value, the Plan uses various valuation techniques. A fair value hierarchy for inputs is used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the most observable inputs are to be used when available. Valuation techniques that are consistent with the market or income approach are used to measure fair value. The fair value hierarchy is categorized into three levels based on the inputs as follows:

Level 1 - Valuations based on unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 - Valuations based on inputs, other than quoted prices included in Level 1, that are observable either directly or indirectly.

Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

3. Fair value measurements (continued)

Fair value is a market-based measure, based on assumptions of prices and inputs considered from the perspective of a market participant that are current as of the measurement date, rather than an entity-specific measure. Therefore, even when market assumptions are not readily available, the Plan's own assumptions are set to reflect those that market participants would use in pricing the asset or liability at the measurement date.

The availability of valuation techniques and observable inputs can vary from investment to investment and are affected by a wide variety of factors, including the type of investment, whether the investment is new and not yet established in the marketplace, the liquidity of markets, and other characteristics particular to the transaction. To the extent that valuation is based on models or inputs that are less observable or unobservable in the market, the determination of fair value requires more judgment. Because of the inherent uncertainty of valuation, those estimated values may be materially higher or lower than the values that would have been used had a ready market for the investments existed. Accordingly, the degree of judgment exercised by the Plan in determining fair value is greatest for investments categorized in Level 3. In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, the level in the fair value hierarchy which the fair value measurement falls in its entirety is determined based on the lowest level input that is significant to the fair value measurement.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund.

Common collective trusts: The common collective trusts' funds fair values are determined by the respective fund managers using NAV as a practical expedient. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. There were no unfunded commitments, redemption restrictions or redemption frequency limitations at December 31, 2024 and 2023. Common collective trust funds can be redeemed daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Fair Value – Valuation Processes

The Company has a designated investment sub-committee (the "Committee") which reviews the values of the Plan's investments and the performance of the underlying investment options throughout the year. The Committee meets on a quarterly basis or more frequently as needed. The Committee utilizes the services of a third party consulting firm as the Plan's investment advisor.

The following table sets forth by level, within the fair value hierarchy, the Plan's investments measured at fair value as of December 31, 2024 and 2023:

4. Income tax status

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor or the Internal Revenue Service ("IRS"). The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The IRS has determined and informed the Company by letter dated June 30, 2020 that the Plan is designed in conformity with applicable sections of the IRS. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRS.

5. Group annuity account investment

The Plan participates in a benefit-responsive group annuity contract made available by New York Life Investment Management ("New York Life"). The investment is included in the Statements of Net Assets Available for Benefits at contract value. Contract value represents contributions made under the investment, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The average yield and crediting interest rate was approximately 3% per annum for the year ended December 31, 2024. Interest is accrued daily and credited monthly interest rates are guaranteed by New York Life Insurance Company ("NYLIC") to be no less than 1%, before any deduction for expenses.

5. Group annuity account investment (continued)

The following events would limit the Plan's ability to transact at contract value with New York Life. The Plan administrator believes the occurrence of such events, that would also limit the Plan's ability to transact at contract value with Plan participants, is not probable.

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer.

6. Information Certified by the Trustee

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Trustee has certified the completeness and accuracy of all investments and related investment activity and notes receivable from participants and the related interest income in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024 and the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.

As a result of the aforementioned election, no auditing procedures were performed by the independent auditor with respect to information certified as complete and accurate, except for comparing such information with the related information included in the financial statements. Based on information provided by the Trustee, there are no fixed income obligations, leases, or debt instruments in default or deemed uncollectible, as defined by ERISA for the years ended December 31, 2024 and 2023.

7. Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as described in the Plan document.

8. Concentration of credit risk and uncertainties

The Plan offers a number of investment options, including a group annuity contract, collective trust funds, and a variety of mutual funds. Investment securities, in general, are exposed to various risks, such as interest rate, foreign exchange, credit, and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits and participant account balances.

The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across participant-directed fund elections. Additionally, the investments within each participant-directed account are further diversified into varied instruments.

In the normal course of business, all of the Plan's assets are transacted with and held by the Trustee.

9. Party-in-interest

Certain assets of the Plan invested with the Trustee as of December 31, 2024 and 2023 are considered party-in-interest investments. The Trustee is a party-in-interest as a provider of administrative, investment management and accounting services to the funds. These transactions are exempt from the prohibited transaction rules. Transactions relating to notes receivable from participants also qualify as exempt party-in-interest transactions.

10. Subsequent events

Management has evaluated subsequent events through July 31, 2025, the date the financial statements were available to be issued.
