Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

Note 1 - Description of Plan

The following description of Barr Brands International, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document or the summary plan description for a more complete description of the Plan's provisions, which are available from the plan administrator.

General

The Plan is a defined contribution 401(k) retirement plan available to all eligible employees of Barr Brands International, Inc., W.M. Barr & Company, and Microban International, Ltd. (collectively, the "Company") who are age eighteen (18) or older and have completed ninety (90) days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Participants may contribute any percentage of their annual eligible compensation up to seventy-five percent (75%) subject to Internal Revenue Service (IRS) limitations. Participants who have attained age fifty (50) before the end of the plan year are also eligible to make catch-up contributions. Participants are automatically enrolled when they first become eligible at three percent (3%) of their pay. The Plan also provides for a contribution accelerator which automatically increases participant contributions one percent (1%) each year on April 1 until the participant's contribution rate reaches ten percent (10%).

Each year the Company will make a qualified non-elective contribution (QNEC) on behalf of each participant in an amount equal to three percent (3%) of each participant's eligible compensation for the plan year if the participant was an active participant at any time during the plan year in this Plan and in the Barr Brands International, Inc. Amended and Restated Employee Stock Ownership Plan (ESOP). Such qualified non-elective contributions are made each year to the ESOP.

Participant investment account options

The Plan allows participants to direct their contributions and account balances among different investment options offered through Principal Trust Company.

Participant accounts

Each participant's account is credited with the participant's deferral contributions and a proportionate interest in the investment earnings or losses of the funds in which the contributions are invested and an allocation of administrative expenses. Allocations are based upon participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Note 1 - Description of Plan (continued)

Vesting

Participants are immediately 100% vested in all contributions plus earnings thereon.

Payment of benefits

Upon termination of service due to death, disability, retirement or separation from service, or upon attainment of age sixty-five (65), participants may receive account distributions in the form of a lump sum payment as defined in the plan document. Withdrawals by a participant while employed are limited to those requested due to events of financial hardship as defined in the plan document or upon the attainment of age 59½. Participants may withdraw all or any part of their account resulting from rollover contributions. These withdrawals are limited to two during any one year period.

Note 2 - Summary of significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions which affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Certain expenses of the Plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Investment related expenses are included in net appreciation in fair value of investments.

Note 3 - Information prepared and certified by the trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Trust Company, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and the supplemental schedule is complete and accurate:

- Investments at fair value
- Net appreciation in fair value of investments
- Dividends
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and the supplemental schedule.

Note 4 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described below.

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Note 4 - Fair value measurements (continued)

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust fund: Valued at the NAV of units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that security liquidations will be carried out in an orderly business manner.

Note 5 - Related party transactions and party-in-interest transactions

Plan investments represent interests in certain mutual funds and a common/collective trust fund offered by Principal Trust Company. Delaware Charter Guarantee & Trust Co., operating as Principal Trust Company, is the trustee as defined by the Plan. These investments and related investment transactions qualify as party-in-interest transactions. Fees paid by the Plan to Principal totaled \$76,306 and \$60,394 for the years ended December 31, 2024 and 2023, respectively. The Plan Sponsor pays directly any other fees related to the Plan's operations.

Note 6 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA.

Note 7 - Tax status

The IRS has determined that the Non-Standardized Pre-Approved Profit Sharing Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC) and informed Principal of such in a letter dated June 30, 2020. Although the Plan has been amended since receiving the opinion letter, plan management believes that the Plan and related trust is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

Note 8 - Risks, uncertainties and concentrations

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Approximately 15% and 17% of the Plan's total investments were invested in the Vanguard Target Retirement 2030 Investment Fund as of December 31, 2024 and 2023, respectively.

Note 9 - Subsequent events

Plan management has evaluated subsequent events through July 11, 2025, which is the date that the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.
