1. Summary of Significant Accounting Policies

A summary of the major accounting policies followed by the Pfeiffer & Son, Ltd. ("Company") Employees' Profit Sharing Plan and Trust ("Plan") in the preparation of the accompanying financial statements is presented below:

The Plan's investments in mutual funds are reported at fair value as determined by Fidelity Management Trust Company, based on quoted market values of underlying assets. Purchases and sales of securities are recorded on a trade-date basis.

The financial statements of the Plan are prepared using the modified cash basis method of accounting. Additions are recognized when cash is received and deductions are recognized when cash is paid.

The Profit Sharing Plan is qualified under Section 401(a) of the Internal Revenue Code (the "IRC") and is exempt from Federal Income Taxes under 501(a) of the IRC.

The Company adopted a Volume Submitter Profit Sharing Plan (VSPS Plan) with CODA sponsored by a Third Party Trust Company. The Internal Revenue Service has determined and informed the VSPS Plan Sponsor by a letter dated June 30, 2020 that the VSPS Plan and related trust are designed in accordance with applicable sections of the IRC. The VSPS Plan's opinion letter is being relied on by the Plan. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Although the financials are presented on a modified cash basis instead of GAAP basis, the plan administrator has chosen to analyze the tax positions taken by the plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. For federal income tax purposes the tax returns essentially remain open for possible examination for a period of three years after the date on which those returns are filed.

The presentation of financial statements in conformity with modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

2. Plan Participants' Equity

The net assets available for Plan benefits are composed of the trust fund established by the Plan's Trustee for the benefit of Pfeiffer & Son, Ltd. participants.

3. Investments

The Plan's investments are held by a retirement plan service company and are composed of money market, growth and income funds.

4. Description of Plan

The following provides only general information of the Pfeiffer & Son, Ltd. Employee's Profit Sharing Plan and Trust. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of the company who have one year of service, 1,000 hours of service during the plan year, and are employed as of the last day of the plan year. It is subject to the provisions of the Employee Retirement Security Act of 1974 (ERISA).

The trustee of the Plan is the plan administrator, who is the managing member of the plan sponsor/Company. Among other duties, the trustee is responsible for overseeing the Plan and evaluating plan management and service providers. Fidelity Management Trust Company serves as the custodian of the Plan's assets. The custodian's duties include receiving contributions, holding and investing the fund assets in accordance with the directions of the participants, and making distributions as directed by the plan administrator or participant. Fidelity Investments Institutional Operations Company, Inc. serves as the third party administrator, responsible for plan administration, recordkeeping, and transaction processing, including maintaining complete and accurate account records for all plan participants, allocating contributions and earnings, posting distributions and forfeiture information to participant accounts, and preparing participant statements and reports.

Administrative Charges

All administrative expenses of the Plan may be paid by the Plan or the Company and may be reduced by forfeitures. Investment management fees are assessed by the custodian and are offset against investment income.

Employer Contributions

Each year, the company may make an annual discretionary profit sharing contribution determined at Plan year end by the General Partners. The Plan allows for a total employee and employer contribution of up to sixty percent (60%) of qualified wages, with combined employer and employee contributions not to exceed \$69,000 for 2024 and \$66,000 for 2023. An additional contribution of \$7,500 for 2024 and 2023 is permitted for employees age 50 or older by year end. During the years ended December 31, 2024 and 2023, the Company made contributions consisting of a twelve percent (12%) profit sharing plus a three percent (3%) safe harbor non-elective contribution of the qualified previous year wages not exceeding \$51,750 and \$49,500 per participant per year, respectively.

Employee Contributions

Participants may elect to contribute up to 60% of their annual wages as either traditional, pre-tax contributions and/or Roth contributions. These combined contributions are subject to annual IRS dollar limitations as set forth by Section 415 of the Internal Revenue Code and are adjusted on an annual basis for cost-of-living increases. For 2024 and 2023, the maximum contribution that can be made is \$23,000 and \$22,500 per year, respectively, plus an additional catch-up contribution of \$7,500 for employees who are at least age 50 by the end of the year. Only an employee's salary deferral contributions can be allocated to the Roth account.

Participant Accounts

Each participant's account is credited with his or her respective employee and employer contribution and an allocation of (a) plan earnings, and (b) forfeitures of terminated participant's non vested accounts as determined by the plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct their investments into any combination of available options within the Plan. Loans are not permitted under the Plan.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant will be entitled to receive 100% of their account balance in either a lump sum amount or in annual installments over a specified period of time.

On termination of service for reasons other than death, disability or retirement, a participant will be entitled to receive only the vested percentage of their account balance upon achievement of reaching the Plan's normal retirement age or early retirement age, if applicable, with the remainder of their account being forfeited.

Payment of Benefits (Continued)

Non-vested account balances are moved from the employee's account into the forfeiture account after a five year break in service.

A participant may at any time file for a hardship distribution based on account of an immediate and heavy financial need. Hardship withdrawals will be permitted only from a participant's deferral contribution account.

In-Service distributions may be made to a Participant who has either not separated from service provided the participant has attained the age of 60, or who attained the age of 55 and has 15 years of employment with the company and has separated from service by choosing early retirement, and can only be made from accounts that are fully vested. Participants become fully vested upon reaching the normal or qualified early retirement age.

Vesting

Participants are always 100% vested in amounts contributed from their salary deferrals. The vesting percentage in the participant's account generated from employer discretionary profit sharing and safe harbor non-elective contributions are determined under the following schedule and is based on vesting years of service.

Forfeitures

The non-vested portion of a terminated participant's account balance remains in the Plan. Forfeitures are available to pay future employer contributions, plan related administrative expenses, and/or reallocated among the accounts of eligible participants. In 2024, \$-0- forfeitures were utilized for employer contributions, \$151 forfeitures were utilized for recordkeeping fees, \$15,963 of forfeitures were utilized for auditing fees, and \$41,000 were utilized for investment advisory fees. In 2023, \$-0- forfeitures were utilized for employer contributions, \$151 forfeitures were utilized for recordkeeping fees, \$-0- of forfeitures were utilized for auditing fees, and \$41,000 were utilized for investment advisory fees. Forfeited non-vested accounts totaled \$1,913 and \$39,548 at December 31, 2024 and 2023.

5. Continuation of the Plan

The Company intends to continue the Plan indefinitely, but has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

6. Participant Directed Investments

Investments held by the Plan represent participant-directed accounts. That is, individual participants decide how funds held in trust for them are allocated among various investments. Participants should see the Fidelity Investments website for the investment choices offered.

7. Party-in-Interest Transactions

Plan investments are money market accounts and mutual funds managed by Fidelity Management Trust Company, an entity that is a party-in-interest with respect to the Plan. These transactions are exempt and covered by the Prohibited Transaction Exemption provisions of ERISA and the Code.

The Company provides certain accounting, administrative, and investment management services to the Plan for which no fees are charged.

8. Administrative Expenses

Administrative Expenses consist of Audit Fees, Investor Fees, and Custodian Fees. Custodian Fees include a rebate credit that is received from the mutual funds and applied to the expenses. Administrative fees as of December 31, 2024 and 2023 consist of the following:

9. Risks and Uncertainties

The Plan may invest in various types of investment securities which are not insured by the federal government. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for plan benefits.

10. Certification Information

As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, information prepared and certified by a bank or insurance company, which is regulated, supervised and subject to periodic examination by a state or federal agency, need not be audited.

The plan administrator has obtained certifications from the Fidelity Management Trust Company (custodian) that all information provided by them is complete and accurate. Information included in the accompanying financial statements and notes to financial statements as to investments, net appreciation (depreciation) in fair value of investments, interest income and all information in the Supplemental Schedule H, line 4i, Schedule of Assets (held at year end), is presented solely upon reliance on those certifications. The independent auditors did not perform auditing procedures with respect to this information except for comparing such information to the related information in the financial statements, notes to financial statements, and supplemental schedule.

11. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Fair Value Measurements Using:
