INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of
Brookside Equipment Sales, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Brookside Equipment Sales, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits in liquidation as of December 17, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits in liquidation for the period from January 1, 2024 through December 17, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 17, 2024 and December 31, 2023, and for the period from January 1, 2024 through December 17, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Terminating Plan and Liquidation Basis of Accounting

As further discussed in Note 1 to the financial statements, the Plan administrator authorized the termination of the Plan effective September 12, 2023 and liquidated all of the Plan's assets by December 17, 2024. As a result, in accordance with accounting principles generally accepted in the United States of America, the Plan is presenting the 2024 and 2023 financial statements on the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of Brookside Equipment Sales, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of Brookside Equipment Sales, Inc. (the “Company”). Eligible employees may become participants on the first day of the plan year or first day of the seventh month of the plan year coinciding with or next following the completion of six consecutive months with at least one hour of service. Effective September 12, 2023, no new participants were allowed in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Plan Termination and Liquidation

On September 12, 2023, the Plan administrator authorized the termination of the Plan pursuant to the purchase of substantially all the assets of the Company by a third party. Participants of the Plan could submit their withdrawal or rollover elections beginning September 12, 2023. Participant and Company contributions to the Plan ended on October 27, 2023. All of the Plan’s assets were distributed to participants by December 17, 2024.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and allocations of (a) the Company’s contributions and (b) Plan earnings and charged with any applicable administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Prior to Plan termination effective September 12, 2023, participants were at all times fully vested in their contributions, rollover contributions, and the appreciation or depreciation thereon. Vesting in the Company’s contributions plus earnings thereon was based on years of continuous service. A participant had to complete 1,000 hours of service during a plan year to qualify for a year of service and count toward vesting. A participant vested 100% in the Company’s safe harbor nonelective contributions after two years of service. In the Company’s discretionary nonelective employer contributions, a participant vested 20% per year after two years of service becoming 100% vested after six years of service. A participant would be immediately vested upon death, retirement, or total and permanent disability.

Upon Plan termination, all participants became fully vested in their accounts.

Forfeited Accounts

Forfeitures of nonvested Company contributions shall be used to reduce Company contributions or to pay Plan expenses. The forfeitures balance at December 31, 2023 was \$3,877. There was no forfeitures balance at December 17, 2024. Forfeitures of \$3,301 were used to pay Plan expenses during 2024.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

In accordance with accounting principles generally accepted in the United States of America, the Plan is presenting the 2024 and 2023 financial statements on the liquidation basis due to the Plan termination and liquidation discussed in Note 1.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan administrative and recordkeeping expenses are reflected on the accompanying statement of changes in net assets available for benefits in liquidation for the period from January 1, 2024 through December 17, 2024. Fees related to withdrawals and contract administration are charged directly to the participant's account and are included in administrative expenses. Other investment-related expenses are included in net appreciation in fair value of investments.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investments

Investments are reported at fair value, except the fully benefit-responsive investment contract (Note 6), which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits in liquidation of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

NOTE 3 - FAIR VALUE MEASUREMENTS

Various inputs are used in determining the fair value of the Plan's investments. Valuation techniques used to measure fair value must maximize the use of observable inputs and minimize the use of unobservable inputs. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy, including the types of Plan investments that fall under each category and the valuation methodologies used to measure fair value, are described below:

- Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.
- Level 2* - Inputs to the valuation methodology are other than quoted market prices in active markets that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices that are in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3* - Inputs to the valuation methodology are unobservable inputs (i.e., projections, estimates, interpretations, etc.) that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Investments measured using the net asset value ("NAV") practical expedient are described below.

Pooled Separate Accounts: Valued at NAV by Sentry Life Insurance Company ("Sentry") based on the units held reflecting the closing price reported on the applicable active market on which the underlying investments are traded. Underlying investments are primarily composed of stocks, bonds, and mutual funds that are priced in an active market. The pooled separate accounts held by the Plan provide for daily redemptions by the Plan at reported NAV with no advance notice requirement. The Plan has no unfunded commitments and no contractual obligations to further invest in the pooled separate accounts.

NOTE 3 - FAIR VALUE MEASUREMENTS (CONTINUED)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The inputs and methodologies used for valuing securities are not an indication of the risk associated with investing in those securities. There have been no changes in the methodologies used at December 17, 2024 or December 31, 2023.

As described in Note 1, the Plan was terminated and all assets were distributed to participants as of December 17, 2024. The following table sets forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2023:

*As discussed above, investments that are measured at fair value using the NAV per share (or its equivalent) practical expedient, which is a reasonable estimate of fair value, have not been categorized in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the investments line item presented in the statements of net assets available for benefits in liquidation.

NOTE 4 - INFORMATION CERTIFIED

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Sentry, an insurance company, has certified to the completeness and accuracy of all investments reflected in the accompanying statements of net assets available for benefits in liquidation as of December 17, 2024 and December 31, 2023, and the related investment activity reflected in the statement of changes in net assets available for benefits in liquidation for the period from January 1, 2024 through December 17, 2024.

NOTE 5 - TAX STATUS

The Plan has adopted a non-standardized prototype plan, which obtained its latest opinion letter dated June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the prototype plan document satisfied the applicable provisions of the Internal Revenue Code ("IRC"). The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, contributions to the Plan and earnings from its assets are not currently taxable to the Plan or its participants.

NOTE 5 - TAX STATUS (CONTINUED)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan to determine if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 17, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - INVESTMENT AT CONTRACT VALUE

Prior to Plan liquidation at December 17, 2024, the Plan maintained a fully benefit-responsive investment contract (the Guaranteed Interest Account) with Sentry, a guaranteed investment account, contained in the general account of Sentry. As described in Note 2, the Guaranteed Interest Account is reported at contract value. Sentry, as the contract issuer, is contractually obligated to repay the principal and interest at a specified crediting interest rate. The crediting rate is based on a formula established by the contract issuer and is reviewed annually for resetting. There is no guaranteed minimum or maximum interest rate. In certain circumstances specified in the contract, a market value adjustment may be assessed if the contract is cancelled. There was no significant market value adjustment in 2024. The principal and interest in the contract account are backed by the assets held in the general account of Sentry.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan provides for various investments. In general, such investments are exposed to various risks such as significant world events, interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits in liquidation.

NOTE 8 - PARTY-IN-INTEREST TRANSACTIONS

Prior to Plan liquidation at December 17, 2024, certain Plan investments were in pooled separate accounts and a contract account managed by entities affiliated with Sentry. Sentry qualifies as a party in interest under ERISA guidelines. These transactions are covered by an exemption from the prohibited transaction provisions.

NOTE 9 - FIDELITY BOND

The Plan was not covered by a fidelity bond beginning January 2, 2024 through December 17, 2024, and was therefore not in compliance with ERISA requirements.

NOTE 10 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through July 16, 2025, the date the financial statements were available to be issued.
