### Report on the Audit of the Financial Statements

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Redwood Day School Defined Contribution Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Redwood Day School Defined Contribution Retirement Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

#### **Opinion**

## Notes to Financial Statements

---

### **Note 1 – The Plan and Its Significant Accounting Policies**

**General** – The following description of Redwood Day School Defined Contribution Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan that was established in 1988 by Redwood Day School (the School) to provide benefits to eligible employees, as defined in the Plan document. The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code (the Code) and the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Administration** – Under the terms of the Plan, a group of designated officers of the School act as the trustee. The School has appointed the 403(b) Investment Committee to manage the operation and administration of the Plan. The School has contracted with Teachers Insurance and Annuity Association of America/College Retirement Equities Fund (TIAA and CREF) to act as the custodian, and an affiliate of TIAA and CREF to act as a third-party administrator to process and maintain the records of participant data. Direct expenses incurred for administering the Plan are paid by the School, to the extent they are not paid by the Plan.

**Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Basis of accounting** – The financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the U.S.

**Investment valuation and income recognition** – The investments are reported at fair value and contract value. The Plan's custodian, TIAA and CREF, certifies the contract value of the fully benefit-responsive investment contracts and the fair market value of all other investments, including nonfully benefit-responsive investment contracts held by the Plan. If available, quoted market prices are used to value investments.

Fair value is the price that would be received upon the sale of an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 2 for discussion of fair value measurements.

Contract value is the relevant measurement for assets invested in fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Certain TIAA traditional annuity contract types, including the Supplemental Retirement Annuities and the Group Supplemental Retirement Annuities, are considered fully benefit-responsive. Other TIAA traditional annuity contract types, including the Retirement Annuities (RA), Group Retirement Annuities and Retirement Choice, are considered nonfully benefit-responsive and, therefore, are reported at fair value.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought or sold as well as held during the year.

**Income taxes** – The Plan has been designed to qualify under Section 403(b) of the Code. The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service (IRS). The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for participants under Section 403(b).

In accordance with guidance on accounting for uncertainty in income taxes (ASC 740-10), management evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Risks and uncertainties** – The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rates, market fluctuations, and credit risks. Due to the risk associated with certain investment securities, it is at least reasonably possible that changes in market values, interest rates, or other factors in the near term would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

**Subsequent events** – The School has evaluated subsequent events through August 1, 2025, which is the date the financial statements were available to be issued.

### Note 2 – Fair Value Measurements

The fair value measurements standard establishes a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the standard are described below:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3 –** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies* – The CREF funds are considered registered investment companies and are valued at the daily closing price as reported by the fund. CREF funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The CREF funds held by the Plan are deemed to be actively traded.

*Nonfully benefit-responsive investment contract* – The Plan has investments in nonfully benefit-responsive TIAA Traditional Annuity RA contracts, which are presented at contract value, which approximates fair value, on the statement of net assets available for benefits. Transactions involving the purchases and sales of individual RA contracts are not observable in a public marketplace, but contract value is a good approximation of fair value as supported by the fact that new contributions represent current transactions between willing buyers and sellers as prescribed in the relevant GAAP guidance. As these transactions continue to occur with continued participant contributions at current stated contract values, the market-observable presumption is that the contract value of current funding represents a good approximation of fair value based on the willingness of the participant to continue to contribute. For each contribution, TIAA continues to record a contractual liability for the current contribution and does not consider such liability to have any embedded gain or loss. Further, TIAA has concluded that contract value approximates fair value using a quantitative model based on assumptions of future interest rates and related discounted cash flows. The contract value equals the accumulated cash contributions and interest credited to the Plan's contract, less withdrawals.

*Variable annuity accounts* – TIAA Access Funds' variable annuity accounts are valued using the NAV practical expedient, an estimate of fair value. This NAV practical expedient would not be used if it is determined to be probable that the Plan will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

*Pooled separate account* – The TIAA Real Estate Account is a pooled separate account valued at NAV that seeks long-term returns primarily in real estate and real estate related investments owned by the account. The fund held by the Plan is an open-end fund that is registered with the U.S. Securities and Exchange Commission. The fund is required to publish its daily NAV and to transact at that price. The TIAA Real Estate Account held by the Plan is deemed to be actively traded.

These RA contracts are individually owned contracts in which lump sum withdrawals are not permitted, and participant-initiated transfers may only be made in 10 annual installments over a period of nine years plus one day.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **Note 3 – Guaranteed Investment Contracts**

The Plan has entered into fully benefit-responsive investment contracts with TIAA and CREF. TIAA and CREF maintain the contributions in a general account. The account is credited with earnings from the general account and charged for participant withdrawals and administrative expenses. The guaranteed investment contracts issuer are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contracts. Contract value, as reported to the Plan by TIAA and CREF, represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contracts do not permit the insurance company to terminate the agreements prior to the scheduled maturity dates.

#### **Note 4 – Related-Party Transactions**

Certain Plan investments are managed by TIAA and CREF, the custodian of the Plan. Any purchases and sales of these funds are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

#### **Note 5 – Participation and Benefits**

**Participant contributions** – Participants may elect to have the School contribute their eligible pre-tax compensation to the Plan up to the amount allowable under the Plan document and current income tax regulations.

Participants are also allowed to make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with the participant's direction and the Plan's provisions.

**Employer contributions** – The School is allowed to make contributions to the Plan in the form of matching contributions, as defined in the Plan and as approved by the Board of Directors. In 2024, the School matched 400% of the participant's elective deferrals that did not exceed 1% of the participant's eligible compensation, plus, 200% of the participant's elective deferrals that did not exceed the next 1% of the participant's eligible compensation, plus 100% of the participant's elective deferrals that did not exceed the next 1% of the participant's eligible compensation. The match will not exceed 7% of compensation each year.

The Plan allows for nonelective employer contributions. There were no nonelective employer contributions for the year-ended December 31, 2024.

**Vesting** – Participants are immediately vested in their entire account, including employer contributions.

**Participant accounts** – Each participant's account is credited with the participant's contribution, Plan earnings or losses, and an allocation of the School's contribution, if any. Allocation of the School's contribution is based on participant contributions and eligible employee compensation, as defined in the Plan.

**Payment of benefits** – Upon termination, the participants or beneficiaries may elect to leave their account balance in the Plan, or receive their total benefits in a lump sum, installment payments, or purchase life or joint and survivor annuities equal to the value of the participant's vested interest in their account. The Plan shall not make involuntary cash-outs to any terminated vested participant.

**Notes receivable from participants** – The Plan allows participants to borrow up to the lesser of \$50,000 or 50% of their account balance. The notes receivable are secured by the participant's balance. Such notes receivable bear interest at the available market financing rates and must be repaid to the Plan within a five-year period, unless the proceeds are used for the purchase of a principal residence in which case the maximum repayment period may be longer. The specific terms and conditions of such notes receivable are established by the plan administrator. There are nine outstanding notes receivable at December 31, 2024, carrying interest rates ranging from 4.25% to 9.50%, maturing in September 2029.

TIAA and CREF also issues loans to Plan participants outside of the scope of the Plan in accordance with the Plan document. Participants may borrow from TIAA and CREF a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. These loans are secured by the balance of the participant's account and bear fixed rates of interest, as determined by TIAA and CREF. The participant is required to transfer funds equal to the amount of the loan plus 10% into the TIAA Traditional Annuity Account for use as collateral on the loan. These funds are restricted with respect to withdrawals and transfers while the loan is outstanding. The maximum loan term is five years unless the loan term qualifies as a home loan, in which case the term of the loan is not to exceed ten years. Principal and interest payments are made monthly by the participant directly to TIAA and CREF. The loans themselves are not reported assets of the Plan. As of December 31, 2024, there are approximately \$23,000 outstanding loans and the rates of interest ranged from 5.09% to 5.28% with various maturities through December 2027.
