Their report, dated July 29, 2024, indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agreed to or is derived from the certified investment information, were presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. Description of the Plan

The following brief description of the Adelman Travel Systems, Inc. Profit Sharing 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

The Plan is a defined contribution plan covering all non-excluded employees of Adelman Travel Systems, Inc. (the Company or Plan administrator). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The original effective date of the Plan was January 1, 1987. The Plan was amended and restated effective January 1, 2022. No significant changes were made to the Plan as a result of this restatement.

Eligibility

The Plan covers all non-excluded employees of the Company who have completed one month of service and are at least 21 years of age. Eligible participants are automatically enrolled in the Plan on the first day of the month following the date in which the participant satisfies the service requirements. Participants will automatically defer 6% of included compensation for each payroll period, unless the eligible participant makes a contrary salary reduction agreement election. Long-term part-time employees who met eligibility requirements under SECURE Act are also eligible to participate in the Plan.

Contributions

Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants may also designate all or a portion of their deferral and Company contributions as after-tax contributions into a Roth account. All employees who are eligible to make salary deferrals under this Plan and who are age 50 or older before the close of the Plan year, are eligible to make catch-up contributions, subject to Internal Revenue Service (IRS) limits. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers)

The Company may make a discretionary matching contribution, determined and funded each pay period. During December 31, 2024, the Company matched 50% of each participant's salary deferral contribution up to a maximum of 6% of that participant's total compensation. Additionally, the Company may also make discretionary profit-sharing contributions on an annual basis. To receive an allocation of such contributions, a participant generally must be employed on the last day of the Plan year and must have completed 1,000 hours during that Plan year. There were no Company discretionary profit-sharing contributions for the 2024 Plan year.

Participant Accounts

Each participant's account is credited with the participant's contribution, rollovers, Company contributions, if any, and the Plan earnings (losses). The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Distributions

Participant accounts may be withdrawn upon retirement, death, disability, or termination of employment. If a participant terminates employment and the participant's vested account balance is less than \$7,000, the Plan administrator will authorize the benefit payment without the participant's consent. The Plan allows in-service withdrawals at age 59½, as well as withdrawals in the event of financial hardship. The withdrawals can only be made from accounts which are fully vested.

1. Description of the Plan (cont.)

Vesting

Participants are 100% vested in their deferrals, their voluntary and rollover contributions, plus actual earnings (losses) thereon. Vesting in Company contributions is based on years of credited service. The Plan document allows crediting for years of service for participants who terminate and are rehired, subject to certain rules. Based on years of credited service, the vesting schedule is as follows:

1	20%
2	40%
3	60%
4	80%
5	100%

Participants become 100% vested in their account upon attainment of age 65 or termination of employment due to death or disability.

Forfeitures

Non-vested account balances of terminated employees are forfeited upon the earlier of the complete distribution of the vested portion of the participant account or the last day of the Plan year in which the participant incurs five consecutive 1-year breaks in service. Forfeitures may be used to reduce Company contributions or pay certain Plan expenses. At December 31, 2024 and 2023, the forfeiture balances remaining were \$23,936 and \$19,204, respectively. For the year ended December 31, 2024, \$16,725 was used to reduce Plan expenses and \$9,607 was used to reduce Company contributions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan were prepared using the accrual basis of accounting. The Plan follows accounting standards set by the Financial Accounting Standards Board (FASB). The FASB sets accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income (Loss) Recognition

The investments of the Plan are reported at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Contract value is the relevant measurement for that portion of the net assets available for benefits because contract value is the amount participants would normally receive if they initiate permitted transactions under the terms of the Plan.

2. Summary of Significant Accounting Policies (cont.)

Investment Valuation and Income (Loss) Recognition (cont.)

The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian and insurance company.

Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Administrative Expenses

Certain administrative expenses are paid by the Plan. These expenses may include, but are not limited to, contract holder fees, recordkeeping fees and other fees for services provided to the Plan.

Payment of Benefits

Benefits are recorded when paid.

3. Certified Information

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Voya Retirement Insurance and Annuity Company (Voya), the Custodian of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the statement of changes in net assets available for benefits for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

4. Fair Value Measurement

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs in which little or no market data exists (Level 3 measurements). The three levels of the fair value hierarchy under GAAP are as follows:

4. Fair Value Measurement (cont.)

Level 1 - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2 - Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

Level 3 - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

The *pooled separate account* is valued at net asset value (NAV) as practical expedient based on the last reported sales price of the underlying investments held and the number of units held by the Plan at year-end.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's investments at fair value as of December 31, 2024 and 2023 are made up entirely of a pooled separate account, which is measured at the NAV as a practical expedient, and is not classified in the fair value hierarchy. The Plan has no assets at December 31, 2024 and 2023 that are classified in the fair value hierarchy.

5. Investment Contract with Insurance Company

The Plan has a guaranteed investment contract with Voya. The guaranteed investment contract is fully benefit-responsive. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The contract guarantees principal and a guaranteed minimum interest rate (GMIR) for the life of the product as well as featuring two declared interest rates: a current rate, determined at least monthly, and a guaranteed minimum floor rate declared for a defined period – currently one calendar year. The guaranteed minimum floor rate may change after a defined period, but it will never be lower than the GMIR that applies for the life of the contract. The current rate, the guaranteed minimum floor rate and the GMIR are expressed as annual effective yields. Taking the effect of compounding into account, the interest credited to your account daily yields the then current credited rate.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provision, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required transaction exemption under ERISA. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

6. Tax Status

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing Plan with CODA (pre-approved plan) sponsored by PPG Retirement Plan Services (PPG). The IRS has opined and informed PPG with a letter dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate uncertain tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Related Parties and Party-In-Interest Transactions

Voya, the custodian of the Plan's assets, performs services, sells products, and maintains certain investments of the Plan for which fees are charged to the Plan. Such transactions, while considered party-in-interest transactions under ERISA, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become 100% vested in their accounts, and the Plan administrator will facilitate the distribution of account balances under the provisions of the Plan and trust agreement until all assets have been distributed.

9. Risks, Uncertainties, and Concentrations

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

At December 31, 2024, 28% of the Plan's investments were invested in the Putnam Dynamic Asset Allocation Balanced Fund.

10. SECURE 2.0 Act of 2022

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

11. Subsequent Events

The Company has evaluated subsequent events through July 23, 2025, the date the financial statements were available to be issued.
