Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Longview Capital Corporation 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Longview Capital Corporation 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution, John Hancock Life Insurance Company, as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the Financial Statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the Financial Statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of Longview Capital Corporation 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

1. Description of Plan

The following description of Longview Capital Corporation 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering the employees of Longview Capital Corporation which consists of Longview Bank, Midwest Agri Credit, Bank of Gibson City, and Longview Community Bank (Company) who are at least 21 years of age for purposes of employee deferrals and those that are at least 21 years of age and have completed one year of service for purposes of the employer matching portion of the Plan. The Plan excludes leased employees and is subject to the provisions of ERISA.

Contributions – Each year, participants may elect to defer a portion of their annual compensation, on a pre-tax or Roth basis, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified plans. The maximum contribution to the Plan in any year is determined by the provisions in the Plan and the Internal Revenue Code and Income Tax Regulations. Participants direct the investment of these contributions into various investment options. As of December 31, 2024, the Plan offered various pooled separate accounts as investment options for participant contributions.

Company contributions are made at the option of management. For 2024, management elected to make a matching contribution of 100 percent of each participant's contribution up to 3 percent. The Plan also matched 50 percent for participant contributions between 3 percent and 7 percent, with a maximum match of 5 percent. Participants have the option to direct all Company contributions into certificates of deposits held at the Company as well as various pooled separate accounts noted above.

Participant Accounts – Each participant's account is credited with the participant's contribution, if any, and allocations of (a) the Company's contribution, if any, (b) administrative expenses, and (c) plan earnings, net of investment fees. Allocations are based on participant earnings, account balances, or other participant events, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of service. A participant is 100 percent vested after six years of credited service. All employer contributions vest immediately upon a participant's death, disability, or attainment of the normal retirement age.

Payment of Benefits – On termination of service, for any reason, a participant will receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. The Plan provides for an automatic lump-sum distribution of account balances of \$5,000 or less. In addition, the Plan allows for financial hardship withdrawals of all or part of the participant’s deferral contributions, if the participant can prove financial hardship and is unable to meet their financial needs another way.

Prior to July 23, 2023, in-service distributions of the participant’s elected deferrals are allowed for participants over age 59 ½. After July 23, 2023, in-service distributions are allowed from all accounts for participants over age 59 ½. The Plan also allows for in-service distributions of 100 percent vested employer contributions made at least two years prior to the date of such distribution.

Forfeited Accounts – Upon termination of employment, participants forfeit their nonvested balances. Forfeited amounts are used to reduce any employer contributions to be made for the plan year or to pay plan expenses. Forfeited balances included in net assets available for benefits as of December 31, 2024 and 2023, were \$502 and \$0. For the year ended December 31, 2024, \$5,676 was used to reduce employer contributions.

2. Summary of Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition – The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment and Administrative Expenses – The Plan’s expenses are paid either by the Plan or the employer, as provided by the Plan document. Expenses paid directly by the employer are excluded from these financial statements. Certain fees are charged to the Plan for services provided by the investment custodian of the Plan and are netted with investment earnings.

Payment of Benefits – Benefits are recorded when paid for financial statement purposes.

Subsequent Events – The Plan has evaluated subsequent events through June 26, 2025, the date on which the financial statements were available to be issued.

3. Information Certified by John Hancock Life Insurance Company, the Investment Custodian

Certain information, as noted below, related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in value of investments or the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company.

4. Fair Value Measurements

The Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820-10 establishes a framework for measuring fair value under generally accepted accounting principles. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Level 1 Inputs to the valuation methodology are based on unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024.

The following is a description of the valuation methodologies used for assets measured at fair value.

- *Certificates of Deposit* – Valued at the total of invested deposits plus earnings thereon, which approximates fair value. The certificates of deposit are issued by the Company and the interest rates on the certificates of deposit are set annually by the Company at rates commensurate with those offered on similar, high-quality certificates of deposit.
- *Pooled Separate Accounts* – Valued at the fair value of the underlying assets. The underlying assets are valued at the closing price reported on the active market on which the individual securities are traded. These investments follow a variety of investment strategies consistent with the asset class to which the underlying assets belong. The plan administrator is not aware of any restrictions related to these investments.
- *Pooled Separate Account* – NY Life Ins. Co. Anchor Account: A pooled separate account investing solely in the Reliance Trust New York Life Anchor Account (the Fund). The Fund is a collective investment trust maintained by Reliance Trust Company that invests 100 percent of its assets in an insurance company separate account maintained by New York Life Insurance Company. Although the portfolio will seek to maintain a stable value, there is a risk that it will not be able to do so, and participants may lose their investment. Investments in the fund will accrue interest at the applicable monthly crediting rate, which will be set based upon a formula but may be adjusted from time to time as agreed upon by Reliance Trust Company and New York Life Insurance Company. The actual market value of the underlying assets may, at times, be greater than or less than the book value of the fund. Any difference between the market value and book value will be taken into consideration when setting future crediting rates.

Management has determined that this investment qualifies for the net asset value practical expedient under FASB ASC 820, and, as such, it is not categorized in the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There are no unfunded commitments, or significant redemptions or restriction on the investment measured at net asset value per share using the practical expedient as of December 31, 2024 and 2023.

Interest earned on the certificates of deposit, which are issued by the Company, for 2024 was \$26,773.

5. Administrative Expenses and Party-In-Interest Transactions

A transaction with a plan service provider or a participant of the Plan qualifies as a party-in-interest transaction. Service provider fees, either directly or indirectly, are paid to the investment custodian and recordkeeper, third-party administrator, and investment advisor. Of these fees, \$75,097 is included in administrative expenses on Exhibit B. Other investment fees are netted with investment earnings. Expenses incurred in the administration of the Plan were also paid by the plan sponsor.

Additionally, certain plan investments are both held and managed by the custodian and the certificates of deposit are issued, held, and managed by the Company.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their employer contributions.

7. Tax Status

On June 30, 2020, the IRS stated that the pre-approved plan adopted by the Plan, as then designed, was in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended and restated since receiving the advisory letter. However, the plan administrator and the pre-approved plan provider believe the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Prohibited Transactions

During 2024, contributions totaling \$32,125 were not remitted timely to the Plan. Subsequent to year end, but as of June 26, 2025, these amounts and the associated lost earnings on the correction were remitted to the Plan.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Longview Capital Corporation 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Longview Capital Corporation 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution, John Hancock Life Insurance Company, as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the Financial Statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the Financial Statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Notes to the Financial Statements

1. Description of Plan

The following description of Longview Capital Corporation 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering the employees of Longview Capital Corporation which consists of Longview Bank, Midwest Agri Credit, Bank of Gibson City, and Longview Community Bank (Company) who are at least 21 years of age for purposes of employee deferrals and those that are at least 21 years of age and have completed one year of service for purposes of the employer matching portion of the Plan. The Plan excludes leased employees and is subject to the provisions of ERISA.

Contributions – Each year, participants may elect to defer a portion of their annual compensation, on a pre-tax or Roth basis, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified plans. The maximum contribution to the Plan in any year is determined by the provisions in the Plan and the Internal Revenue Code and Income Tax Regulations. Participants direct the investment of these contributions into various investment options. As of December 31, 2024, the Plan offered various pooled separate accounts as investment options for participant contributions.

Company contributions are made at the option of management. For 2024, management elected to make a matching contribution of 100 percent of each participant's contribution up to 3 percent. The Plan also matched 50 percent for participant contributions between 3 percent and 7 percent, with a maximum match of 5 percent. Participants have the option to direct all Company contributions into certificates of deposits held at the Company as well as various pooled separate accounts noted above.

Participant Accounts – Each participant's account is credited with the participant's contribution, if any, and allocations of (a) the Company's contribution, if any, (b) administrative expenses, and (c) plan earnings, net of investment fees. Allocations are based on participant earnings, account balances, or other participant events, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of service. A participant is 100 percent vested after six years of credited service. All employer contributions vest immediately upon a participant's death, disability, or attainment of the normal retirement age.

Payment of Benefits – On termination of service, for any reason, a participant will receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. The Plan provides for an automatic lump-sum distribution of account balances of \$5,000 or less. In addition, the Plan allows for financial hardship withdrawals of all or part of the participant’s deferral contributions, if the participant can prove financial hardship and is unable to meet their financial needs another way.

Prior to July 23, 2023, in-service distributions of the participant’s elected deferrals are allowed for participants over age 59 ½. After July 23, 2023, in-service distributions are allowed from all accounts for participants over age 59 ½. The Plan also allows for in-service distributions of 100 percent vested employer contributions made at least two years prior to the date of such distribution.

Forfeited Accounts – Upon termination of employment, participants forfeit their nonvested balances. Forfeited amounts are used to reduce any employer contributions to be made for the plan year or to pay plan expenses. Forfeited balances included in net assets available for benefits as of December 31, 2024 and 2023, were \$502 and \$0. For the year ended December 31, 2024, \$5,676 was used to reduce employer contributions.

2. Summary of Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition – The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment and Administrative Expenses – The Plan’s expenses are paid either by the Plan or the employer, as provided by the Plan document. Expenses paid directly by the employer are excluded from these financial statements. Certain fees are charged to the Plan for services provided by the investment custodian of the Plan and are netted with investment earnings.

Payment of Benefits – Benefits are recorded when paid for financial statement purposes.

Subsequent Events – The Plan has evaluated subsequent events through June 26, 2025, the date on which the financial statements were available to be issued.

3. Information Certified by John Hancock Life Insurance Company, the Investment Custodian

Certain information, as noted below, related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in value of investments or the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company.

4. Fair Value Measurements

The Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820-10 establishes a framework for measuring fair value under generally accepted accounting principles. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Level 1 Inputs to the valuation methodology are based on unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024.

The following is a description of the valuation methodologies used for assets measured at fair value.

- *Certificates of Deposit* – Valued at the total of invested deposits plus earnings thereon, which approximates fair value. The certificates of deposit are issued by the Company and the interest rates on the certificates of deposit are set annually by the Company at rates commensurate with those offered on similar, high-quality certificates of deposit.
- *Pooled Separate Accounts* – Valued at the fair value of the underlying assets. The underlying assets are valued at the closing price reported on the active market on which the individual securities are traded. These investments follow a variety of investment strategies consistent with the asset class to which the underlying assets belong. The plan administrator is not aware of any restrictions related to these investments.
- *Pooled Separate Account* – NY Life Ins. Co. Anchor Account: A pooled separate account investing solely in the Reliance Trust New York Life Anchor Account (the Fund). The Fund is a collective investment trust maintained by Reliance Trust Company that invests 100 percent of its assets in an insurance company separate account maintained by New York Life Insurance Company. Although the portfolio will seek to maintain a stable value, there is a risk that it will not be able to do so, and participants may lose their investment. Investments in the fund will accrue interest at the applicable monthly crediting rate, which will be set based upon a formula but may be adjusted from time to time as agreed upon by Reliance Trust Company and New York Life Insurance Company. The actual market value of the underlying assets may, at times, be greater than or less than the book value of the fund. Any difference between the market value and book value will be taken into consideration when setting future crediting rates.

Management has determined that this investment qualifies for the net asset value practical expedient under FASB ASC 820, and, as such, it is not categorized in the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There are no unfunded commitments, or significant redemptions or restriction on the investment measured at net asset value per share using the practical expedient as of December 31, 2024 and 2023.

Interest earned on the certificates of deposit, which are issued by the Company, for 2024 was \$26,773.

5. Administrative Expenses and Party-In-Interest Transactions

A transaction with a plan service provider or a participant of the Plan qualifies as a party-in-interest transaction. Service provider fees, either directly or indirectly, are paid to the investment custodian and recordkeeper, third-party administrator, and investment advisor. Of these fees, \$75,097 is included in administrative expenses on Exhibit B. Other investment fees are netted with investment earnings. Expenses incurred in the administration of the Plan were also paid by the plan sponsor.

Additionally, certain plan investments are both held and managed by the custodian and the certificates of deposit are issued, held, and managed by the Company.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their employer contributions.

7. Tax Status

On June 30, 2020, the IRS stated that the pre-approved plan adopted by the Plan, as then designed, was in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended and restated since receiving the advisory letter. However, the plan administrator and the pre-approved plan provider believe the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Prohibited Transactions

During 2024, contributions totaling \$32,125 were not remitted timely to the Plan. Subsequent to year end, but as of June 26, 2025, these amounts and the associated lost earnings on the correction were remitted to the Plan.
