Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Flexicon Corporation 401(k) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Flexicon Corporation 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's *Rules and Regulations for Reporting and Disclosure* under ERISA. 

NOTE 1 DESCRIPTION OF PLAN

The Flexicon Corporation 401(k) Plan (Plan) is administered by Flexicon Corporation (Company). The following brief description of the Plan is provided for general information purposes only. More complete information is provided in the Summary Plan Description and Plan Document, which are available from the Company.

General

The Plan is a voluntary, participant-directed, defined-contribution savings plan, covering certain employees of the Company and certain employees of HammerTek Corporation, a related party through common ownership. The Plan became effective October 1, 1996. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees, excluding union employees, certain nonresident aliens and employees under age 18, are eligible to participate in the Plan after completing three months of service. Employees can enter the Plan on the first day of the calendar quarter after meeting the eligibility requirements.

Contributions

Each Plan year, participants may elect to make voluntary contributions up to 100% of eligible compensation to their tax-deferred account or Roth after-tax account subject to certain statutory limitations. Participants can change their voluntary contributions on the first day of any payroll period. Participants may elect to roll over contributions that were received from another qualified plan. Participants, age 50 or older, may make an additional pre-tax contribution subject to Internal Revenue Service (IRS) limitations. The Company permits Roth contributions. The Company matches 25% of the first 8% of eligible compensation that a participant contributes to the Plan. The Company may also make a discretionary profit-sharing contribution to all eligible participants who are enrolled in the Plan on the last day of the Plan year, which is December 31. Profit-sharing contributions, if made, are based on a comparability formula as defined in the Plan. There were no discretionary profit-sharing contributions made during the 2024 Plan year.

Participant Accounts

Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant's account is credited with the participant's contribution, an allocation of the Company's match and discretionary profit-sharing contribution, Plan earnings or losses, and investment expenses. Portfolio fees normally charged by the investment funds are applied against the participant's account and reported as a reduction of fund earnings.

NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's matching contribution is based on years of continuous service. The Company's matching contributions, discretionary profit-sharing contributions and earnings thereon vest each year starting after two years of credited service, and are 100% vested after six years of credited service.

Benefit Payments

On termination of service, a participant may elect, at any time, to receive either a cash lump-sum amount equal to the value of their vested account or receive a rollover directly to the account of their choice.

The Plan allows for in-service distributions if a participant reaches 60 (normal retirement age) and hardship distributions subject to Plan provisions

When a participant retires and reaches age normal retirement age, or terminates employment due to the participant's death, disability, or attainment of age 60, the entire vested amount in the participant's account can be distributed in the form of a lump-sum payment.

Participants have the option to leave amounts in the Plan up to the required minimum distribution date, which is defined as April 1 following the calendar year of attaining the age of 72. If participants are still employed by the age of 72, the required minimum distribution date generally is April 1 following the termination date of employment. When a participant dies, the entire amount in the participant's account is distributed to the participant's beneficiary(ies).

Forfeitures

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures are allocated to pay either plan expenses, excluding participant transaction fees, employer matching or employer discretionary profit-sharing contributions. The Plan used \$2,436 during the year ended December 31, 2024, to reduce employer matching contributions. The balance in the forfeiture account as of December 31, 2024, and 2023 was \$8,287 and \$-0-, respectively.

Notes Receivable from Participants:

A participant may request a loan from their account within the Plan. The minimum loan allowed is \$1,000. The maximum loan allowed is the lesser of one-half of the vested account balance or \$50,000, reduced by the participant's highest loan balance outstanding from the Plan during the preceding 12 months. Loans must be repaid by payroll deductions over a maximum period of five years unless the loan is a principal residence loan, which must be repaid over a maximum period of 15 years. No more than one loan outstanding will be permitted at any point in time. A second loan may be permitted for the sole purpose of paying off the first loan in a situation where a refinance is not available. Loans bear interest at prime plus 1%.

Investment Options:

Investments with John Hancock Life Insurance Company, the custodian of the Plan, may be made in 26 fund vehicles, and participants may elect to have their contributions invested in any of these funds. A separate account is maintained for each participant, and interest and dividends earned by each fund are reinvested in that fund. Participants may change their investment options daily, subject to certain fund limitations.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Quoted market prices are used to value investments, if readily available. Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded as earned on the accrual basis.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative fees related to participant transactions are generally paid through a reduction in the participant account balance. Any fees not paid by the Plan will be paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Subsequent Events

The Company has evaluated its subsequent events and transactions occurring after the period ending December 31, 2024 through July 30, 2025, the date that the financial statements were available to be issued.

NOTE 3 INVESTMENTS CERTIFIED BY THE CUSTODIAN

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to, or derived from, information certified as complete and accurate by John Hancock Life Insurance Company, the custodian of the Plan.

NOTE 4 FAIR VALUE MEASUREMENTS

Fair value measurements establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; or

- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Pooled Separate Accounts: Valued at the net asset value (NAV) of units of a pooled separate account. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the pooled separate account, the investment adviser reserves the right to temporarily delay withdrawal from the account or trust in order to ensure that securities liquidations will be carried out in an orderly business manner (Other Input).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 TAX STATUS

The employer has adopted a prototype plan and has received a favorable determination letter from the Internal Revenue Service on June 30, 2020, stating that the prototype plan was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has since been amended. However, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the Internal Revenue Service.

The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 PLAN TERMINATION

Although the Company has not expressed intent to terminate the Plan, it may do so at any time under the provisions of ERISA. Upon termination of the Plan, participants will become 100% vested and entitled to their full account balance, including all Company contributions and earnings thereon, as of the termination date.

NOTE 7 PARTY- IN- INTEREST TRANSACTIONS

The Plan's investments include investments managed by John Hancock Life Insurance Company, the custodian, as defined by the Plan and, therefore, those transactions are considered as party-in-interest transactions. Fees paid by the Plan were \$105,943 the year ended December 31, 2024.

NOTE 8 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits. To the extent that a participant directs that their contributions be invested through the self-directed brokerage account option, the participant solely determines the extent to which such amounts will be diversified, if at all.

Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit



NOTE 1 DESCRIPTION OF PLAN

The Flexicon Corporation 401(k) Plan (Plan) is administered by Flexicon Corporation (Company). The following brief description of the Plan is provided for general information purposes only. More complete information is provided in the Summary Plan Description and Plan Document, which are available from the Company.

General

The Plan is a voluntary, participant-directed, defined-contribution savings plan, covering certain employees of the Company and certain employees of HammerTek Corporation, a related party through common ownership. The Plan became effective October 1, 1996. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees, excluding union employees, certain nonresident aliens and employees under age 18, are eligible to participate in the Plan after completing three months of service. Employees can enter the Plan on the first day of the calendar quarter after meeting the eligibility requirements.

Contributions

Each Plan year, participants may elect to make voluntary contributions up to 100% of eligible compensation to their tax-deferred account or Roth after-tax account subject to certain statutory limitations. Participants can change their voluntary contributions on the first day of any payroll period. Participants may elect to roll over contributions that were received from another qualified plan. Participants, age 50 or older, may make an additional pre-tax contribution subject to Internal Revenue Service (IRS) limitations. The Company permits Roth contributions. The Company matches 25% of the first 8% of eligible compensation that a participant contributes to the Plan. The Company may also make a discretionary profit-sharing contribution to all eligible participants who are enrolled in the Plan on the last day of the Plan year, which is December 31. Profit-sharing contributions, if made, are based on a comparability formula as defined in the Plan. There were no discretionary profit-sharing contributions made during the 2024 Plan year.

Participant Accounts

Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant's account is credited with the participant's contribution, an allocation of the Company's match and discretionary profit-sharing contribution, Plan earnings or losses, and investment expenses. Portfolio fees normally charged by the investment funds are applied against the participant's account and reported as a reduction of fund earnings.

NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's matching contribution is based on years of continuous service. The Company's matching contributions, discretionary profit-sharing contributions and earnings thereon vest each year starting after two years of credited service, and are 100% vested after six years of credited service.

Benefit Payments

On termination of service, a participant may elect, at any time, to receive either a cash lump-sum amount equal to the value of their vested account or receive a rollover directly to the account of their choice.

The Plan allows for in-service distributions if a participant reaches 60 (normal retirement age) and hardship distributions subject to Plan provisions

When a participant retires and reaches age normal retirement age, or terminates employment due to the participant's death, disability, or attainment of age 60, the entire vested amount in the participant's account can be distributed in the form of a lump-sum payment.

Participants have the option to leave amounts in the Plan up to the required minimum distribution date, which is defined as April 1 following the calendar year of attaining the age of 72. If participants are still employed by the age of 72, the required minimum distribution date generally is April 1 following the termination date of employment. When a participant dies, the entire amount in the participant's account is distributed to the participant's beneficiary(ies).

Forfeitures

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures are allocated to pay either plan expenses, excluding participant transaction fees, employer matching or employer discretionary profit-sharing contributions. The Plan used \$2,436 during the year ended December 31, 2024, to reduce employer matching contributions. The balance in the forfeiture account as of December 31, 2024, and 2023 was \$8,287 and \$-0-, respectively.

Notes Receivable from Participants:

A participant may request a loan from their account within the Plan. The minimum loan allowed is \$1,000. The maximum loan allowed is the lesser of one-half of the vested account balance or \$50,000, reduced by the participant's highest loan balance outstanding from the Plan during the preceding 12 months. Loans must be repaid by payroll deductions over a maximum period of five years unless the loan is a principal residence loan, which must be repaid over a maximum period of 15 years. No more than one loan outstanding will be permitted at any point in time. A second loan may be permitted for the sole purpose of paying off the first loan in a situation where a refinance is not available. Loans bear interest at prime plus 1%.

Investment Options:

Investments with John Hancock Life Insurance Company, the custodian of the Plan, may be made in 26 fund vehicles, and participants may elect to have their contributions invested in any of these funds. A separate account is maintained for each participant, and interest and dividends earned by each fund are reinvested in that fund. Participants may change their investment options daily, subject to certain fund limitations.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Quoted market prices are used to value investments, if readily available. Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded as earned on the accrual basis.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative fees related to participant transactions are generally paid through a reduction in the participant account balance. Any fees not paid by the Plan will be paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Subsequent Events

The Company has evaluated its subsequent events and transactions occurring after the period ending December 31, 2024 through July 30, 2025, the date that the financial statements were available to be issued.

NOTE 3 INVESTMENTS CERTIFIED BY THE CUSTODIAN

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to, or derived from, information certified as complete and accurate by John Hancock Life Insurance Company, the custodian of the Plan.

NOTE 4 FAIR VALUE MEASUREMENTS

Fair value measurements establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; or

- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Pooled Separate Accounts: Valued at the net asset value (NAV) of units of a pooled separate account. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the pooled separate account, the investment adviser reserves the right to temporarily delay withdrawal from the account or trust in order to ensure that securities liquidations will be carried out in an orderly business manner (Other Input).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 TAX STATUS

The employer has adopted a prototype plan and has received a favorable determination letter from the Internal Revenue Service on June 30, 2020, stating that the prototype plan was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has since been amended. However, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the Internal Revenue Service.

The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 PLAN TERMINATION

Although the Company has not expressed intent to terminate the Plan, it may do so at any time under the provisions of ERISA. Upon termination of the Plan, participants will become 100% vested and entitled to their full account balance, including all Company contributions and earnings thereon, as of the termination date.

NOTE 7 PARTY-IN-INTEREST TRANSACTIONS

The Plan's investments include investments managed by John Hancock Life Insurance Company, the custodian, as defined by the Plan and, therefore, those transactions are considered as party-in-interest transactions. Fees paid by the Plan were \$105,943 the year ended December 31, 2024.

NOTE 8 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits. To the extent that a participant directs that their contributions be invested through the self-directed brokerage account option, the participant solely determines the extent to which such amounts will be diversified, if at all.
