## Notes to Financial Statements

- 1. Description of the Plan** The following description of the iNovex Information Systems 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all employees of iNovex Information Systems (the "Company"), except for part-time, temporary, and seasonal employees who have less than one year of service of at least 1,000 hours, nonresident aliens, employees covered by a collective bargaining agreement, and leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective December 31, 2023, the Plan was amended to provide for the mergers of HTS Infosys LLC 401(k) Profit Sharing Plan and Trust ("HTS"), Secure Innovations 401(k) Plan ("Secure"), and Innoplex, LLC 401(k) Profit Sharing Plan and Trust ("Innoplex"). All net assets of HTS, Secure, and Innoplex were transferred to the Plan during January 2024 and reported as Due from merging plans as of December 31, 2023 in the accompanying financial statements.

Effective January 1, 2024, the Plan was amended and restated ("Restatement"). In connection with the Restatement, Empower Trust Company, LLC became the trustee and custodian of the Plan. All assets of the Plan were transferred to Empower Trust Company, LLC in January 2024. Effective with this Restatement, interns are excluded from participation while part-time, temporary, and seasonal employees who have less than one year of service of at least 1,000 hours are no longer excluded from participation.

**Contributions:** Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan. Roth contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Company provides a safe harbor nonelective contribution of five percent of compensation to all eligible participants. Profit sharing amounts may be contributed at the discretion of the Company. Participants must be employed on the last day of the Plan year to receive an allocation of any discretionary profit sharing contribution. Effective October 31, 2024, the Plan was amended and participants are no longer required to be employed on the last day of the Plan year to be eligible for the Company discretionary profit sharing contributions. During 2024, the Company contributed approximately \$4,704,000 as a discretionary profit sharing contribution to the Plan. Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

**Participant accounts:** Each participant's account is credited with the participant's contributions, the Company's safe harbor nonelective contributions, as well as allocations of the Company's discretionary profit sharing contribution, if any, and Plan earnings. Participant accounts may also be charged with an allocation of certain administrative expenses. Investment earnings and losses are allocated based upon the investment performance of each investment in the participant's account. Allocations of the Company's discretionary profit sharing contributions, if any, are based on a grouping allocation method whereby each participant constitutes a separate grouping classification. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes receivable from participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or longer for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the prime rate. Principal and interest are paid through payroll deductions.

**Vesting:** Participants are vested immediately in their contributions, the Company safe harbor nonelective contributions, and actual earnings thereon. Vesting in the Company discretionary profit sharing contributions is based on years of continuous service of at least 1,000 hours per year. A participant is 100 percent vested after three years of service is completed. Effective with this Restatement, the vesting schedule for the Company discretionary profit sharing contributions was modified to be 25 percent vested after one year of service is completed, 50 percent vested after two years of service is completed, and fully vested after three years of service is completed. Furthermore, participants of HTS and Innoplex who were hired prior to January 1, 2024 are 100% vested in all contributions.

**Payment of benefits:** Benefits are payable upon retirement at age 65, disability, death, or termination of employment. Hardship withdrawals and in-service withdrawals at age 59 1/2 are also permitted, subject to provisions described in the Plan document. Withdrawals from rollover contributions are permitted at any time. The Plan was amended effective September 13, 2024 to permit early retirement withdrawals at age 59 1/2. Benefits are payable in lump sum, installment or partial payments.

**Forfeited accounts:** At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$168,092 and \$3,102, respectively. These accounts will be used to reduce future Company contributions or to pay Plan expenses. During 2024, \$94,549 of forfeited nonvested accounts were used to reduce Company contributions and \$6,450 was used to pay Plan expenses.

**Administrative expenses:** Certain expenses of maintaining the Plan are paid by the Company. Transaction expenses, such as loan and distribution administration fees, are charged directly to the participant's account and are included in administrative expenses. Plan administration fees are also charged to participants based on account balances.

## 2. Significant accounting policies

**Basis of accounting:** The financial statements of the Plan are prepared under the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

**Investment valuation and income recognition:** Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are reclassified as distributions based upon the terms of the Plan document.

**Contributions:** Participant contributions are recognized in the period the participant contribution is withheld from compensation. Company safe harbor nonelective contributions and discretionary profit sharing contribution, if any, are recognized in the period the related eligible compensation is paid to the participant.

**Payment of benefits:** Benefits are recorded when paid.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Subsequent events:** The Plan has evaluated subsequent events for disclosure in these financial statements through July 25, 2025, which is the date the financial statements were available to be issued.

### 3. Certified information

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividend income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya Retirement Insurance and Annuity Company, Empower Annuity Insurance Company of America, and Empower Trust Company, LLC, the insurance companies and custodian of the Plan.

Certain information related to notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including notes receivable from participants held at December 31, 2024, and interest income from notes receivable from participants for the period from January 11, 2024 to December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC.

- 4. Fair value measurements** The Plan reports its assets at fair value based on a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The fair value of the shares of mutual funds owned by the Plan is based on quoted net asset values on the last business day of the Plan year.

The fair value of the collective trust funds is based on the net asset value ("NAV") on the last business day of the Plan year provided by the entity holding the trust funds. The NAV of the collective trust is used as a practical expedient to estimate fair value and is determined by the fund trustee based on the fair value of underlying assets in the trust, less its liabilities.

- There are no reserves against contract value for credit risk of the contract issuer or otherwise. There are no events that could limit the ability of the Plan to transact at contract value with Empower.
- 6. Risks and uncertainties** The Plan provides for investments in various securities that are exposed to risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in future statements of net assets available for benefits.
- 7. Plan termination** Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

- 8. Tax status** The Plan is a pre-approved plan of Coastal Pension Services Inc. which received an opinion letter on November 30, 2020, in which the Internal Revenue Service (“IRS”) stated that the form of the plan document was acceptable under the applicable requirements of the Internal Revenue Code (“IRC”). The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

- 9. Party-in-interest transactions** Certain Plan investments are managed by affiliates of Empower Trust Company, LLC and Empower Annuity Insurance Company of America (collectively "Empower Retirement") and Voya. Empower Retirement and Voya are the insurance companies and recordkeeper as defined by the Plan. These transactions qualify as exempt party-in-interest transactions.

Effective January 1, 2024, the Plan is a party to a plan expense agreement with Empower Retirement, LLC. Under this agreement, a portion of the revenue earned by Empower Retirement, LLC with respect to the services it provided for the Plan was made available to the Plan to pay Plan expenses. During 2024, the Plan received \$76,361, which is reported as a reduction of administrative expenses in the accompanying financial statements. During 2024, the Plan paid \$76,361 for investment advisory fees and other services from the account. These transactions qualify as exempt party-in-interest transactions.
