The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### Opinion

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE 1 - DESCRIPTION OF PLAN**

TPI Corporation (the “Company”) established the TPI Corporation Pension Plan (the “Plan”) on May 16, 1983. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan covering all full-time production and maintenance employees of the Company covered by a collective bargaining agreement who have completed 1,000 hours of service in the twelve month period after their date of hire and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Contributions**

Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan, and in accordance with applicable sections of the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers several pooled separate accounts and a guaranteed interest account as investment options for participants.

The Company may, at its discretion, contribute a set amount per pay period as a fixed-rate contribution. The amount was \$.82 for each hour of service credited up to 40 hours per week during January 1, 2024 through December 31, 2024. Contributions are subject to certain limitations.

**Participant Accounts**

Each participant’s account is credited with the participant’s contribution, an allocation of the Company’s contributions, and the Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Company’s discretionary and matching contributions plus earnings thereon is based on years of continuous service. Participants become fully vested after three years of credited service.

**Forfeitures**

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$5,066 and \$8,993, respectively. In accordance with the provisions of the Plan, these accounts will be used to reduce future employer contributions or pay plan expenses. During the years ended December 31, 2024 and 2023, \$5,953 and \$5,082, respectively, were used to reduce employer contributions or pay plan expenses.

**Participant Withdrawals**

Participants are entitled to withdraw all or a portion of their vested account balances upon attainment of age 65 or any time thereafter. Upon retirement, participants may withdraw vested benefits prior to age 65 subject to IRC penalties (unless meeting early retirement provisions under the Plan). In case of death, disability, or termination, the entire value of the participant's account may be withdrawn. The Plan also permits participants to withdraw from their accounts in the event of extreme economic hardship as prescribed by the IRC.

If a participant's vested balance is greater than \$1,000 but less than \$5,000, the vested account balance will be rolled over into an individual retirement account. For any vested balance of \$1,000 or less, the participant will receive a lump sum distribution as soon as administratively feasible.

**Participant Loans**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. Loans are secured by the vested balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%, which is based on the prime interest rate at the beginning of each month +1.00%. Principal and interest are paid ratably through payroll deductions. Beginning in 2023, the Plan allows up to two loans per participant at any one time, and loan refinancing is no longer allowed.

**Termination of the Plan**

The Company anticipates and believes that the Plan will continue without interruption but reserves the right to discontinue the Plan. In the event that such discontinuance results in termination of the Plan, the Plan provides that the assets of the funds be allocated among the participants and beneficiaries in the amounts credited to each participant's respective account at the effective date of such termination.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements. Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined contribution plan attributable to a benefit-responsive investment contract because the contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

The Plan specifies that expenses of the Plan will be paid using the Plan's assets unless paid by the Company. All administrative expenses of the Plan paid during the periods ended December 31, 2024 and 2023 were paid by the Plan.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires estimates and assumptions to be made that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**NOTE 3 - FAIR VALUE MEASUREMENT**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets.

Level 2

Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by the observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at the periods ended December 31, 2024 and 2023.

*Pooled Separate Accounts:* Valued at the net asset value (NAV) of units held by the Plan at year-end. The NAV is based on the value of the underlying assets owned by the fund, minus liabilities, and then divided by the number of shares outstanding. Fair value is considered readily determinable, and therefore, has been included in the fair value hierarchy below.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 - INVESTMENT CONTRACTS WITH INSURANCE COMPANIES**

The Plan offers a guaranteed interest account as an investment option. This account is a traditional fully benefit-responsive investment contract provided through a group annuity contract between the Plan and Empower Retirement. Empower Retirement maintains the contributions in a general account.

Because the guaranteed account is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of net assets available for benefits attributed to the guaranteed account. Contract value, as reported to the Plan by Empower Trust Company, LLC, represents contributions made under the contract, plus credited interest, less participant withdrawals and administrative fees. Participants may direct the withdrawal or transfer of all or a portion of their investment at contract value.

Under this group annuity contract, a crediting rate is established for a specified period of time and contributions invested in the guaranteed account are credited with that rate. Empower Trust Company, LLC typically reestablishes the guaranteed rate semiannually.

Certain events may limit the ability for the Plan to transact at contract value with the contract issuers, such as premature termination of the contracts and Plan termination or merger. In addition, no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and participants. In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value, such as an uncured violation of the Plan's investment guidelines, a breach of material obligation under the contracts, a material misrepresentation, and a material amendment to the agreements without the consent of the issuers.

**NOTE 5 - RELATED-PARTY TRANSACTIONS**

Certain Plan investments are managed by the custodian, Empower Retirement; therefore, these transactions qualify as party-in-interest transactions. During the periods ended December 31, 2024 and 2023, fees paid by the Plan for administrative services were \$46,443 and \$37,940, respectively.

**NOTE 6 - TAX STATUS**

The Internal Revenue Service has determined and informed the Company by a letter dated April 7, 2021 that the Plan and related trust are designed in accordance with applicable sections of the IRC. The plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax exempt.

The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 - CERTIFICATION**

The following is a summary of the unaudited information included in the Plan's financial statements and supplemental schedule that were prepared or derived from information prepared by Empower Trust Company, LLC, the certifying entity of the Plan, and furnished to the plan administrator. The plan administrator has obtained a certification from the certifying entity that such information is complete and accurate.

*Statements of Net Assets Available for Benefits* – all items and amounts.

*Statements of Changes in Net Assets Available for Benefits* – all items and amounts except for contributions, benefits paid to participants, administrative expenses, and transfers to other plans.

*Supplemental Schedule* – all items and amounts.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 9 - SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events from the statements of net assets available for benefits date through July 24, 2025, the date at which the financial statements were available to be issued, and determined there are no other items to disclose.

**NOTE 10 - PLAN TRANSFERS**

During 2024 and 2023, \$58,629 and \$64,173, respectively, was transferred to the TPI Corporation Defined Contribution 401(k) Plan.

**NOTE 11 - SETTING EVERY COMMUNITY UP FOR RETIREMENT ENHANCEMENT ACT (SECURE 2.0)**

In December 2022, SECURE 2.0 was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 SECURE Act. Most of the provisions will become effective in 2025 and forward, therefore there is no current impact to the Plan. Since the provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect.
