#### **Note 1 - Description of the Plan**

The following description of the King Beverage, Inc. Employees' 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### General

The Plan is a defined-contribution plan covering all regular full-time employees of King Beverage, Inc. (Company) who are age 18 or older. All employees are immediately eligible to participate in the Plan. Union employees, leased employees and non-resident alien employees are not eligible to participate in the Plan. The Plan provides participants with a salary deferral option pursuant to Section 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

##### Contributions

Each year, participants may contribute up to 100% of their compensation as pretax and after-tax Roth contributions and additional catch-up contributions, subject to limits of the tax law as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, subject to limits of the tax law as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined-benefit or defined-contribution plans.

Effective January 1, 2023, the Plan was amended to increase the safe harbor match formula to 100% of first the 4% of deferrals and 50% for the next 2% of deferrals. Previously, the safe harbor match formula was 100% of the first 4% of deferrals.

The Company also may elect to make a discretionary profit-sharing contribution in an amount to be determined at the end of the Plan year. Profit-sharing contributions are allocated to participants in the same proportion as the participant's compensation bears to the total of all participants' compensation. There were no discretionary profit-sharing contributions made to the Plan during 2024.

The Plan also allows the Company to make discretionary nonelective contributions. Contributions are subject to certain limitations.

##### Investment Elections

Participants direct the investment of their contributions into various investment options offered by the Plan. Participants have the opportunity to change their investment combinations on a daily basis.

##### Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings, and is charged with an allocation of administrative expenses. Allocations are made in a manner that recognizes each participant's account balance, investment selection, and timing of contributions and withdrawals. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Vesting

A participant is 100% vested in their participant-elected contributions and in the safe harbor matching contributions, and discretionary profit-sharing contributions plus actual earnings thereon.

##### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes are secured by the balance in the participant's account and bear a fixed interest rate of prime plus 1.00%. The maximum note term is five years. Principal and interest are paid ratably through payroll deductions. The interest rates were 4.25% to 9.5%, with maturities from March 2025 to December 2029, for the year ended December 31, 2024.

#### **Note 1 - Description of the Plan, continued**

##### Payment of Benefits

On termination of service due to any reason, participants with vested account balances of less than \$5,000 receive an automatic distribution to an Individual Retirement Account (IRA). On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. The Plan also allows for in-service distributions if a participant reaches 59½ and Ad-Hoc (partial) distributions subject to Plan provisions. Withdrawals due to "financial hardship" are not permitted.

#### **Note 2 - Summary of Significant Accounting Policies**

##### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### Investments Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

##### Payments of Benefits

Benefits are recorded when paid.

##### Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

##### Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

##### Subsequent Events

The Plan has evaluated subsequent events through July 30, 2025, the date the financial statements were available to be issued.

#### **Note 3 - Information Certified by Custodian**

The Plan's investments are held by John Hancock Life Insurance Company (U.S.A.), the Custodian of the Plan. Investment decisions are made at the direction of the participants. The investments are credited for earnings thereon and charged for withdrawals and expenses as charged by the Custodian. The Plan Administrator has obtained certifications from the Custodian as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that the following information provided to the Plan Administrator by the Custodian is complete and accurate:

- Investments, at fair value
- Notes receivable from participants
- Net change in fair value of investments
- Interest on notes receivable from participants

#### **Note 4 - Fair Value Measurements**

Fair value is the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance.

The Plan follows a fair value hierarchy to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement. Three levels of inputs may be used to measure fair value:

Level 1 - quoted prices in active markets for identical assets or liabilities.

Level 2 - inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

#### Note 4 - Fair Value Measurements, continued

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Pooled Separate Accounts (PSA):* PSAs invest in a variety of domestic stock, international stocks, mutual funds, bonds, and other securities. The majority of the underlying securities have observable level 1 quoted pricing inputs. While the underlying asset values are generally based on publicly quoted prices, the net asset value (NAV) of each PSA is not valued using publicly quoted prices. The NAV provided by the Custodian is used as the practical expedient to estimate fair value. PSAs can be redeemed on a daily basis and each PSA has its own investment strategy. Participants should refer to each PSAs prospectus for a description of the PSA and its investment strategy.

##### Income

---

These funds seek to achieve maximum total return that is consistent with preservation of capital and prudent investment management or track the performance of the Barclays Capital U.S. Aggregate Bond Index which broadly represents the U.S. investment-grade bond market. ##### Aggressive Growth

The majority of these funds seek long-term capital appreciation or to achieve the approximate aggregate total return of the U.S. domestic equity market index or long-term growth of capital. The mid-value fund managers identify companies whose stock prices do not appear to reflect their underlying values and select attractive investments with favorable industry structures, strong market positions, and experienced management. Managers of the small cap index fund attempt to match the performance of the Russell 2000 Index by holding all, or a representative sample of, the securities that comprise the Index. Managers of the small cap opportunity fund invest in the small and micro-cap universe; micro-cap companies are emphasized because they represent the greatest risk-return opportunities; they also identify sectors and companies undergoing change and focus on those whose market prices are depressed and whose valuation is appropriate for a value fund.

#### Note 5 - Plan Termination

#### Note 6 - Tax Status

The Internal Revenue Service (IRS) has determined by an opinion letter dated June 30, 2020, that the Non-Standardized Pre-Approved Profit-Sharing Plan with CODA sponsored by CCH Incorporated dba fdwilliam.com. which has been adopted by the Plan, is acceptable pursuant to section 401 of the IRC and in compliance with the applicable requirements of the IRC. The Plan has not requested its own determination letter from the IRS. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

#### **Note 6 - Tax Status, continued**

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 7 - Party-in-Interest Transactions**

Hunter Benefits Consulting Group provides third-party administration services to the Plan; LPL Financial Corporation Group provides investment advisory services to the Plan; and John Hancock Life Insurance Company (U.S.A.) provides custodian services to the Plan. Transactions with these entities qualify as party-in-interest transactions and are exempt from the prohibited transaction rules under ERISA.
