### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. - Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Supplemental Schedule Required by ERISA**

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Lieff, Cabraser, Heimann & Bernstein 401(k) Profit Sharing Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more specific provisions.

**A. General**

The Plan is a defined contribution plan that was established in 1990 by Lieff, Cabraser, Heimann & Bernstein, LLP (the "Firm") to provide benefits to eligible employees as defined in the Plan document. The plan administrator believes the Plan is designed and operated in compliance with applicable requirements of the Internal Revenue Code (the "Code") and provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

**B. Eligibility**

Members of the Firm of age 21 or older who have completed three consecutive months of service are eligible to participate, unless specifically excluded from the Plan. Plan entry dates are January 1 and July 1 after meeting eligibility requirements.

**C. Participant Elective Contributions**

Participants may elect to have the Firm contribute their eligible pre-tax compensation, as defined in the Plan, up to the amount allowable under the Plan document and the Code. Participants of age 50 or older may elect to make additional catch-up contributions as permitted under applicable Code limits. Participants who elect to have the Firm contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in taxable compensation.

Participants are also allowed to make rollover contributions of amounts received from other tax-qualified retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with participant investment directions.

**D. Profit Sharing Contributions**

The Firm may make discretionary contributions as defined in the Plan and as approved by the Firm's Executive Committee. Firm contributions are allocated among three rate groups based on employment status and age at year-end, as provided in the Plan document. For 2024, eligible participants received profit sharing contributions of 4.45% and 13.33% of their eligible compensation, according to rate group.

**E. Participant Accounts**

Each participant's account is credited with the participant's contributions, rollovers, Firm contributions and an allocation of Plan earnings or losses and expenses. Plan assets are invested based solely on instructions received from participants.

**F. Vesting and Forfeitures**

Participants are immediately 100% vested in their contributions, rollover contributions and related earnings. Participants are fully vested in their accounts attributable to Firm contributions

after 6 years of service. Forfeitures of terminated participants' non-vested accounts are used to reduce future Firm contributions. During 2024, approximately \$45,000 of forfeitures were used to reduce Firm contributions related to the 2023 Plan year and approximately \$85,000 of forfeitures were used to fund plan expenses during 2024. As of December 31, 2024 and 2023, forfeiture balances were approximately \$533,000 and \$45,000, respectively.

**G. Payment of Benefits**

Normal retirement age under the Plan is age 65. Upon termination of service, attainment of age 59½, death, disability or retirement, a participant or beneficiary may maintain his or her account in the Plan or elect to receive benefits payable in a lump sum equal to the value of the participant's vested account balance. Hardship distributions are allowed under limited circumstances as provided by the Plan. The Plan permits in-service withdrawals from participant profit sharing accounts to participants who meet specified eligibility conditions as defined.

**H. Notes Receivable from Participants**

The Plan allows participants to borrow not less than \$1,000 and up to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the participants' vested balance, bear interest at a fixed rate determined at loan inception based on available market financing rates and must be repaid to the Plan within a five-year period, unless a loan is used for the purchase of a principal residence in which case the loan term may be extended. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants at December 31, 2024 carry interest rates ranging from 5.25% to 10.50% with various maturities through October 2043. Notes receivable from participants are measured at their unpaid principal balance plus accrued interest. Delinquent notes receivable from participants are recorded as distributions based on the terms of the Plan document.

**I. Expenses**

The Plan record keeper and directed trustee receives revenue sharing payments from Plan investments. These payments were used to offset Plan costs for record keeping and investment advisory fees. Certain other fees for participant elective transactions, primarily withdrawal and participant loan administration fees, are charged directly to participants.

**J. Plan Termination**

Although it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA. The accounts of participants affected by a partial or complete termination of the Plan are non-forfeitable and will be determined as of the termination date.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Presentation**

The financial statements are prepared on the accrual basis of accounting.

**B. Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Purchases and sales of investments are recorded on the trade-date basis. Mutual fund capital gains distributions are included in dividend income. Net appreciation of investments includes realized and unrealized gains and losses on investments bought and sold as well as held during the year.

**C. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

**D. Risks and Uncertainties**

Plan investments are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in equity markets, interest rates or other factors in the near term would materially affect participant accounts and amounts reported in the financial statements.

**NOTE 3 - PARTY-IN-INTEREST TRANSACTIONS**

Payments of direct and indirect administrative fees to Plan service providers by the Plan are considered party-in-interest transactions under ERISA regulations. Such transactions are permitted under provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

**NOTE 4 - INCOME TAX STATUS**

The Firm adopted an approved prototype plan document that has received a favorable opinion letter from the Internal Revenue Service. The plan administrator believes the Plan is designed and operated in compliance with applicable requirements of the Code and related state statutes and the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 5 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEES**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain

information related to investments disclosed in the accompanying financial statements and supplemental schedule including investments held at December 31, 2024 and 2023, and net appreciation of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Ascensus, LLC as an authorized representative of Ascensus Trust Company and Newport Trust Company, LLC as of and for the years ended December 31, 2024 and 2023, the trustees.

**NOTE 6 - FAIR VALUE MEASUREMENTS**

Accounting guidance establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices for identical securities in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

Level 1 investments include mutual funds and cash stated at fair market value based on quoted market prices. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net assets value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Although the plan administrator believes this valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value could result in a difference fair value measurement at the reporting date.
