Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Burrelles Information Services, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of November 30, 2024 (liquidation basis) and December 31, 2023 (accrual basis), and the related statement of changes in net assets available for benefits for the eleven month period ended November 30, 2024 (liquidation basis), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Burrelles Information Services, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of November 30, 2024 (liquidation basis) and December 31, 2023 (accrual basis) and for the eleven month period ended November 30, 2024 (liquidation basis), stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the bases of accounting as described in Note 2.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Burrelles Information Services, LLC 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting for 2024

As discussed in Notes 1 and 2 to the financial statements, the Board of Trustees voted to terminate the Plan effective September 30, 2024, and management determined that liquidation is imminent. The assets of the Plan have been distributed as of November 30, 2024. As a result of the termination, the Plan changed its basis of accounting from accrual basis used in presenting the 2023 financial statements to liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the bases of accounting as described in Note 2, and for determining that the bases of accounting are an acceptable basis for the preparation of financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Burrelles Information Services, LLC 401(k) Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

1. Plan Description

The Burrelles Information Services, LLC 401(k) Plan (“the Plan”) was the retirement plan for Burrelles Information Services, LLC (the “Company”). The following description provides only general information. Participants should refer to the Plan document for more complete description of the Plan’s provisions.

Plan Termination

The Company approved the termination of the Plan effective September 30, 2024. All participants in the Plan were provided the option to have their account balance rolled into any qualified plan or IRA or receive a lump sum distribution. All Plan assets were distributed from the Plan as of the close of business on November 30, 2024.

General

Prior to termination, the Plan, a defined contribution plan, was available to all full-time employees of the Company following three months of service and attaining age 21. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan Administrator was responsible for oversight of the Plan, determining the appropriateness of the Plan’s investment offerings and monitoring investment performance.

Contributions

Each year, participants could contribute up to 50% of eligible pretax compensation, as defined by the Plan, up to the maximum allowed by law. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants directed the investment of contributions into various investment options offered by the Plan. Participants were also permitted to make contributions as “Roth” contributions. In addition, participants could contribute distributions from other qualified plans (rollovers). The Company could elect to make a discretionary matching contribution equal to a percentage of salary deferrals. The Company contributed 50% of the participant’s contribution up to a maximum of 5% of the participant’s compensation until October 31, 2018. The Company’s employer match was stopped effective October 31, 2018. Contributions were subject to certain Internal Revenue Service (“IRS”) limitations.

Participant Accounts

Each participant’s account was credited with the participant’s contributions, the Company’s matching contributions and Plan earnings (and losses) and charged with the participant’s withdrawals or distributions and an allocation of administrative expenses. Allocations were based on participant account balances as defined in the Plan document. The benefit to which a participant was entitled was the participant’s vested account.

1. Plan Description (*continued*)

Vesting

Participants were immediately vested in their contributions plus actual earnings thereon. Participants' vesting of Company matching contributions was based on years of service. A participant vests 20% after two years of credited service and each year thereafter, until 100% vested after six years of credited service. Upon death, disability, or retirement, as defined by the Plan document, a participant will become fully vested.

Notes Receivable from Participants

Prior to the Plan's assets being distributed, participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans required repayment within no more than 5 years, or up to 30 years if the loan was used for the purchase of a primary residence. The Plan allowed only one loan outstanding per participant. The loans were secured by the balance in the participant's account and bore interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Principal and interest was paid ratably through payroll deductions or otherwise in at least equal quarterly installments.

Forfeited Accounts

Forfeited accounts were amounts forfeited by participants who terminated their employment and have withdrawn from the Plan. At November 30, 2024 and December 31, 2023 forfeited non-vested accounts totaled \$0 and \$1,586. Forfeitures would be used to reduce employer matching contributions. For the eleven month period ended November 30, 2024, remaining forfeited non-vested accounts were distributed to the employees that were still in the Plan.

Payment of Benefits

Upon termination of service due to disability or retirement, a participant, or his or her beneficiary, may elect to receive one of the following forms of payment equal to the value of the participant's vested interest in his or her account: 1) lump sum; 2) fixed payment installments; or 3) partial distribution. In those cases where the vested balance, excluding rollovers, was less than \$5,000, the participant received the value of the vested interest as a lump sum distribution.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The financial statements of the Plan as of November 30, 2024 have been prepared using the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”). This basis of accounting is considered appropriate when, among other things, liquidation of an entity is imminent. On September 30, 2024 the Company approved the decision to terminate the plan and liquidation became imminent. Under the liquidation basis of accounting, assets are stated at their estimated net realized cash value and liabilities are stated at their anticipated settlement amounts. As a result of the Plan termination the Plan’s financial statements as of November 30, 2024 and for the eleven month period ended November 30, 2024 have been prepared on the liquidation basis and the December 31, 2023 financial statements have been prepared on an accrual basis, in accordance with GAAP.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At November 30, 2024, all of the Plan’s investments were distributed. At December 31, 2023, all of the Plan’s investments that were valued at fair value, were valued using level 1 inputs.

Investment Valuation and Income Recognition

All of the Plan’s investments were stated at fair value except for the group annuity contract, which was valued at contract value. Registered investment companies held by the Plan were valued at fair value based on the daily closing price as reported by the funds. All of the registered investment companies were open-ended and registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The registered investment companies of the Plan were deemed to be actively traded. The group annuity contract was valued at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Purchases and sales of investments were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were charged directly to the borrowing participant's account and were included in administrative expenses when incurred. As of November 30, 2024 and December 31, 2023, no allowance for credit losses has been recorded. If a participant did not make loan repayments and the Plan administrator considered the participant loan to be in default, the loan balance was reduced, and the delinquent participant note receivable was recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid

Administrative Expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain administration fees were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net appreciation (depreciation) of fair value of investments.

Subsequent Events

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is July 17, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements including investments and notes receivable from participants held at December 31, 2023, and net appreciation (depreciation) in value of investments, interest and dividends, and interest on notes receivable from participants for the eleven month period ended November 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, a qualified institution.

4. Common/Collective Trusts

The Plan held an investment in the Reliance Trust Company Stable Value Fund – MetLife Series diversified SAGIC through a group annuity contract totaling \$3,809,024 as of December 31, 2023. These contracts met the fully benefit responsive investment contract criteria and, therefore, were reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The traditional investment contracts that were held by the Plan were guaranteed investment contracts. Metropolitan Life Insurance Company (the “contract issuer”) was contractually obligated to repay the principal and interest at a specified interest rate that was guaranteed to the Plan. The crediting rate was based on a formula established by the contract issuer but may not be less than 0%. The crediting rate was reviewed on a quarterly basis for resetting. The contract could not be terminated before the scheduled maturity date.

The Plan’s ability to receive amounts due in accordance with fully benefit-responsive investment contracts was dependent on the third-party issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations could be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

- The Plan’s failure to qualify under Section 401(a) of the Internal Revenue Code (“IRC”) or the failure of the trust to be tax-exempt under Section 501(a) of the IRC.
- Plan termination or merger.
- Changes to the Plan’s prohibition on competing investment options.
- Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan’s normal operations.

As of September 30, 2024 the Plan Sponsor terminated the contract. Upon termination of the contract, the insurance provider exercised its right under the contract’s terms to restrict participant redemptions to market value or impose a 60 day settlement period to disburse the full contract value.

There were no penalties incurred by the Plan as a result of this termination, and all participant accounts were unaffected in terms of access to their funds, though the returns on these balances may differ during the settlement period.

5. Tax Status

The Internal Revenue Service (“IRS”) has determined and informed the prototype document preparer, ADP, by a letter dated October 6, 2020, that the Plan was designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

6. Party-in-Interest Transactions

Participants who were active employees could borrow from their accounts and such loans qualified as exempt party-in-interest transactions under ERISA. These loans were recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain administrative functions were performed by officers or employees of the Company. No such officer or employee received compensation from the Plan.
