## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter—Supplemental Schedule Required by ERISA***

The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

**Note 1. Description of the Plan**

The following description of the Mississippi Silicon 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Mississippi Silicon, LLC and Polymet Alloys, Inc., a related entity (collectively, the "Company" or the "Plan Sponsor"). Employees may enter the Plan on the first day of the month following or coinciding with the date they complete three months of service. Non-resident aliens, leased employees and union employees are excluded from the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Plan Amendment

Effective January 1, 2025, the Plan was amended to include an enhanced two-tiered Safe Harbor matching contributions, enabling it to automatically meet ADP and ACP nondiscrimination requirements. Under the new formula, eligible employees receive a match of 100 percent on the first 3 percent of deferrals, plus 50 percent on the next 3 percent. This amendment was formally documented and communicated to participants.

Contributions

Participants may elect to defer, through salary reductions, up to the maximum amount allowed by law. Participants who reach 50 years of age by the end of the Plan year are eligible to make catch-up salary reduction contributions. Catch-up contributions are not eligible for the Company's matching contribution. The Company may make a discretionary matching contribution equal to a uniform percentage of a participant's elective deferral. The Company may choose to make an additional, discretionary contribution to the Plan. This contribution is allocated among participants based on each participant's share of the total compensation paid to all participants during the year. The Company made discretionary matching and discretionary nonelective contributions totaling \$154,703 for the year ended December 31, 2024. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contributions, allocation of the Company's discretionary nonelective contribution to the Plan and Plan earnings and losses and charged with an allocation of administrative expense paid by the Plan. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are always 100 percent vested in rollover and elective deferral contributions, and Company discretionary and non-discretionary matching contributions, plus actual earnings or losses thereon.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum payment, life annuity or monthly or annual installments. For termination of service due to other reasons, a participant may receive the value in his or her account at the time of termination or the occurrence of the normal retirement date, as defined in the Plan. After attaining age 59 1/2, a participant may elect to receive an in-service distribution for all or a portion of their account balance. Hardship distributions are also available from a participant's account subject to regulatory requirements.

**Note 2. Summary of Significant Accounting Policies**

Basis of Presentation

The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants prior to March 15, 2025, and March 15, 2024, respectively.

Payment of Benefits

Benefits payments are recorded upon distribution. As of December 31, 2024 and 2023, there were no participants that elected to withdraw from the Plan but had not yet been paid as of period end.

Administrative Expenses

Plan expenses incurred are paid by the Plan Sponsor except those intrinsic to trust assets such as brokerage commissions and loan administrative fees. These expenses are charged to the participants on a pro rata basis. Fees related to the payment of benefits are assessed against each participant's account in which the benefits relate. Administrative fees incurred by participants for the year ended December 31, 2024 totaled \$3,845. Expenses paid by the Plan Sponsor are excluded from these financial statements.

Contributions

Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which participant compensation is earned.

**Note 3. Information Certified by Ascensus Trust Company**

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedules, obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus Trust Company, a qualified institution:

**Note 4. Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**Note 5. Income Tax Status**

The Plan has adopted a customized pre-approved plan sponsored by Trustmark National Bank. The customized pre-approved plan has received an advisory letter dated June 30, 2020, from the IRS as to the pre-approved plan's qualified status. The customized pre-approved plan advisory letter has been relied upon by this Plan. The customized pre-approved plan has been amended since receiving the opinion letter. The Plan administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

**Note 6. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 7. Related Party Transactions**

The Vanguard Group, Inc. ("Vanguard") provides investment advisory services to the Plan. Certain Plan investments are shares of mutual funds managed by Vanguard and, therefore, these transactions qualify as party-in-interest transactions. Expenses paid by the Plan totaled \$3,845 for the year ended December 31, 2024. Plan expenses paid by the Plan Sponsor on behalf of the Plan qualify as exempt party-in-interest transactions. Expenses paid by the Plan Sponsor totaled \$16,605 for the year ended December 31, 2024. Expenses paid by the Plan Sponsor are excluded from these financial statements.

**Note 8. Fair Value Measurements**

Accounting Standards Codification ("ASC") Topic 820 ("ASC 820"), *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Interest-bearing cash:* Cost approximates fair value due to the short maturity of these instruments (Level 1).

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
