Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE 1 – DESCRIPTION OF PLAN

The following description of the BULAB Profit Sharing and 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the plan document for more complete information.

General

The Plan is a defined contribution plan covering substantially all employees of BULAB Holdings, Inc. and its U.S. subsidiaries (the “Company”) as discussed in the plan document. BULAB Profit Sharing and 401(k) Plan Committee of the Company controls and manages the operation and administration of the Plan. Vanguard Fiduciary Trust Company (“Vanguard”) serves as the trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year, participants may contribute compensation, as defined in the plan document, subject to certain Internal Revenue Code (“IRC”) limitations. Participant salary deferrals may be traditional 401(k) (pretax) or Roth 401(k) (after-tax). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans and certain individual retirement accounts (rollovers).

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Participants of the BULAB Employee Stock Ownership Plan may also contribute through a diversification option that allows a cash distribution to the Plan. The Company contributes matching contributions up to 6% of compensation that a participant contributes to the Plan. Additional profit-sharing amounts may be contributed at the discretion of the Company’s board of directors. For the year ended December 31, 2024, the Company made a profit-sharing contribution of \$551,852.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and allocations of the Company’s contributions and Plan earnings (losses) and charged with benefit payments and allocations of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. All investments are participant-directed.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1 to 5 years for general loans or up to 20 years for the purchase of a primary residence. The loans are secured by the vested balance in the participant’s account and bear interest of the prime rate plus 1% at the time the loan is taken. Principal and interest is paid ratably through payroll deductions.

Vesting

Participants are immediately vested in their deferral contributions and rollover accounts plus actual earnings thereon. Vesting in the Company's matching and profit-sharing contributions plus actual earnings thereon is based on years of credited service, as follows:

Payment of Benefits

Upon termination of service by retirement or total and permanent disability, a participant may elect to receive a lump-sum amount equal to the vested interest in his or her account or can elect to receive installment payments or partial payments as outlined in the plan document. The plan defines normal retirement age as 65. Generally, all participants must begin withdrawing benefits no later than April 1, following the year age 72 is attained. Withdrawals by a participant while employed are limited to those requested due to events of financial hardship as defined by the plan document, withdrawals of qualified rollover or transferred assets, or upon attainment of age 59 ½.

Death and Disability Benefits

Upon death or total and permanent disability prior to normal retirement age, the participant account becomes 100% vested regardless of years of service. Death benefits can be paid to his or her beneficiary in a lump-sum payment, partial payments, or installment payments as elected by the beneficiary and outlined in the plan document.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Other professional and administrative fees are charged to participant accounts and are separately disclosed in the accompanying financial statements.

Forfeitures

Forfeited accounts of non-vested terminated participants may be used at the discretion of the Plan Sponsor to reduce future employer contributions or pay plan expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$755,405 and \$303,154, respectively. For the years ended December 31, 2024 and 2023, \$0 and \$684,624 of forfeitures were used to reduce employer contributions, respectively.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The financial statements of the Plan are prepared using the accrual method of accounting.

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the period. Actual results could differ from those estimates.

The Plan's investments are stated at fair value, as defined by generally accepted accounting principles. See Note 3 for disclosure of fair value measurement.

Notes receivable from participants are reported at their unpaid balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as deemed distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan presents in the statement of changes in net assets available for benefits the net appreciation (depreciation) in the fair value of its investments which consists of investment income, realized gains and (losses), and the unrealized appreciation (depreciation) on investments.

Benefits are recorded when paid.

Date of Management's Review

The Plan Sponsor evaluated its December 31, 2024 financial statements for subsequent events through July 28, 2025, the date the financial statements were available to be issued. The plan sponsor is not aware of any subsequent events which would require recognition or disclosure in the financial statements.

NOTE 3 – FAIR VALUE MEASUREMENTS

Generally accepted accounting principles establishes a framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under generally accepted accounting principles are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3 Inputs into the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual funds: Valued daily at the closing price reported on the active market on which the funds are traded.

Stable value collective trust funds: Valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 – RISKS AND UNCERTIANTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 5 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts and plan assets will be used solely to provide benefits for participants.

NOTE 6 – FEDERAL INCOME TAX STATUS

The Internal Revenue Service issued an opinion letter dated June 30, 2020 stating that the non-standardized pre-approved profit sharing defined contribution plan, which the Plan adopted, was designed in accordance with applicable IRC requirements. The plan administrator and the plan's tax counsel believe the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. The Plan administrator believes that the Plan has not generated any taxable income and no federal or state income tax returns have been filed. Federal and state taxing authorities could request an examination of the financial records of the Plan to ascertain if any such taxable income exists but no such examination has occurred or is pending.

NOTE 7 – EXEMPT PARTY-IN-INTERST TRANSACTIONS

Certain plan investments are managed by Vanguard, the trustee as defined by the Plan and, therefore, those transactions qualify as party-in-interest. In addition, certain administrative expenses paid by the Plan Sponsor also qualify as party-in-interest transactions. These transactions are exempt from the prohibited transaction provision of ERISA and the Internal Revenue Code.

NOTE 8 – SUMMARY OF INFORMATION CERTIFIED BY TRUSTEE

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the custodian, Vanguard, has certified that the following data include in the accompanying financial statements and supplemental information is complete and accurate:

- Investments at fair value as show in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment activity, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- The schedule of assets (held at end of year) as of December 31, 2024.
- Notes receivable from participants as of December 31, 2024 and 2023.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental information.
