Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Nellson Nutraceutical, LLC Employee Savings & Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE A - DESCRIPTION OF THE PLAN

The following description of the Nellson Nutraceutical, LLC Employee Savings & Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General

Effective December 3, 2007, the Plan was established for certain employees of Nellson Nutraceutical, LLC and subsidiaries, (the "Company" or "Employer"). The Plan is a contributory profit sharing plan under Sections 401(a) and 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

2. Eligibility

An employee is immediately eligible to participate in the Plan following thirty days of employment and the attainment of age 21. Unless eligible employees elect otherwise, they will be automatically enrolled into the Plan at a deferral rate of 3%. Each eligible employee that is auto-enrolled into the Plan will have their deferral rate automatically increased to 4%, 5% and 6% on December 24, of the first, second, and third year, respectively, following the plan year in which the participant was enrolled.

In addition, participants deferring at least 1% of compensation will have their deferral rate automatically escalated by 1% per year up to a maximum of 6% on December 24 each year, unless the participant opts out of auto-escalation.

Employees covered under a collective bargaining agreement, leased, part-time, temporary, and seasonal employees scheduled to work less than 1,000 hours in a plan year, and employees of an employer in a controlled group that has not adopted the Plan are not eligible to participate in the Plan.

3. Contributions

Participants may elect to contribute on a tax-deferred basis or an after-tax Roth basis from 1% to 100% of their compensation, up to the maximum deferral limit per Section 402(g)(1) of the IRC. Additional "catch-up" contributions can be made beginning in the plan year in which a participant will be at least age 50 by the end of the plan year.

The Employer may make a discretionary matching contribution, subject to determination on an annual basis by the Board of Directors of the Employer, in an amount equal to a percentage of the participant's deferred compensation, up to a maximum of 3% of compensation. Catch-up contributions are not matched. In addition, the Employer may also elect to contribute a discretionary non-elective contribution or a qualified non-elective contribution in an amount to be determined by the Employer to participants with 1,000 hours of service and who are employed on the last day of the plan year. No non-elective contributions were made for the year ended December 31, 2024.

4. Participant Accounts

Each participant's account is credited with the employee's contributions, rollovers, Employer matching contributions and allocations of the Employer discretionary and qualified non-elective contributions and plan earnings. Allocations for non-elective contributions are based on the ratio each participant's compensation bears to the compensation for all participants. Plan earnings on investments are allocated based on participant account balances. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

5. Investment Options

Participants may direct employee and Employer contributions, as desired, in any of a variety of investment options held by Empower Trust Company LLC (ETC), the trustee, and Empower Annuity Insurance Company ("Empower"), a custodian. Participants may change their investment options daily.

6. Notes Receivable from Participants

Subject to approval by the plan administrator, participants may borrow a minimum of \$1,000 up to 50% of their vested balance, not to exceed \$50,000 reduced by the excess of the participant's highest outstanding loan balance during the prior 12-month period. Only one outstanding loan per participant is permitted. The loan shall bear interest equal to the Prime rate plus 1% per annum. Loans must be repaid within five years of the date of issuance, in accordance with terms established by the plan administrator. Loans for the purchase of a primary residence may be repaid over 15 years.

7. Vesting

Participant contributions, rollovers, Employer qualified non-elective contributions, safe harbor contributions, if any, and actual earnings on all such contributions are fully vested at all times. Vesting of Employer matching contributions, Employer discretionary non-elective contributions, and actual earnings on such contributions is based upon the participant's years of service with the Employer as follows:

Certain employees who were terminated after September 1, 2016 became 100% vested in all Employer contributions as a result of a partial plan termination.

7. **Vesting** (Continued)

During 2022 and 2023, the Company laid off a significant number of employees at its Salt Lake City location. As a result, the Plan experienced a partial plan termination and affected participants became fully vested in their account balances.

8. **Benefit Payments**

Upon termination of service, participants are entitled to receive partial withdrawals, installments or a lump-sum amount equal to the value of their vested account balance. In the event of retirement, death or disability while employed by the Employer, the participant or a participant's beneficiary is entitled to the total value of the participant's account. In-service and hardship withdrawals are permitted if certain criteria are met.

9. **Forfeitures**

Forfeitures of terminated participants' non-vested accounts may be used to offset plan expenses or to reduce Employer contributions. Forfeitures totaling approximately \$101,000 were used to reduce Employer contributions and approximately \$49,000 was used to pay Plan expenses. As of December 31, 2024 and 2023, outstanding forfeitures available totaled \$120,729 and \$140,904, respectively, and are included in net assets available for benefits.

10. **Plan Termination**

Although it has not expressed such intent, the Employer reserves the right to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, further contributions to the Plan shall cease and all participants shall become 100% vested. Net assets available for benefits would then be distributed to the participants based on each participant's interest in the Plan. See Note A.7. regarding a partial plan termination that the Plan experienced in prior years.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting.

2. **Plan Administration**

The Employer is the plan sponsor and the plan administrator. The plan administrator is responsible for carrying out the duties imposed under ERISA.

3. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

4. Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee and custodian. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

5. Payment of Benefits

Benefits are recorded when paid.

6. Administrative Expenses

Administrative expenses incurred by the custodian and trustee in performance of their duties are paid from the assets of the Plan. Other reasonable Plan expenses may be paid from the Plan's forfeiture account. Fees related to the administration of notes receivable from participants and other participant specific fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation/depreciation in fair value of investments.

7. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

8. Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

NOTE C - CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by ETC and Empower (the trustee and custodian of the Plan).

NOTE D - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Account: The NAV is based on the accumulated values of the underlying investments at the end of the year, as provided by the trustee of the fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan holds a group annuity contract with Empower that is a guaranteed investment contract (the Contract). The Contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for a fully benefit-responsive investment contract because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings at guaranteed crediting rates, less participant withdrawals and administrative expenses. The following represents the traditional investment contract held by the Plan:

The contract issuer is obligated to repay the principal and interest at the specified interest rate that is guaranteed to the Plan. The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third party issuer's ability to meet its financial obligations which may be affected by future economic and regulatory developments.

There are generally no events that would limit the ability of the Plan to transact at contract value paid either within 90 days or over time. Also, there are no events that allow the issuer to terminate the contract which would require the Plan sponsor to settle at an amount different than contract value paid either within 90 days or over time. In addition, participant initiated transfers from this fund must be directed to and remain in a non-competing fund for a period of 90 days before it can be invested in a competing fund.

NOTE F - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Plan investments are held and managed by ETC and Empower. ETC is the trustee and Empower is a custodian, as defined by the Plan. Empower Retirement, LLC is the recordkeeper. Therefore, transactions with these entities qualify as party-in-interest transactions. Notes receivable from participants and the related interest income are also considered party-in-interest transactions.

NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

NOTE H - TAX STATUS

The Employer adopted a non-standardized pre-approved profit sharing plan ("pre-approved plan") which received a favorable opinion letter from the Internal Revenue Service (IRS) dated December 4, 2020, which stated that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter, however, the administrator and advisors believe that the Plan is currently designed and operated in compliance with the applicable provisions of the IRC. Administration errors, if any, which are insignificant or operational in nature, are handled by the plan administrator in accordance with applicable IRS correction programs. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
