## **Note 1. Description of the Plan**

The following description of the Banterra Corp Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator, Banterra Corp. (Company).

### **General**

The Plan is a defined-contribution plan sponsored by the Company covering all of its employees who have at least three months of service and are age 21 or older.

The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Ascensus Trust Company (Ascensus) is the trustee of Plan and serves as Plan custodian.

### **Contributions**

The Plan permits eligible employees, through a salary deferral election, to have the Company make annual contributions up to the statutory limits. Employee rollover contributions are also permitted. In 2024 and 2023, the Company made matching contributions on employees' salary deferral amounts of 100% on the first 6% of employees' eligible compensation. Additional amounts may be contributed at the discretion of the Company's board of directors. Contributions are subject to certain limitations. Forfeitures are used to reduce Company contributions.

The Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer 6% of eligible compensation unless the participant made an affirmative election otherwise. The Plan does not have an auto-escalation feature.

### **Participant Investment Account Options**

Investment account options available include various funds. Each participant has the option of directing his or her contributions into any of the separate investment accounts and may change the allocation daily in accordance with the various mutual funds' trading guidelines for substantially all investments held by the Plan.

### **Participant Accounts**

Each participant's account is credited with the participant's contribution, the Company's contributions and plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled are the benefits that can be provided from the participant's vested account.

### **Vesting**

Participants are immediately vested in their voluntary contributions, plus earnings thereon. Vesting in the Company's contribution portion of their accounts, plus earnings thereon, is based on years of cumulative service. A participant is fully vested after two years of cumulative service. The nonvested balance is forfeited upon termination of service.

### **Payment of Benefits**

Upon termination of service, a participant may elect to receive a lump-sum amount equal to the vested value of his or her account.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$33,857 and \$48,740, respectively. These accounts will be used to reduce the Plan's administrative expenses or reduce employer contributions. In 2024 and 2023, administrative expenses or employer contributions were reduced by \$49,694 and \$5,011, respectively.

***Notes Receivable From Participants***

Participants may, under certain circumstances as defined by the Plan Document, borrow up to the lesser of \$50,000 or 50% of their vested account balance. The minimum amount of a loan shall be \$1,000. Participants may have two notes outstanding at any time. The notes are secured by the balance in the participant's account and bear interest at the prevailing rate charged by other lenders for similar notes. The notes are repaid ratably through payroll deductions over a period of five years or less, unless for the purchase of a principal residence, in which case the note terms may be up to 30 years.

Notes receivable from participants are reported at amortized principal balance plus accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

The Plan's investments, which include mutual funds and money market funds, are valued using quoted market prices, if available. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses and Revenue Credits***

Administrative expenses may be paid by the Company or plan, at the Company's discretion. The Plan allows for revenue credits, including advisory fee rebates. The Plan invests the revenue credits in certain investment products. Administrative expenses are reported net of revenue credits as deductions in 2024 and 2023.

### **Note 3. Certification of Plan Trustee**

The Company has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus, agent for Ascensus Trust Company, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

### **Note 4. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Plan incurs expenses related to general administration and recordkeeping. The Plan paid \$177,395 and \$152,246 in fees for the years ended December 31, 2024 and 2023, respectively, including \$52,060 and \$51,636, to Ascensus for recordkeeping and custodian services, and \$125,335 and \$100,610, respectively, to UMB Financial Services for investment services. The Plan received \$164,283 and \$146,734 of advisory fee rebates during 2024 and 2023, respectively. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. The advisory fee rebates are reported net of administrative expenses in the accompanying financial statements. The Company pays certain accounting and auditing fees relating to the Plan and provides certain administrative services at no cost to the Plan.

### **Note 5. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible changes in the values of investment securities will occur in the near term and such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 6. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

***Investments***

Where quoted market prices are available in an active market, investments are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such investments are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, investments are classified within Level 3 of the hierarchy. There were no investments classified as Level 2 or Level 3 for the years ended December 31, 2024 and 2023.

**Note 7. Plan Termination**

Although it has not expressed an intention to do so, the Company has the right to amend the Plan to discontinue its contributions at any time or to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note 8. Plan Tax Status**

The Plan operates under an adoption agreement in connection with a volume submitter profit-sharing plan sponsored by Ascensus Consulting LLC. The Plan has not been submitted to the Internal Revenue Service (IRS) for an individual determination letter as the volume submitter plan document has a favorable opinion letter from the IRS. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the plan administrator believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

**Note 9. Subsequent Events**

Effective January 1, 2025, automatic enrollments will be invested in the American Funds American Balance Fund A.

Subsequent events have been evaluated through August 1, 2025, which is the date the financial statements were available to be issued.
