## Independent Auditor's Report

To the Plan Administrator and Plan Participants of the  
North Coast Medical Supply 401(k) Retirement Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of the North Coast Medical Supply 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). 

# North Coast Medical Supply 401(k) Retirement Plan

## Notes to Financial Statements

### December 31, 2024 and 2023

---

#### 1. Description of the Plan

##### General

The following description of the North Coast Medical Supply 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan’s provisions.

The Plan, originally established on January 7, 2022, is a defined contribution plan covering substantially all employees of North Coast Medical Supply, LLC and its wholly owned subsidiaries (the “Company”). Eligible employees may begin participating in the Plan on the first day of the month coinciding with or following the completion of two months of service.

The Plan is a participant-directed defined contribution plan under Sections 401(a) and 401(k) and related provisions of the Internal Revenue Code (the “Code”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

On November 11, 2024, it was announced that Cardinal Health, Inc. had entered into a definitive agreement to acquire the Company. The acquisition was finalized on April 1, 2025. In connection with the acquisition, the Company adopted a resolution to terminate the Plan, effective March 31, 2025. As a result of the termination, all affected participants became fully vested in their account balances in accordance with the Plan’s provisions. The Plan is in the process of distributing assets to participants and completing the necessary steps for formal termination.

##### Contributions

Each year, participants may contribute up to 80% of their eligible annual compensation, as defined by the Plan, subject to Internal Revenue Service (“IRS”) limits. Participants who attain age 50 before the end of the Plan year are eligible to make additional catch-up contributions, which are 100% vested and non-forfeitable. The Plan also permits participants to designate all or a portion of a participant’s contributions as pre-tax or Roth deferrals. In addition, participants may make rollover contributions from other tax-qualified plans, subject to applicable Code regulations. Rollover contributions are 100% vested and non-forfeitable.

Effective November 22, 2024, the Plan was amended to add an automatic enrollment provision for employees with a date of hire on or after October 1, 2024. Under this provision, eligible employees will be automatically enrolled in the Plan at a deferral rate of 2% of eligible compensation, contributed as pre-tax deferrals, unless the participant elects otherwise.

The Company has elected to make safe harbor matching contributions to all eligible participants in an amount equal to 100% of the first 4% of eligible compensation contributed to the Plan. These contributions satisfy certain Code requirements and eliminate the need for the Plan to perform certain annual nondiscrimination tests. Such safe harbor matching contributions are 100% vested and non-forfeitable.

The Company may make discretionary non-elective contributions to the Plan. These contributions are allocated to participants’ accounts in proportion to each participant’s compensation relative to the total compensation of all eligible participants within their designated allocation group. Contributions are subject to overall Company contribution limits and individual participant annual addition limits. These discretionary non-elective contributions are subject to a vesting schedule. For the year ended December 31, 2024, the Company elected to make \$600,000 in discretionary non-elective contributions, offset by \$46,995 in forfeitures.

The Plan includes provisions to ensure compliance with applicable statutory requirements. As such, certain limitations may be imposed on participant contributions. Contributions are subject to the annual limits established by the IRS, including limits on participant deferrals and overall annual additions to participant accounts.

#### **Participant Accounts**

Individual accounts are maintained for each participant. Each account is credited with the participant's contributions, rollover contributions, Company safe harbor matching contributions, Company discretionary non-elective contributions, and an allocation of the Plan's net earnings or losses. Accounts are also charged with an allocation of administrative expenses paid by the Plan. A participant's benefit under the Plan is the value of their vested account balance. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants may elect to invest their accounts in a variety of participant-directed investment options offered by the Plan that are designed to provide the participants with a wide range of investment options. A participant may authorize transfers among investment options at any time.

#### **Vesting**

Participants are immediately 100% vested in their own contributions and the related earnings. Company safe harbor matching contributions and associated earnings are also 100% vested immediately. Vesting in the Company's discretionary non-elective contributions, including related earnings, is based on years of continuous service and follows the vesting schedule below:

For vesting purposes, the Plan uses the elapsed time method, which measures service based on a participant's period of employment. A year of service is generally defined as a 12-month period of continuous employment beginning on the employee's hire or rehire date. Participants are credited with one year of service for each such 12-month period of uninterrupted employment. Effective January 1, 2025, the vesting schedule for the Company's discretionary non-elective contributions was changed to a two-year cliff vesting schedule.

Participants become fully vested upon termination due to retirement, death, disability, or if the Plan is terminated. Non-vested benefits are forfeited upon termination for reasons other than normal retirement, death, or disability.

#### **Payment of Benefits**

Upon termination of service due to separation of service, disability or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to death, a participant may receive the value of

the vested interest in his or her account as a lump sum distribution. The distribution shall be made to the participant or beneficiary in accordance with the election of the participant.

Participants may also elect to withdraw certain vested amounts within his or her contribution account to the extent necessary to meet a financial hardship, in accordance with the regulations and rulings of the Code.

#### **Notes Receivable from Participants**

Participants may borrow from their individual accounts a minimum amount of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Loans must be repaid within five years unless the loan is granted to allow the participant to purchase his or her principal residence. The loans are secured by the balance in the participant's account. Principal and interest are paid ratably through payroll deductions.

#### **Forfeited Accounts**

Non-vested account balances are generally forfeited upon either the full distribution of a participant's vested balance or after five consecutive one-year breaks in service, as defined in the Plan document. Forfeitures may be used to reduce Company contributions to the Plan or to pay reasonable Plan administrative expenses.

As of December 31, 2024 and 2023, forfeited non-vested account balances totaled \$13,681 and \$126,826, respectively. During 2024, a total of \$127,718 in forfeitures were utilized. Of this amount, \$49,892 related to 2024 Plan activity. The remaining forfeitures were applied to prior period Plan activity, including Company contributions.

#### **Risks and Uncertainties**

Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities and level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

## **2. Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

The financial statements as of December 31, 2024 and 2023, and for the year ended December 31, 2024, have been prepared on a going concern basis, which assumes the Plan will continue to operate as an ongoing entity for the foreseeable future. However, due to the subsequent event of the Plan's termination in 2025, the going concern basis will no longer be appropriate for future financial statements. Upon termination, the Plan will transition to a liquidation basis of accounting, as prescribed by Accounting Standards Codification ("ASC") 205 *Presentation of Financial Statements*, beginning with the financial statements for the period in which liquidation becomes imminent (e.g., the date of the Plan's termination approval, March 31, 2025). Under the liquidation basis, assets will be reported at their estimated realizable values, and liabilities will reflect amounts expected to be settled, consistent with the Plan's termination provisions.

As part of the Plan's termination, participant investments will be liquidated in accordance with the Plan's termination provisions and ERISA requirements. The Plan's assets, consisting of mutual funds, a collective investment trust, and self-directed brokerage ("BrokerageLink"), will be distributed to participants and beneficiaries in the form of lump-sum payments, rollovers to individual retirement accounts (IRAs), or other qualified plans, as elected by participants. The liquidation process is expected to be completed in 2025. The Plan administrator will oversee the liquidation and distribution process to ensure participants receive their account balances at fair value.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

#### **Net Appreciation (Depreciation) in Fair Value of Investments**

Net realized and unrealized appreciation (depreciation) are recorded in the accompanying statement of changes in net assets available for benefits as net appreciation in fair value of investments.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 below for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis using fair value. Dividends are recorded on the ex-dividend date. Interest is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Contributions**

Participant contributions and related Company safe harbor matching contributions are recorded in the year in which the participant contributions are withheld from compensation. The Company's discretionary non-elective contribution is recorded based on each participant's compensation paid during the Plan year.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Brokerage fees, transfer taxes, and other expenses incurred in connection with the investment of the Plan's assets will be added to the cost of such investments or deducted from the proceeds thereof, as the case may be. Fees related to the administration of notes receivable from participants are allocated directly to the participant responsible for the expense.

#### **Benefit Payments**

Benefits are recorded when paid.

#### Notes Receivable from Participants

Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recognized on an accrual basis. Principal and interest are repaid ratably through payroll deductions. Related fees are recorded as administrative expenses and are expensed when incurred. If a participant ceases to make loan repayments and the Plan administrator deems the loan to be in default, the outstanding loan balance is reduced and treated as a deemed distribution, which is recorded as a benefit payment.

### 3. Fair Value Measurements

Accounting Standards Codification (“ASC”) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2      Inputs to the valuation methodology include

- quoted prices for similar assets and liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques and inputs used for each general type of assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds fair values are determined utilizing quoted market prices reported on the active market on which they are traded.

The collective investment trust is valued using the net asset value (NAV) as reported by the trust, which represents fair value. The NAV is used as a practical expedient to estimate fair value. Fair value is determined by the trustee sponsoring the collective investment trust by dividing the trust’s net assets at fair value by the number of units outstanding as of the valuation date. Participant transactions (purchases and sales) may occur daily. However, if the Plan initiates a full redemption of its investment in the trust, the trustee may, at its sole discretion, impose a prior

notice period of up to 60 days for any Company-initiated withdrawal of assets. The Plan does not have any contractual obligations to make additional investments in the trust. This investment is not classified within the fair value hierarchy but is presented in the fair value reconciliation table for reconciliation to the statements of net assets available for benefits.

BrokerageLink accounts consist of common stock and registered investment companies that are valued on the basis of readily determinable market prices.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**4. Unaudited Information Certified by the Plan Trustee**

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, and was prepared by or derived from information certified by the Fidelity Management Trust Company (the "Trustee") and furnished to the plan administrator. The plan administrator has obtained certifications from the Trustee that such information is complete and accurate within the meaning of CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA.

**5. Tax Status**

The Plan sponsor adopted a non-standardized pre-approved plan document. The Internal Revenue Service (“IRS”) has determined and informed the pre-approved plan sponsor, by an opinion letter dated on June 30, 2020, that the pre-approved plan is designed in accordance with applicable sections of the Code. The Plan has not received a determination letter specific to the Plan itself. The Plan sponsor has indicated that it will take the necessary steps, if any, to bring the Plan’s operations into compliance with the Code. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effect of a tax position is recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. Parties-in-interest Transactions**

The Company, which is a party-in-interest, provides certain administrative services to the Plan at no charge. The cost of providing these services constitutes exempt party-in-interest transactions under ERISA.

Certain Plan investments are shares of mutual funds managed by Fidelity Management Trust Company, the Trustee as defined by the Plan, and therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

In addition, the Plan has arrangements with various service providers and these arrangements qualify as party-in-interest transactions.

**7. Prohibited Transactions**

During 2023 and 2022, the Company failed to remit participant contributions in a timely manner. These delinquent remittances are considered nonexempt party-in-interest transactions. In 2024, the Company remitted corrective lost earnings related to the delinquent participant contributions.

**8. Subsequent Events**

As of the date of this report, the Plan is in the process of distributing assets to participants in accordance with the applicable provisions of the Plan document and the Code.

Subsequent events have been evaluated through July 24, 2025, the date the financial statements were available to be issued.
