Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Munich Re Specialty Group N.A. Inc. Retirement Savings Plan (formerly known as Roanoke Group Inc. Retirement Savings Plan) (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

Note 1. Plan Description

The following description of Munich Re Specialty Group N.A. Inc. Retirement Savings (formerly known as Roanoke Group Inc. Retirement Savings Plan) (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions. The Plan was amended on September 3, 2024 to change its name from Roanoke Group Inc. Retirement Savings Plan to Munich Re Specialty Group, N.A. Inc. Retirement Savings Plan effective September 30, 2024.

General: The Plan is a defined contribution plan covering all employees of Munich Re Specialty Group N.A. Inc. (the Company), as defined, who are age 21 or older. Employees can enter the Plan on the first day of each month following eligibility. To be eligible for the Company discretionary profit sharing contributions, employees must have completed at least 1,000 hours of service during the Plan year and be employed by the Company as of the last day of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Each year, participants may contribute pretax, a portion of their compensation up to the lesser of 60% of their eligible compensation, as defined in the Plan, or the maximum allowed by the Internal Revenue Service (IRS). Eligible new employees were automatically enrolled at a deferral rate of 6% of eligible compensation, which will be increased annually by 1% unless employee elects otherwise, until it reaches 10% of eligible compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan allows for Roth 401(k) contributions. The Company contributes matching contributions of 100% of a participant's contribution up to 5% of their eligible compensation. Additionally, at the discretion of the Company's Board of Directors, the Company may make profit sharing contributions. The Company elected not to contribute profit sharing contributions for the years ended 2024 and 2023. Contributions are subject to certain limitations.

Participants' accounts: Each participant's account is credited with participant contributions, the Company's matching contribution, and allocations of the Company's profit sharing contribution, if any, and plan earnings. Allocations are based on the participant's earnings or account balances, as defined. Participants' accounts are charged with administrative fees on certain participant driven transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their pretax and Roth after-tax deferral contributions and actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 100% vested after five years of credited service. In addition, 100% vesting occurs upon the death, disability, or normal retirement of a participant.

Investment options: Upon enrollment in the Plan, a participant may direct contributions into a variety of investments as more fully described in the Plan's literature. Participants may change their investment options daily.

Notes receivable from participants: Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. Note terms range from one to five years but may be up to 10 years if used for the purchase of a primary residence. The notes are collateralized by the balance in the participant's account and bear interest at a rate of interest as determined by the Company based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. Principal and interest are paid through payroll deductions.

Note 1. Plan Description (Continued)

Payment of benefits: On termination of service, a participant may elect to receive either (a) a lump-sum distribution or (b) an installment distribution.

Forfeited accounts: At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$90,368 and \$55,685, respectively. These accounts are used to reduce future Company contributions. In 2024 and 2023, \$55,555 and \$21,742, respectively, of forfeitures were used to reduce Company contributions.

Note 2. Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value (except for fully benefit-responsive contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Committee determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Contributions: Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the participant contributions are withheld from compensation.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis.

Payment of benefits: Benefits are recorded when paid.

Subsequent events: The Plan's management has evaluated subsequent events for potential recognition and/or disclosure through August 1, 2025, the date the financial statements were available to be issued.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Accounting Standards Codification (ASC) 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 4. Fair Value Measurements (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Shares of registered investment companies: Valued at the daily closing price as reported by the fund. Shares of registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. Those funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Changes in fair value levels: To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to the total net assets available for benefits. For the years ended December 31, 2024 and 2023, there were no transfers in or out of Level 3.

Note 5. Investment Contract With Insurance Company

The Plan entered into a fully benefit-responsive investment contract with New York Life Insurance Company (NYL). The group annuity contract provides for two distinct accounts: The Stable Value Account and Pooled Separate Account No. 25. The Stable Value Account at all times is equal to the contributions made to the contract plus interest credited, plus dividends, if any, minus expenses withdrawn and minus withdrawals made pursuant to the annuity contract, and represents the amount NYL is contractually obligated to repay the Plan. Pooled Separate Account No. 25 is the underlying investment account in which all contributions are invested. The concept of a value other than contract value does not apply to this group annuity contract. Participants may direct the withdrawal or transfer of all or a portion of the investment at contract value.

Note 5. Investment Contract With Insurance Company (Continued)

The Plan receives interest accrued daily and credited monthly to the Stable Value Account which reflects the experience of Pooled Separate Account No. 25. Interest rates are guaranteed by NYL to be no less than 0% before deducting for expenses. The crediting interest rate as of December 31, 2024 and 2023, was 3.65% and 3.31%, respectively. Such interest rates are reviewed January 1 and July 1 of each year for resetting.

Events that limit the ability to transact at contract value with the issuer include employer-initiated plan termination, merger, spinoff, layoff, early retirements that cause significant withdrawal from the plan or any failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

Note 6. Related-Party and Party-in-Interest Transactions

Certain plan investments are shares of registered investment companies managed by Fidelity. Fidelity is the trustee and record keeper as defined by the Plan, and Mesirow Financial is the Plan's investment advisor. Therefore, these transactions qualify as party-in-interest transactions. Furthermore, Fidelity is providing plan administration services to the Plan. Participants pay fees for certain participant driven transactions. Total fees paid to Fidelity and Mesirow Financial amounted to \$2,975 and \$47,340, respectively, for the year ended December 31, 2024, and \$2,653 and \$44,430, respectively, for the year ended December 31, 2023.

All other fees are paid by the Company on behalf of the Plan and are excluded from these financial statements. Certain employees of the Company provide administrative services to the Plan. These employees are not compensated for such services.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their Company contributions.

Note 8. Tax Status

The Plan adopted a preapproved plan document that received an opinion letter from the IRS dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed and is being operated, in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Munich Re Specialty Group N.A. Inc. Retirement Savings Plan (formerly known as Roanoke Group Inc. Retirement Savings Plan) (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements, or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Notes to Financial Statements

Note 1. Plan Description

The following description of Munich Re Specialty Group N.A. Inc. Retirement Savings (formerly known as Roanoke Group Inc. Retirement Savings Plan) (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions. The Plan was amended on September 3, 2024 to change its name from Roanoke Group Inc. Retirement Savings Plan to Munich Re Specialty Group, N.A. Inc. Retirement Savings Plan effective September 30, 2024.

General: The Plan is a defined contribution plan covering all employees of Munich Re Specialty Group N.A. Inc. (the Company), as defined, who are age 21 or older. Employees can enter the Plan on the first day of each month following eligibility. To be eligible for the Company discretionary profit sharing contributions, employees must have completed at least 1,000 hours of service during the Plan year and be employed by the Company as of the last day of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Each year, participants may contribute pretax, a portion of their compensation up to the lesser of 60% of their eligible compensation, as defined in the Plan, or the maximum allowed by the Internal Revenue Service (IRS). Eligible new employees were automatically enrolled at a deferral rate of 6% of eligible compensation, which will be increased annually by 1% unless employee elects otherwise, until it reaches 10% of eligible compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan allows for Roth 401(k) contributions. The Company contributes matching contributions of 100% of a participant's contribution up to 5% of their eligible compensation. Additionally, at the discretion of the Company's Board of Directors, the Company may make profit sharing contributions. The Company elected not to contribute profit sharing contributions for the years ended 2024 and 2023. Contributions are subject to certain limitations.

Participants' accounts: Each participant's account is credited with participant contributions, the Company's matching contribution, and allocations of the Company's profit sharing contribution, if any, and plan earnings. Allocations are based on the participant's earnings or account balances, as defined. Participants' accounts are charged with administrative fees on certain participant driven transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their pretax and Roth after-tax deferral contributions and actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 100% vested after five years of credited service. In addition, 100% vesting occurs upon the death, disability, or normal retirement of a participant.

Investment options: Upon enrollment in the Plan, a participant may direct contributions into a variety of investments as more fully described in the Plan's literature. Participants may change their investment options daily.

Notes receivable from participants: Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. Note terms range from one to five years but may be up to 10 years if used for the purchase of a primary residence. The notes are collateralized by the balance in the participant's account and bear interest at a rate of interest as determined by the Company based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. Principal and interest are paid through payroll deductions.

Note 1. Plan Description (Continued)

Payment of benefits: On termination of service, a participant may elect to receive either (a) a lump-sum distribution or (b) an installment distribution.

Forfeited accounts: At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$90,368 and \$55,685, respectively. These accounts are used to reduce future Company contributions. In 2024 and 2023, \$55,555 and \$21,742, respectively, of forfeitures were used to reduce Company contributions.

Note 2. Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value (except for fully benefit-responsive contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Committee determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Contributions: Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the participant contributions are withheld from compensation.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis.

Payment of benefits: Benefits are recorded when paid.

Subsequent events: The Plan's management has evaluated subsequent events for potential recognition and/or disclosure through August 1, 2025, the date the financial statements were available to be issued.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Accounting Standards Codification (ASC) 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 4. Fair Value Measurements (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Shares of registered investment companies: Valued at the daily closing price as reported by the fund. Shares of registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. Those funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Changes in fair value levels: To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to the total net assets available for benefits. For the years ended December 31, 2024 and 2023, there were no transfers in or out of Level 3.

Note 5. Investment Contract With Insurance Company

The Plan entered into a fully benefit-responsive investment contract with New York Life Insurance Company (NYL). The group annuity contract provides for two distinct accounts: The Stable Value Account and Pooled Separate Account No. 25. The Stable Value Account at all times is equal to the contributions made to the contract plus interest credited, plus dividends, if any, minus expenses withdrawn and minus withdrawals made pursuant to the annuity contract, and represents the amount NYL is contractually obligated to repay the Plan. Pooled Separate Account No. 25 is the underlying investment account in which all contributions are invested. The concept of a value other than contract value does not apply to this group annuity contract. Participants may direct the withdrawal or transfer of all or a portion of the investment at contract value.

Note 5. Investment Contract With Insurance Company (Continued)

The Plan receives interest accrued daily and credited monthly to the Stable Value Account which reflects the experience of Pooled Separate Account No. 25. Interest rates are guaranteed by NYL to be no less than 0% before deducting for expenses. The crediting interest rate as of December 31, 2024 and 2023, was 3.65% and 3.31%, respectively. Such interest rates are reviewed January 1 and July 1 of each year for resetting.

Events that limit the ability to transact at contract value with the issuer include employer-initiated plan termination, merger, spinoff, layoff, early retirements that cause significant withdrawal from the plan or any failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

Note 6. Related-Party and Party-in-Interest Transactions

Certain plan investments are shares of registered investment companies managed by Fidelity. Fidelity is the trustee and record keeper as defined by the Plan, and Mesirow Financial is the Plan's investment advisor. Therefore, these transactions qualify as party-in-interest transactions. Furthermore, Fidelity is providing plan administration services to the Plan. Participants pay fees for certain participant driven transactions. Total fees paid to Fidelity and Mesirow Financial amounted to \$2,975 and \$47,340, respectively, for the year ended December 31, 2024, and \$2,653 and \$44,430, respectively, for the year ended December 31, 2023.

All other fees are paid by the Company on behalf of the Plan and are excluded from these financial statements. Certain employees of the Company provide administrative services to the Plan. These employees are not compensated for such services.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their Company contributions.

Note 8. Tax Status

The Plan adopted a preapproved plan document that received an opinion letter from the IRS dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed and is being operated, in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
