INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of

***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

### ***Responsibilities of Management for the Financial Statements***

Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Harbor Pipe & Steel, Inc. 401(k) Plan’s ability to continue as a going concern for one year after the date financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors’ Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

***Other Matter - Supplemental Schedule Required by ERISA***

The supplemental Schedule H, line 4i-Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE A - DESCRIPTION OF THE PLAN**

The following description of the Harbor Pipe & Steel, Inc. (the “Employer”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**1. General**

Effective January 1, 2015, the Plan was established for employees of Harbor Pipe & Steel, Inc. (the “Employer”). The Plan is established for the exclusive benefit of all eligible employees and their beneficiaries with the intention to provide a measure of retirement security under Sections 401(a) and 401(k) of the Internal Revenue Code (“IRC”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**2. Eligibility**

All employees, except union employees and nonresident aliens, are eligible for participation in the Plan upon attaining age 21 and completion of 6 months of service with the Employer. An employee may enroll on the first day of the Plan year quarter coinciding with or next following the date eligibility requirements are met.

**3. Contributions**

Participants may elect to contribute on a pre-tax basis, up to 90% of their compensation, not to exceed the maximum deferral limit per Section 402(g)(1) of the IRC of \$23,000 for the year ended December 31, 2024. Additional “catch-up” contributions can be made beginning in the Plan year in which a participant will be at least age 50 by the end of the Plan year. The maximum “catch-up” contribution is \$7,500 in 2024.

The Employer may make a basic safe harbor contribution to the Plan at its discretion. For the Plan year ended December 31, 2024, the Employer made a safe harbor contribution match of 100% of participant contributions for the first 3% of participant compensation and 50% of participant contributions for the next 2% of participant compensation for a maximum match equal to 4% of participant compensation. Safe harbor Employer contributions totaled \$287,243 and \$298,830 for the years ended December 31, 2024 and 2023.

At the discretion of the Employer, additional Employer contributions can be made. No additional contributions were made for the Plan year ended December 31, 2024.

**4. Rollover Contributions**

An employee who qualifies as part of an eligible class of employees can make rollover contributions subject to the guidelines of the Plan.

**NOTE A - DESCRIPTION OF THE PLAN (Continued)**

**5. Participant Accounts**

Each participant-directed account is credited with the participant's deferred compensation, rollover contribution, Employer safe harbor matching contributions and allocations of the discretionary Employer contribution, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**6. Investment Options**

Participants may direct employee and Employer contributions, as desired, in any of a variety of investment options held by Reliance Trust Company, as provided by the Plan. Participants may change their investment options daily.

**7. Vesting**

Participants are fully vested in their elective deferral contributions, rollover contributions, and Employer safe harbor contributions plus actual earnings thereon. Employer contributions are subject to a vesting schedule based upon the participant's years of service with the Employer as follows:

Less than 2	0%
2 but less than 3	20%
3 but less than 4	40%
4 but less than 5	60%
5 but less than 6	80%
6 or more	100%

**8. Benefit Payments**

Upon termination of service, retirement, or the attainment of the age of 59½ years, participants are entitled to receive in a single lump-sum payment, installments, or partial withdrawal equal to the value of his or her vested account balances. In the event of death or disability, a participant's beneficiary or the participant is entitled to the total value of the participant's account.

**NOTE A - DESCRIPTION OF THE PLAN (Continued)**

**9. Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to 50% of their vested account balance, not to exceed \$50,000 reduced by any outstanding loan. The loan shall bear a reasonable interest rate consistent with rates being charged by commercial banks plus 1%. Loans must be repaid within 5 years of the date of issuance in accordance with terms established by the plan administrator.

Loans for the purchase of a principal residence must be repaid within 30 years. A participant may have only one loan outstanding at any given time.

**10. Forfeitures**

Forfeitures of terminated participants' non-vested accounts are applied against future Employer contributions or reallocated to participants. Forfeitures applied during the years ended December 31, 2024 and 2023, as well as the forfeiture balances as of those dates, were immaterial to the financial statements as a whole.

**11. Plan Termination**

While the Employer has not expressed any intent to terminate the Plan, the Employer has the right to terminate the Plan at any time, subject to the provisions of ERISA. Upon termination, all interests of participants become fully vested, and the assets are distributed among the participants of the Plan in accordance with the provisions of the Plan.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**1. Basis of Presentation**

The accompanying financial statements have been prepared based on the accrual basis of accounting.

**2. Plan Administration**

The Employer is the plan sponsor and the plan administrator. The plan administrator is responsible for carrying out the duties imposed under ERISA.

**3. Investment Valuation and Income Recognition**

Plan investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors. See Note D for discussion of fair value measurements.

**3. Investment Valuation and Income Recognition (Continued)**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**4. Administrative Expenses**

Administrative expenses incurred by the trustee in the performance of its duties are paid from the assets of the Plan. Fees related to the administration of notes receivable and other participant-specific fees are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in the net appreciation of fair value of investments.

**5. Payment of Benefits**

Benefits are recorded when paid.

**6. Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**7. Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**8. Contributions**

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

**NOTE C - CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the trustee of the Plan).

**NOTE D - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The 3 levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2            Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The NAV for mutual funds is a publicly available quoted price in an active market.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE E - PARTY-IN-INTEREST TRANSACTIONS**

Plan investments are held by Reliance Trust Company, the trustee for the Plan. Automatic Data Processing Inc. provides record-keeping services for the Plan. These transactions qualify as party-in-interest transactions. Notes receivable from Plan participants and the related interest income are also considered party-in-interest transactions as defined in Section 3(14) of ERISA, for which a statutory exemption exists.

**NOTE F - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**NOTE F - RISKS AND UNCERTAINTIES (Continued)**

The Plan invests, through mutual funds, in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments.

**NOTE G - INCOME TAX STATUS**

The Employer adopted a volume submitter document, which the Internal Revenue Service (“IRS”) issued a favorable opinion letter dated October 6, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC. Administration errors, if any, that are insignificant or operational in nature, are handled by the plan administrator in accordance with applicable IRS correction policies. Therefore, the plan administrator believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE H - SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events through July 30, 2025, the date the financial statements were available to be issued.
