Opinion

Notes to Financial Statements

December 31, 2024 and 2023

(1) Description of Plan

The following description of the Polysciences, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees (as defined by plan document) of Polysciences, Inc., Bangs Laboratories, Inc. and Ethos Biosciences, Inc. (collectively, the Companies) who have completed one hour of service in a thirty day period and attained 18 years of age. To participate in the employer match, the employee must complete one year of service (1,000 hours). The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA), as amended. The Trustees are responsible for oversight of the Plan. The Retirement Committee determines the appropriateness of the Plan's offerings, monitors investment performance, and reports to the Plan's Trustees.

Contributions

Participants may elect to reduce their compensation and have that amount contributed to the Plan on a pre-tax basis as a salary deferral, as defined in the Plan. Participants may also make Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans, as defined by the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a variety of registered investment companies for participants. The Companies also make matching contributions equal to 100% of the first 3% of compensation that a participant contributes to the Plan (safe-harbor contributions) plus 50% of salary deferrals between 3% and 5% of compensation. The Companies at their discretion may also make profit sharing contributions as defined by the Plan. There were no profit sharing contributions made in 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Companies' contribution and (b) plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

December 31, 2024 and 2023

(1) Description of Plan, Continued

Vesting

Participants are immediately vested in their contributions, the Companies' matching and profit sharing contributions plus actual earnings or losses thereon.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participants' accounts and bear interest at a fixed rate of interest which is the prime rate in effect at the time the loan is taken. All interest rates currently range from 3.25% to 8.50%. Principal and interest are paid ratably through biweekly payroll deductions.

Payment of Benefits

While employed, a participant may be entitled to withdraw up to 100% of his or her account balance upon attaining age 59 ½.

Upon termination of service due to death, disability, or retirement, a participant will receive a lump-sum amount (or annual installments for required minimum distribution) equal to the value of the participant's vested interest in his or her account.

Forfeited Amounts

Forfeitures in the Plan are available to reduce Company contributions and pay plan expenses. There was no balance in the forfeited non-vested account as of December 31, 2024 and 2023, respectively. No forfeited non-vested amounts were used to reduce the Company contributions for the year ended December 31, 2024.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(2) Summary of Significant Accounting Policies, Continued

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is accrued when earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent loans are treated as distributions based upon the terms of the plan document.

Contributions

Contributions from plan participants and the matching contributions from the Companies are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Although not required to do so, the Companies may elect to pay administrative expenses of the Plan. Fees related to the administration of notes receivable from participants are charged directly to each participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Risks and Uncertainties

The Plan invests in various investment securities that are, in general, exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(2) Summary of Significant Accounting Policies, Continued

Subsequent Events

The Plan has evaluated subsequent events through August 1, 2025, the date the financial statements were available to be issued.

(3) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the assets or liabilities;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means;

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at the fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

(3) Fair Value Measurements, Continued

Registered investment companies: Valued at the net asset value (NAV) of shares held by the Plan at year end. The investments held by the Plan are open end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

(4) Related Party Transactions and Party-In-Interest Transactions

Certain plan investments are shares of registered investment companies managed by Vanguard. Vanguard is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment.

(5) Plan Termination

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA.

(6) Tax Status

The Plan uses a prototype plan document sponsored by Web401k.Com, Inc. (Web401k). The Internal Revenue Service (IRS) has determined and informed Web401K by a letter dated June 30, 2020, that the prototype plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended and restated since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
