## Independent Auditors' Report

To the Plan Administrative Committee  
Life Care Centers of America, Inc. Welfare Benefits Plan

### *Opinion*

We have audited the financial statements of the Life Care Centers of America, Inc. Welfare Benefits Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits, and of plan benefit obligations as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits, and of changes in plan benefit obligations as of December 31, 2024, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits, and plan benefit obligations of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits, and changes in plan benefit obligations for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America ("GAAP").

### *Basis for Opinion*

## Notes to the Financial Statements

December 31, 2024 and 2023

(1) Description of plan

The following brief description of the Life Care Centers of America, Inc. Welfare Benefits Plan is provided for general informational purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

(a) General

The Plan was established to provide health, prescription drugs, life insurance, dental, vision, temporary disability and long-term disability benefits to substantially all employees of Life Care Centers of America, Inc. (the "Sponsor") and its participating facilities and affiliates (collectively, the "Employer") who regularly work 30 hours or more per week. Employees are eligible to participate the first day of the month after sixty days of continuous employment. Dependents are also eligible for coverage under the Plan. Postretirement benefits are not offered by this Plan.

The Plan is a partially self-insured plan supplemented by stop-loss insurance and is funded from the Sponsor, participating facilities, and employee contributions to Life Care Centers of America, Inc. Associate Benefit Trust (the "Trust"). The Plan and the related Trust constitute a Voluntary Employees' Beneficiary Association (VEBA) within the meaning of Section 501(c)(9) of the Internal Revenue Code (IRC). The Trust agreement restricts the corpus, income and assets of the Plan for the exclusive benefit of the participants until all liabilities have been satisfied.

The Sponsor's funding policy is to contribute to the Trust tax deductible amounts actuarially determined to provide payments of the benefits under the Plan and other Trust expenditures. The Sponsor subsequently collects active participant contributions through payroll deduction. COBRA participants fund to a third party, which collects and remits to the Trust. Contributions are based on the participant's elected tier. Contribution rates are actuarially determined based on medical trends.

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. Participants pay the full cost of supplemental and dependent life insurance, dental, vision and voluntary disability insurance programs based on the current group rate premium costs. The Employer pays the full cost of basic life insurance and stop loss insurance. The costs of the medical premiums are shared by the Employer and the participants. Any deficiency of the Plan's net assets over benefit obligations would be funded by the Employer on a pay-as-you-go basis.

Premiums for fully insured benefits are paid directly to insurance carriers by the Sponsor and its facilities. Included in total contributions and insurance premiums paid are \$18,573,430 of fully insured benefits premiums paid directly by facilities for the year ended December 31, 2024.

Medical care benefits are provided on a self-insured basis with a reinsurance contract for annual claims in excess of \$600,000 in 2024. Such contract provides coverage under a stop-loss policy with no limit per participant. The Plan recovered \$1,179,755 under the reinsurance agreement for the year ended December 31, 2024.

The Plan offers Flexible Spending Accounts (FSA) that are funded through participant contributions. The accounts allow eligible participants to be reimbursed tax free for qualified medical expenses or dependent care services subject to a specified ceiling. Any unused funds not claimed by March 31 of the following plan year are forfeited. The accounts cannot be used for anything other than reimbursements for qualified medical expenses or dependent care services; and remaining amounts are not portable upon termination once the employee leaves the Employer.

The Plan offers Health Savings Accounts (HSA) that are funded through participant contributions. The accounts allow eligible participants to be reimbursed tax free for qualified medical expenses. Unused funds are rolled over from year to year; and remaining amounts are portable upon termination. The participant owns the account and is responsible for substantiating distributions from his or her account, thus amounts related to HSAs are excluded from the financial statements.

The life, accidental death and dismemberment, dental, vision and temporary and long-term disability benefits are fully insured benefits under contracts issued by various insurance companies to the Plan.

### (2) Summary of significant accounting policies

#### (a) Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### (b) Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, incurred but not reported eligibility credits, claims payable and disclosure of contingent assets, and liabilities. Actual results could differ from those estimates.

#### (c) Cash and investments

The Plan maintains cash in operating accounts and investment accounts comprised of money market funds and certificates of deposit at seven financial institutions, which may at times exceed federally insured amounts. The balances in excess of federally insured amounts totaled \$19,352,675 and \$12,133,859 as of December 31, 2024 and 2023, respectively.

Notes to the Financial Statements

December 31, 2024 and 2023

(d) Investment valuation and income recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment provider. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

(e) Pharmacy rebate

The Plan's contract with its pharmacy benefit manager provides rebates to the Plan in the event drug manufacturers offer rebates to the pharmacy benefit manager. The Plan receives rebates based on pharmacy utilization. The Plan records a receivable for rebates if notified by the pharmacy benefit manager by the Plan's year-end that a rebate was earned. Benefits paid have been reduced by rebates totaling \$16,861,942 for December 31, 2024.

(f) Flexible spending accounts

Participants can contribute to their FSA through payroll deductions and use funds to pay for dependent care services or their portion of qualifying medical expenses. The amount elected by the participant to contribute to the FSA is available on January 1 of each year. Included in other assets are advancements by the Plan of \$77,140 and \$139,603, as of December 31, 2024 and 2023, respectively, paid to the third-party administrator to cover claims paid prior to the first payroll of 2025 and 2024, respectively.

Included in the accompanying statements of net assets available for benefits are amounts available to reimburse participants for dependent care services and qualifying medical expenses totaling \$221,820 and \$206,457, as of December 31, 2024 and 2023, respectively. Claims incurred before plan year-end that were submitted after year-end (but before March 31, as defined by the plan agreement) totaled \$143,184 relating to 2024. Contributions withheld before plan year-end that were remitted after year-end totaled \$59,776. Forfeited amounts may be used by the Sponsor to pay expenses or provide additional benefits. Forfeited amounts totaling \$551,456 and \$529,705 were available for use as of December 31, 2024 and 2023, respectively.

(g) Benefits paid

Benefits are recognized when paid by the third party claims processors and are reported in the statement of changes in net assets available for benefits net of rebates.

Notes to the Financial Statements

(h) Plan benefit obligations

Plan benefit obligations consist of amounts currently payable to or for participants, beneficiaries and dependents and claims incurred but not reported.

Benefit payments are recorded when paid by the claims processor. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as claims payable in the accompanying statement of changes in plan benefit obligations.

Claims incurred but not reported are estimated by the Plan's actuary in accordance with accepted actuarial principles based on claims data provided by the Plan's third-party claims administrators and adjusted for expected increases in costs and a risk contingency margin of 5% to reflect the uncertainty in the timing and amount of claims payments. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

(i) Administrative expenses

Certain expenses of maintaining the Plan are paid directly by either the Plan or the Sponsor, as provided by the plan document.

(j) Subsequent events

The Sponsor has evaluated events and transactions that occurred between December 31, 2024, and August 1, 2025, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

(3) Fair value measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- (i) Money market funds: Valued at fair value which includes deposits plus interest less withdrawals. Money market funds held by the Plan are investments accounts held by the respective banking entities and are not traded on active markets.
- (ii) Certificate of deposit and interest-bearing cash: Valued based on amortized cost or original cost plus accrued interest, which approximates fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Sponsor provides certain management services to the Plan. Included in administrative salaries and expenses is \$605,693 of management services provided by the Sponsor for the year ended December 31, 2024. Additionally, the Plan reimburses the Sponsor for expenses paid by the Sponsor on behalf of the Plan. These expenses totaled \$1,502,191 for the year ended December 31, 2024. Payables due to the Sponsor from the Plan were \$145,264 and \$151,121 as of December 31, 2024 and 2023, respectively. In addition, the Plan holds cash, money market funds, and a certificate of deposit at financial institutions which are also considered parties-in-interest under the Employee Retirement Income Security Act of 1974 (ERISA).

(5) Plan termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the Sponsor shall have no obligation under the Plan beyond paying the claims and expenses incurred up to the date of termination plus extended benefits, if any, as defined in the Plan. Termination of the Plan shall not permit the return or reversion to the Sponsor of any part of the Trust.

(6) Tax status

The VEBA Trust established under the Plan to hold the Plan's assets obtained an exemption letter effective September 29, 2006, in which the Internal Revenue Service stated that the Trust, as then designed, was tax-exempt under the provisions of Section 501(c)(9) of the IRC. However, as a result of the Plan's funding policy, from time to time, the Trust may be subject to income taxes. The Plan had unrelated business income from interest income received on the investments of the Trust in 2024. No significant tax amounts were associated with the income.

In addition, the Plan and the Trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the Trust. The plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related Trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(7) Risks and uncertainties

The preparation of financial statements in conformity with GAAP requires plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, Plan benefit obligations and changes therein, claims incurred but not reported, and claims payable, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
