Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Community Concepts, Inc. Tax Deferred Annuity Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management has obtained certifications from qualified institutions as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

Notes to Financial Statements

December 31, 2024 and 2023

1. Description of Plan

The following description of Community Concepts, Inc. Tax Deferred Annuity Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions, including benefit provisions.

General

The Plan is a defined contribution plan sponsored by Community Concepts, Inc. (the Company). The Plan is available to substantially all Company employees, excluding employees that normally work less than 20 hours per week. Employees are eligible to make salary deferrals to the Plan as of their date of hire. There are no age or service restrictions upon entering the Plan. Employees are eligible to receive an employer match after reaching age 21 and completing one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants can elect to defer up to the maximum allowable amount, as determined by the Internal Revenue Code (IRC). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company matches 100% of participants' contributions up to 4% of eligible compensation. The Company may also make additional discretionary contributions, which was 2% of eligible compensation for all eligible participants in 2024.

2. Summary of Significant Accounting Policies

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investments

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold, as well as held, during the year. The Plan's investments are stated at fair value, except for the fully benefit-responsive fixed accounts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurement.

The Plan has fully benefit-responsive fixed accounts with Voya Retirement Insurance and Annuity Company (Voya) and Principal Trust Company (Principal). The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The fixed accounts are included in the financial statements at contract value as reported to the Plan by Voya and Principal. Contract values represent contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Because the fixed accounts are

fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the fixed accounts. The fixed accounts seek to provide stability of principal while earning current income that exceeds money market rates over the long term. A delay of up to 12 months may be experienced for plan level withdrawals.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits paid to participants are recorded when amounts are distributed.

Administrative Expenses

Certain expenses incurred to maintain the Plan are paid directly by the Company and are excluded from these financial statements. Certain investment-related expenses are included in net appreciation in fair value of investments. Fees paid to Principal, the Plan custodian, totaled \$98,706 in 2024.

Subsequent Events

The Plan has evaluated subsequent events through July 30, 2025, the date the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

3. Information Prepared and Certified by Custodians

The investments, investment transactions, net appreciation in fair value of investments, notes receivable from participants, and interest and dividends were obtained by management and agreed to or derived from the information certified by the custodians as complete and accurate. The information is included in the following:

4. Income Tax Status

The Plan sponsor adopted a volume submitter 403(b) plan, which received a favorable advisory letter on March 31, 2017, in which the Internal Revenue Service stated that the volume submitter plan as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The volume submitter plan has been amended since receiving the advisory letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently

designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

5. Party-in-Interest Transactions

Plan investments are managed by Voya and Principal, the custodians; therefore, these transactions qualify as party-in-interest transactions.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Fair Value Measurement

Financial Accounting Standards Board Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023:

Mutual funds: Valued at the quoted net asset value (NAV) of shares held by the Plan at year-end.

Pooled separate accounts: Valued using fair value using the market approach based on the underlying NAV of units held by the Plan. Investments in separate accounts seek total return and do not have redemption restrictions.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
