### **NOTE A – DESCRIPTION OF THE PLAN**

The following description of the Hedrick Employee Group Benefit Plan (the "Plan") provides only general information. Participants should refer to the benefit booklet issued to each employee for a more complete description of the Plan's provisions.

#### **General**

The Plan was established effective November 1, 1983, to administer the Voluntary Employees' Beneficiary Association (VEBA) of B.V. Hedrick Gravel and Sand Company and affiliated companies (the "Sponsor"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### **Benefits**

The Plan provides health benefits (medical, hospital, surgical, prescriptions), dental coverage, vision coverage and life insurance to eligible employees and dependents of the Sponsor subject to payment of deductibles and coinsurance amounts by participants. Participants may purchase short-term and/or long-term disability insurance. An employee is eligible for health and dental benefits and disability payments if they work at least thirty hours per week and complete the required ninety consecutive days of active service.

Current health and dental claims of active participants and their dependents were processed by Healthgram, Inc., but the responsibility for such payments to participants and providers is retained by the Plan. Vision, life, and disability benefits are provided by outside insurance companies.

#### **Contributions**

Benefits are funded through contributions from the Sponsor and from participants. The contribution rates are subject to change at the Sponsor's discretion based on periodic evaluations of the costs of the Plan. The Sponsor contributes each year all amounts in excess of participants' contributions which are necessary to provide current payments under the Plan, and to meet any premium or other charges necessary for the administration of the Plan.

#### **Administrative Fees**

Administrative fees are primarily composed of claims processing and healthcare network fees. The Sponsor pays certain administrative expenses relating to the Plan.

#### **Other**

The Sponsor has the right under the Plan to make changes in any or all parts of the Plan including benefit coverage, deductibles, maximums, co-payments, exclusions, limitations, definitions, or eligibility. The Plan may be terminated, subject to the provisions set forth in ERISA.

### **NOTE B – SIGNIFICANT ACCOUNTING POLICIES**

Significant accounting policies are as follows:

#### **Basis of Accounting**

The accounting records of the Hedrick Employee Group Benefit Plan are maintained on the accrual basis of accounting.

#### **Use of Estimates**

The preparation of the financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, medical claims incurred but not reported, claims payable and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Plan Benefits**

Plan obligations at October 31, 2024 and 2023 for claims incurred by active participants but not reported at that date are estimated by the Plan in accordance with accepted actuarial principles. The cost of incurred but not reported claims should be measured at present value of the estimated ultimate cost to the Plan of settling the claims. Such estimated amounts are reported in the accompanying notes to the financial statements at the present value.

The Plan maintains stop-loss insurance coverage for health costs incurred by participants and their dependents in excess of specified amounts. At October 31, 2024 and 2023, the Plan was insured for claims in excess of \$220,000 annually per individual. It is the present intention of the Sponsor and the Plan to continue obtaining such insurance coverage. Stop-loss recoveries of \$685,835 were netted against medical and dental claims paid in the statement of changes in net assets available for benefits for the year ended October 31, 2024.

#### **Termination Priorities**

Although it has not expressed any intent to do so, the Sponsor reserves the right to terminate, suspend, discontinue, or amend the Plan at any time. Should the Plan be terminated, the Sponsor has no obligation to continue to make contributions to the Plan and the rights of participants are limited to covered expenses incurred prior to termination of the Plan.

### **NOTE C - TAX STATUS**

The Trust established under the Plan to hold the Plan's assets was formed under section 501(c)(9) of the Internal Revenue Code and, accordingly, the Trust's net investment income is exempt from income taxes. The Plan obtained a favorable determination letter, dated March 31, 1988, stating its exemption from federal income tax. The Plan Sponsor believes that the Trust, as amended, continues to qualify and to operate in accordance with applicable provisions of the Internal Revenue Code. The Plan has determined that it does not have any material unrecognized tax benefits or obligations as of October 31, 2024.

The Plan is generally subject to routine audits by the Internal Revenue Service and/or Department of Labor for three years, including 2021, 2022, and 2023. There are currently no audits for any periods in progress.

The present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

### **NOTE F – CONCENTRATIONS OF CREDIT RISK**

The Plan may, at times, have cash deposits in various bank deposits that exceed federally insured limits.
