Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Younes Hospitality Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Younes Hospitality Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note G to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

NOTE A - DESCRIPTION OF PLAN

The following brief description of Younes Hospitality Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Employers participating in the Plan under common control and ownership include the following: Fremont Hotels, Inc., GI Hospitality, Inc., GICS Hospitality, Inc., Hastings Hospitality, HIC Express, Inc., JM Hospitality, Inc., KCS Hospitality, Inc., Kearney Express, Inc., Kearney Hospitality, Inc., Kearney Investment Corporation, Mid Plains Hospitality, NMN Express, Inc., Norfolk Hospitality, Inc., Talmadge Properties, WIN Investments, Y Boutique, Inc., Y Star, Inc., and Younes Hospitality, Inc.

Effective during 2024 Fremont Hotels Inc., Norfolk Hospitality, Inc. and NMN Express In. were removed as participating employers.

General. The Plan, which became effective January 1, 2022, is a defined contribution plan covering certain groups of employees of the above-listed companies (collectively, the Company), who have attained the age of 21 and have completed 60 days of service. Entry is available on the first day of the month subsequent to the employee's completion of the participation requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Sponsor is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Elective Contributions. Each year eligible employees may make pre-tax salary and Roth reduction contributions to the Plan not to exceed Internal Revenue Code limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers 15 mutual funds, held in a pooled separate account, as investment options for participants.

Employer Contributions. The Company may make a flexible discretionary matching contribution or discretionary nonelective contribution on behalf of each eligible participant. Discretionary matching contributions are determined each Plan year and are based on elective deferrals. Nonelective contributions are based on a uniform percentage of participant compensation. During the year ended December 31, 2024, the Company made an employer match contribution for each eligible participant up to 2% of the employee compensation, the total flexible discretionary matching contribution was \$102,425. The Company did not elect to make a discretionary nonelective contribution during the year ended December 31, 2024.

Participant Accounts. Each participant's account is credited with the participant's contribution, and allocations of the Company's contribution and Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting. Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service, upon death, or total permanent disability.

NOTES TO FINANCIAL STATEMENTS

NOTE A - DESCRIPTION OF PLAN - CONTINUED

Payment of Benefits. On termination of service due to death, disability, retirement, or termination, a participant may elect to receive a cash distribution in the form of: (a) a lump sum or (b) substantially equal installments or (c) partial withdrawals with no minimum required. Distributions may be made to a participant who has not separated from service upon reaching age 59 ½. Distributions may be made as soon as administratively feasible at the participant's election.

Termination of employment prior to normal retirement requires distribution if the account balance does not exceed \$7,000. The participant can elect to receive: (a) a direct rollover to an IRA or another qualified retirement plan or (b) a payment in cash, subject to federal tax withholding and generally a penalty tax if under age 59½. If no election is made, the benefit will be rolled over to an IRA. If the account balance is less than \$1,000, the distribution will be paid in cash. If the vested account balance is greater than \$7,000, the participant may defer distribution until normal retirement age or further defer to age 73.

Hardship withdrawals are permitted for the purposes specified by the Internal Revenue Code. Withdrawals cannot exceed the amount of financial need plus any amount necessary to pay taxes or penalties as a result of the withdrawal from accounts that are fully vested.

Forfeited Accounts. Forfeiture accounts are used to pay plan expenses or to reduce any Company contribution. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,238 and \$1,443, respectively. During 2024, \$6,425 of forfeitures were used to pay plan expenses.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting. The financial statements of the Plan have been prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition. The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan utilizes a framework to prioritize the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full-term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTES TO FINANCIAL STATEMENTS

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Employer Contribution Receivable. Employer contribution receivable is measured at the amount owed to participants by the Company at December 31, 2023. There is no employer contribution receivable at December 31, 2024.

Participant Contribution Receivable. Participant contribution receivable is measured at the amount owed to participants accounts that has been withheld from participant paychecks at December 31, 2023. There is no participant contribution receivable at December 31, 2024.

Payment of Benefits. Benefits are recorded when paid.

Expenses. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Expenses incurred for the administration of the Plan are the responsibility of the Plan. If incurred directly by the Plan, these expenses are included in administrative expenses on the statement of changes in net assets available for benefits. Other investment related expenses are included in net appreciation of fair value of investments.

Use of Estimates. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

NOTE C - FAIR VALUE

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used during the year ended December 31, 2024 and 2023.

Pooled separate account: The pooled separate account is valued using net asset value (NAV) as a practical expedient.

The underlying funds are considered open-end mutual funds, meaning that the fund is ready to redeem its shares at any time and offers its shares for sale to the public, either through retail outlets or through institutional investors continuously. For institutional funds, NAVs are received daily from fund managers, and the managers stand ready to transact at these quoted amounts. The insurance company custodian transacts in these funds on a daily basis as part of the separate account trading activity.

Were the plan to initiate a full redemption of the trust, the insurance company custodian reserves the right to temporarily delay payment from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

NOTE C - FAIR VALUE - CONTINUED

Pooled separate account – Continued: The calculation of the NAV for funds composed of other funds (e.g., retirement target date funds) is essentially the same as the calculation of the NAV for any other fund: the total market value of assets across all underlying funds less any liabilities are divided by the outstanding shares. Again, this resulting NAV is published and/or the fund managers are ready to transact at the quoted prices. The Plan does not have any unfunded commitments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTES TO FINANCIAL STATEMENTS

NOTE D - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE E - TAX STATUS

The Plan is based on the Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan of Benefit Plans Inc., which received a determination letter from the IRS dated June 30, 2020, stating that the Prototype Plan was designed in accordance with provisions of the Internal Revenue Code (IRC). The Plan Administrator and the Plan's tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

For the years ended December 31, 2024 and 2023, the Plan had no tax liability on unrelated business activity. The Plan believes that it has appropriate support for any tax positions taken, and as such, does not have any uncertain tax positions that are material to the financial statements. The Plan's Federal Returns for December 31, 2024 and 2023 are subject to examination by the IRS, generally for three years after they were filed.

NOTE F - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE H - PARTY IN INTEREST TRANSACTIONS

The Plan receives custodial services from John Hancock Life Insurance Company and its affiliates (John Hancock), the custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. The Plan also pays for recordkeeping services to Benefit Plans, Inc. (BPI). Fees paid by the Plan to John Hancock for custodial services were \$4,408 and \$935 to BPI for recordkeeping services for the year ended December 31, 2024. The Plan also made direct payments of \$194 and \$4,845 to their investment advisors, Wilshire Associates, Inc. and Edward D. Jones & Co., respectively, during the year ended December 31, 2024. As described in note B, the Plan Sponsor pays directly any other fees related to the Plan's operations.

NOTE I – PROHIBITED TRANSACTIONS

During the year ended December 31, 2023, the plan sponsor failed to remit participant contributions in a timely manner. The plan sponsor identified late remittances of \$10, in which participant contributions were remitted to the plan in violation of the DOL regulations. The plan self-corrected the late remittances on January 29, 2024.
