Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Dr. Brown's Company Savings and Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 And 2023

1. Description Of The Plan

The following description of the Dr. Brown's Company Savings and Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution retirement savings and profit sharing plan sponsored by Dr. Brown's Company (the Employer) under the provisions of Section 401(a) of the Internal Revenue Code (IRC). Employees of Swing-A-Way Manufacturing Company and NILY LLC (also referred to as the Employer) are also eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan was most recently restated as of January 1, 2022. Additionally, the Plan was amended as of April 1, 2024, formally changing the name from Handi-Craft Company Savings and Retirement Plan to Dr. Brown's Savings and Retirement Plan.

Benefit Plan Plus (BPP) is the recordkeeper and third party administrator. John Hancock Life Insurance Company (John Hancock) is the custodian for the investments. Edwards Jones is utilized to review the Plan and monitor performance. The Plan also utilizes Wilshire Associates to assist with review and monitoring of investment performance.

Participation

Substantially all employees (that are non-union or non-leased employees) of the Employer are immediately eligible to make deferral contributions upon hire. Participants enter the Plan on the first day of the month after hire. Participants are eligible to share in the Employer matching contributions upon completing 500 hours of service within the first six months of employment. Participants are eligible to receive profit sharing contributions upon completing one year of service of at least 1,000 hours and must work at least 500 hours or be employed on the last day of the Plan year to be eligible for the contribution.

Contributions

Participants may elect to make contributions up to 100% of eligible compensation. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants who attain age 50 during the Plan year, may elect to make catch-up contributions. Participants may also make contributions representing distributions from other qualified plans (rollovers).

Notes To Financial Statements (*Continued*)

The Employer may elect to make a discretionary matching contribution and/or a discretionary profit sharing contribution. There were no discretionary profit sharing contributions made during 2024 or 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions, Employer contributions and an allocation of Plan earnings and expenses. The allocation of earnings and expenses are determined by the participant's investment selection based on each participant's account balance, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Forfeitures

Forfeitures may be used to pay administrative expenses or to reduce Employer contributions. During the years ended December 31, 2024 and 2023, forfeitures used were \$0 and 5,679 respectively. As of December 31, 2024 and 2023, there were \$31,085 and \$3,950, respectively, available forfeitures for future use.

Vesting

Participants are immediately vested in their elective deferral contributions plus actual earnings thereon. Participants are 20% vested in Employer contributions for each year of service, beginning after the second year of service until they are fully vested after six years of service. Nonvested amounts are forfeited if an employee terminates prior to full vesting. In the event of death or disability of a participant, the participant will automatically become fully vested.

Investment Options

Upon enrollment in the Plan, participants may direct their contributions and Employer contributions in a variety of investment options.

Payment Of Benefits

Participant's account and earnings thereon are distributed upon retirement, death, disability, or other termination of employment. Participants with account balances less than \$5,000 will automatically be distributed out of the Plan. Benefit payments are only distributed in a lump sum.

In-Service Withdrawals

Active participants who reach age 59-½ may withdraw all or part of their vested account balance. Participants who experience a qualifying financial hardship may withdraw all or part of their vested account resulting from their employee contributions. Hardship withdrawals will be approved only if they conform to the Plan and established IRS safe harbor provisions.

Administrative Expenses

The Employer pays significant administrative expenses of the Plan. Each participant will pay certain administrative expenses based on the percentage of assets held in their investment accounts. The investment expenses are netted against earnings and are included in investment income on the statement of changes in net assets available for benefits.

Subsequent Events

Management has evaluated subsequent events through the date of the financial statements were available for issue, which is the date of the Independent Auditor's Report.

2. Summary Of Significant Accounting Policies

Basis Of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Estimates And Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation And Income Recognition

Investments, other than fully benefit-responsive investment contracts, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Investment contracts held by a defined contribution plan are generally reported at contract value, except those contracts that are not fully benefit-responsive. In that instance, these contracts are required to be reported at fair value. In 2023, the Plan's investment in the John Hancock Guaranteed Interest Account was not a fully benefit-responsive investment contract and was reported at fair value in the statement of net assets available for benefits. In 2024, the Plan's investment in the John Hancock Stable Value Guaranteed Income Fund is a fully benefit-responsive investment contract and is reported at contract value in the statement of net assets available for benefits.

Interest income is recorded as earned on the accrual basis. Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. The net change in fair value of investments in the accompanying statement of changes in net assets available for benefits includes realized gains (losses) and unrealized appreciation (depreciation).

Payment Of Benefits

Benefits are recorded when paid.

Subsequent Events

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

3. Certified Financial Information

Financial information relating to the investments and related earnings is included in the financial statements and supplemental schedule and is based on information provided by John Hancock. The Plan Administrator has obtained certifications from John Hancock as of and for the years ended December 31, 2024 and 2023 that such information is complete and accurate. This information has not been audited by the Plan's independent auditors.

4. Fair Value Measurements

The Plan utilizes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Guaranteed Interest Account

For 2023, the Guaranteed Interest Account was valued at fair value by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer. Because the participants transact at contract value, fair value is determined annually for financial statement reporting purposes only. Certain unobservable inputs are assessed through utilizing discount rates applied.

Collective Trust Funds

Valued at NAV, as provided by the fund, and is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments in the funds less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily with no trading restrictions. There is no advanced redemption notice required and no unfunded commitments.

Registered Investment Companies

Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end investment companies that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The investment strategies of the pooled separate accounts are as follows:

- (1) Target date funds seek high total return through its target retirement date, with a greater focus on income beyond the target retirement date.
- (2) Asset allocation funds seek returns commensurate with the amount of risk that a participant has selected.
- (3) Aggressive growth funds seek long-term growth of capital consistent with prudent investment risk.
- (4) Growth funds seek long-term growth of capital.
- (5) Growth and income funds seek long-term growth of capital. Current income is also a consideration.
- (6) Income funds seek a high level of current income.
- (7) Money markets are invested in highly liquid money market accounts.

There have been no changes in the valuation methodologies used at December 31, 2024 or 2023.

5. Fully Benefit-Responsive Investment Contract

The Plan entered into a fully benefit-responsive guaranteed investment contract with John Hancock Life Insurance Company effective February 2, 2024. John Hancock Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. John Hancock Life Insurance Company is contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer of otherwise. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 1%. Such interest rate is reviewed on a quarterly basis for resetting. For the year ended December 31, 2024, the average interest crediting rate was 2.50%.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) the decision by the Plan Sponsor to withdraw all assets from the fund and reinvest in another investment vehicle, (3) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (4) the delivery of any communication to Plan participants designed to influence the participant not to invest in the fund, (5) any change in law, regulation, ruling, administrative or judicial position, or accounting requirement applicable to the Plan. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

6. Income Tax Status

The Plan was amended and restated effective January 1, 2022, through the adoption of a pre-approved plan document. The pre-approved plan document sponsor obtained an opinion letter dated June 30, 2020, which states that the pre-approved plan document satisfies the applicable provisions of the Code. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right to terminate the Plan at any time subject to the provisions of ERISA. Participants will become 100% vested in their accounts.

8. Party In Interest Transactions

During 2024 and 2023 the Plan invested in pooled separate accounts and a guaranteed investment account managed by John Hancock. During 2024, the Plan changed investments to collective trust funds, a fully benefit-responsive investment contract, and registered investment companies. The Plan's investments in collective trust funds, the fully benefit-responsive investment contract and certain registered investment companies are managed by John Hancock. These transactions qualify as allowable party in interest transactions.

9. Risks And Uncertainties

The Plan invests in various investment securities, which in general are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
