Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Emphasis of Matter — Basis of Accounting

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Other Matter — Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, Line 4i—Schedule of Assets (Held At End of Year) (Modified Cash Basis) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

The following description of the Stine Seed Companies Multiple Employer 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan, which was effective January 1, 2008 (date of inception) and amended from time to time, is a defined contribution plan covering all employees of the participating companies who have completed one year of service with 1,000 hours and are age twenty-one or older. Participants are allowed to enter the Plan on the subsequent January 1 or July 1 after becoming eligible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to the maximum allowed by law of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants will have 6% of their pretax annual compensation automatically deferred if no written election is made. The Plan allows participants to designate contributions as Roth contributions. Participants may also rollover amounts representing distributions from other qualified plans and IRAs, at the discretion of the Administrator. The Companies have a safe harbor employer match in which they contribute 100% of the first 1% of deferred compensation plus 50% of the next 5% of deferred compensation. The matching Companies contributions are invested according to the Participant deferral election. Additional profit sharing amounts may be contributed at the option of the Companies’ Board of Directors and are invested according to the Participant deferral election. The Companies made no elective profit-sharing contributions for 2024. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and Companies matching contributions as well as allocations from the Companies profit sharing contribution and Plan earnings and losses as applicable. The Plan permits the payment of Plan expenses to be made from the Plan assets if the Companies do not pay these expenses from their own assets. Expenses are allocated proportionately based upon the value of the account balances or as an equal dollar amount based on the number of participants in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options

Upon enrollment in the Plan, participants may direct deferrals and employer contributions in any of the investment options offered by the Plan. Participants may change their investment options daily.

Vesting

Participants are immediately vested in their contributions plus actual net earnings thereon. Vesting in the Companies safe harbor employer match contributions portion of their accounts plus net earnings thereon is based on years of continuous service. A participant is 100 percent vested after two years of credited service.

Vesting in the employer discretionary profit sharing contribution is based on years of continuous service. A participant is vested according to the following schedule.

Participants become fully vested upon death or attainment of normal retirement age. The Plan does not provide accelerated vesting for disability nor early retirement age.

Participant Loans

The Plan does not allow participant loans. However one participant loan was allowed to rollover into the plan at the approval of the Administrator. The participant loan is recorded at the unpaid principal balance plus any accrued but unpaid interest. Interest income on participant loans is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses was recorded as of December 31, 2024 or 2023. If a participant ceases to make a note repayment and the plan administrator deems the note to be a distribution, the note receivable balance is reduced and a benefit payment is recorded.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant will receive a lump-sum payment in cash equal to the value of the participant's vested interest in the participant's account. Participants may request a withdrawal of their accounts, excluding their matching contributions, in case of financial hardship. The normal retirement age, as defined by the Plan, is the later date at which participants reach the age of 65 or have reached the fifth anniversary of joining the Plan.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$3,218 and \$684, respectively. Forfeited nonvested accounts will be used to reduce future employer contributions or pay plan expenses. For the year ended December 31, 2024, approximately \$655 of forfeitures was utilized to reduce Employer contributions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the plan are prepared on the modified cash basis of accounting, which utilizes the cash basis of accounting while carrying investments at fair value and recording investment income on the accrual basis. All other transactions are recorded on the cash basis.

2. Summary of Significant Accounting Policies-(Continued)

Use of Estimates

The preparation of financial statements in accordance with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value and contract value. Principal Life Insurance Company certifies the contract value of the Principal Stable Value Fund and the fair market value of all other investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Contract value is the relevant measurement for assets invested in fully benefit-responsive investment contracts because the contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

Contributions

Participant contributions and the related Companies matching contributions are recorded in the year in which they are deposited with the custodian, Principal Life Insurance Company.

Participant Loan

The participant loan is measured at its unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Benefits are recorded upon distribution.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid directly by one of the Companies. Expenses that are paid by one of the Companies are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through July 25, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Valued at fair value based on the NAV of units held of the pooled separate account. The NAV is based on the observable market prices of the underlying investments within the fund less liabilities. The NAV for the underlying assets of the fund is a readily determinable measure of their fair value and is the basis used by the fund for current transactions.

Common/collective funds: Valued at fair value based on the NAV of units held of the collective fund. The NAV is based on the observable market prices of the underlying investments within the fund less liabilities. The NAV for the underlying assets of the fund is a readily determinable measure of their fair value and is the basis used by the fund for current transactions.

For years ended December 31, 2024 and 2023, there were no transfers between Levels.

4. Investment at Contract Value

The Plan provides participants a stable value investment option, the Principal Stable Value Fund (the Fund). The objective of the Fund is to provide principal preservation, maintain a stable interest rate, and provide daily liquidity at contract value for participant withdrawals and transfers in accordance with provisions of the Plan. The Fund is considered a fully benefit-responsive synthetic investment contract and therefore is reported at contract value. The Plan values the investment in the Fund at contract value. The Fund is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The Fund invests primarily in investment contracts such as traditional guaranteed investment contracts (GICs), separate account insurance contracts, and wrapper contracts. Traditional GICs are issued by insurance companies, and the underlying investments are held in the issuer's general account. The issuer is contractually obligated to repay the principal and a specified rate of interest guaranteed to the Fund. In a separate account insurance contract, the Fund purchases a contract from an insurance company and the underlying investments are segregated from the insurance company's general account in a separate account set up specifically for the Plan. In a wrapper contract structure, the Fund purchases a wrapper contract from an insurance company or bank and the underlying investments are owned by the Fund and held in trust for the participants.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting rate is based on a formula agreed upon with the contract issuer, but it may not be less than zero. Separate account and wrapper contracts' interest rates are typically reviewed on a monthly or quarterly basis for resetting.

4. Investment at Contract Value-(Continued)

Because changes in the market interest rates affect the yield to maturity and the market value of the underlying investments, they can have a material impact on the contract's interest crediting rate. If the contract value is greater than the market value of the underlying investments, the market value losses will be amortized in the future through lower interest crediting than would otherwise be the case. If the contract value is less than the market value of the underlying investments, the amortization of the market value gains will result in the future crediting rate to be higher than it otherwise would have been.

The key factors that could influence future interest crediting rates for a separate account or wrapper contract include: (1) the level of market interest rates, (2) the amount and timing of participant contributions, transfers, and withdrawals into/out of the contract, (3) the investment returns generated by the fixed-income investment that back the contract, and (4) the duration of the underlying investments backing the contract.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) termination of the Plan, (2) the Company elects to withdraw from a contract to switch to a competing investment option, or (3) other Company events (for example, merger, divestitures, or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan. The Company does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Events that would permit a contract issuer to terminate a contract prior to the scheduled maturity date include the Plan's loss of its qualified status, uncured breach of contract, or material and adverse changes to the provisions of the Plan.

5. Related-Party Transactions and Party-in-Interest Transactions

Two Board of Trustees members are currently participants in the Plan and an officer of the Companies serves as the trustee and plan administrator of the Plan.

The Plan sponsor provides certain administrative and accounting services at no cost and other administrative expenses are paid directly by the Plan sponsor.

The Plan maintains common/collective trusts managed by Principal Global Investors Trust Company and pooled separate accounts managed by Principal Life Insurance Company. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

The Plan paid Principal Life Insurance Company, the custodian and a recordkeeper for the Plan, \$66,072 for investment and administrative services. The Plan paid Newport Group Benefits Consultants, Inc., the administrator for the Plan \$11,206 for administrative services.

6. Plan Termination

Although it has not expressed any intent to do so, the company has the right under the Plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

7. Tax Status

The Plan was an adoption of a pre-approved plan. The pre-approved plan had received a favorable determination letter from the Internal Revenue Service dated March, 31, 2014, which states that the Plan as then designed, qualifies under the applicable provisions of the Internal Revenue Code and that it is therefore, exempt from federal income taxes. The Plan has been amended since adopting the pre-approved plan. In the opinion of the plan administrator the Plan is designed, and currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe the Plan is qualified, and the related trust is tax-exempt.

The modified cash basis of accounting requires plan management to evaluate tax positions taken by the plan and recognize a tax liability of the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on the participant loan for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Principal Life Insurance Company as Plan Custodian held the Plan's investments.
