Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of WinSouth Credit Union Cash Balance Defined Benefit Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of WinSouth Credit Union Cash Balance Defined Benefit Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report.

We are required to be independent of WinSouth Credit Union Cash Balance Defined Benefit Plan and Trust and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about WinSouth Credit Union Cash Balance Defined Benefit Plan and Trust's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedules Required by ERISA

NOTE 1 - PLAN DESCRIPTION

The following description of WinSouth Credit Union (Sponsor) Cash Balance Defined Benefit Plan and Trust (Plan) provides only general information. Participants should refer to the Plan Agreement or Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined benefit plan available to qualifying employees of the Sponsor. To be eligible to participate in the Plan, an employee must have attained the age of 18 and completed six months of service. An eligible employee may enter the Plan on the first day of the Plan year coinciding with or next following the date on which such eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective January 1, 2010, the Plan was restated to change the defined benefit plan and trust to a cash balance defined benefit plan and trust. Under the restatement, employees with continuous employment beginning on or after January 1, 2010, or who were rehired as of or after January 1, 2010, will be covered by a percentage cash balance formula. A cash balance plan is a defined benefit plan that defines the benefit in terms that are more characteristic of a defined contribution plan. It defines the promised benefit in terms of a stated account balance. A hypothetical account is maintained for each participant in which pay credits are credited to the participant's account for the benefit of the individual.

Vesting

Participants become 100% vested in Sponsor contributions after three years of service or reaching early retirement age. A year of service means the applicable computation period during which an employee has completed at least 1,000 hours of service. If participants become totally and permanently disabled or die while still employed by the Sponsor, their benefits also become fully vested.

Payment of Benefits

Upon termination of service, due to death, disability, early or late retirement or separation of service (if accrued benefits are greater than \$1,000), participants may receive their accrued benefits, depending on the circumstances for termination of service, in the form of lump-sum payments or annuity payments under various options. Distributions may be made as soon as administratively feasible following severance of employment.

Administrative Expenses

The Sponsor pays the administrative costs of the Plan associated with any professional services provided to the Plan and the cost of communications to the participants. Administrative expenses paid by the Plan include custodian fees, other recordkeeping fees, and other administrative fees paid directly from the Plan's earnings.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America. In preparing the financial statements, management evaluated subsequent events through July 31, 2025, the date the financial statements were available to be issued.

As required by accounting principles generally accepted in the United States of America, investment contracts held by a defined benefit plan are required to be reported at fair value. The Plan holds an investment in a guaranteed account which is a deposit administration (DA) contract with CUNA Mutual Insurance Society, which is a fully benefit-responsive investment contract. The investment is valued at contract value, which approximates fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined benefit plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The statements of net assets available for benefits present the contract value of the investment in the DA contract.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities and the actuarial present value of accumulated Plan benefits at the date of the financial statements and reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Concentration of Market Risk

As of December 31, 2024 and 2023, approximately 76% and 95%, respectively, of the Plan's net assets were invested in seven and eight mutual funds, respectively. As of December 31, 2024, approximately 24% of the Plan's net assets were invested in the deposit administration contract. The underlying value of the investments is dependent on the performance of the individual investment holding and the market's evaluation of such performance. It is at least reasonably possible that changes in the fair value of the registered investments and deposit administration contract and their investment holdings in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Income Recognition

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year. Realized gains and losses from security transactions are reported on the average cost method.

Fair Value

The established framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Fair value is the price the Plan would expect to receive to sell an asset or pay to transfer a liability in an orderly transaction with a market participant at the measurement date. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs which are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Actuarial Present Value of Accumulated Plan Benefits and Actuarial Assumptions - Continued

Accumulated Plan benefits are those future periodic payments, including lump-sum distributions that are attributable, under the Plan's provisions, to the service employees have rendered. Accumulated Plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. Benefits under the Plan are based on employees' compensation during their five highest consecutive years of credited service.

Accumulated Plan benefits for active employees are based on 50% of their average compensation during their five highest consecutive years of credited service, with a prorated reduction for service less than 25 years, rounded to the nearest \$5, less any applicable offsets to the benefits. Effective January 1, 2010, employees who were hired on or after January 1, 2010 or have a rehire date on or after January 1, 2010, will be covered by a cash balance formula based on years of service. Pay credits equal 6% of compensation as of the last day of the Plan year for each eligible participant that has completed one year of service. Benefits are payable under all circumstances - normal retirement, early or late retirement, death, and separation of employment are included, to the extent they are deemed attributable to employee service rendered and subject to vesting requirements. Benefits to be provided via annuity contracts excluded from the Plan assets are excluded from accumulated Plan benefits.

The actuarial present value of accumulated Plan benefits is determined by an actuary from CUNA Mutual Insurance Society and is the amount that results from applying actuarial assumptions to adjust the accumulated Plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, withdrawal, or retirement) between the valuation date and the date of payment. The significant actuarial assumptions used in the valuations as of December 31, 2024 and 2023 were: (a) life expectancy of participants (the Pri-2012 Mortality Table Projected by Scale MP-2021 for employees before retirement and for annuitants after retirement as of December 31, 2024 and 2023), (b) retirement age assumptions (the assumed average retirement age was 65), (c) investment return of 4.00% as of December 31, 2024 and 2023, (d) discount rate of 7.00% as of December 31, 2024 and 2023, (e) salary scales (percentage increases in participant compensation was 4.50% as of December 31, 2024 and 2023), (f) marriage factors for participants (100% of all participants assumed to be married with the spouse being the same age of the participant as of December 31, 2024 and 2023), (g) disability (no disability is assumed), and (h) turnover (based on participant age - rates of turnover range from 9.70% to 1.60% as participants increase in age from 25 to 55 years old, respectively, as of December 31, 2024 and 2023, Table T7 published by the Society of Actuaries).

Actuarial Present Value of Accumulated Plan Benefits and Actuarial Assumptions - Continued

The actuarial cost method used in measuring the actuarial present value of accumulated Plan benefits and over-or-under funding required by the IRS is known as the entry age normal method. Normal cost is computed as a level percentage of participant salary each year. Entry age into the Plan for each employee at the Plan's outset is the earliest time they would have been eligible under the Plan had it been in existence continuously for the employee's entire service period. For employees becoming eligible after the Plan's adoption, entry age is defined under the Plan (age 18). Normal cost is calculated for the period between the entry and attained retirement dates for participants. Initial supplemental actuarial values (past service costs) for employees becoming eligible upon adoption of the Plan are equivalent to the actuarial values of the normal costs assigned to years between credited entry dates and the date of the Plan's adoption. Actuarial gains and losses are recognized annually and are amortized separately.

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated Plan benefits. The computations of the actuarial present value of accumulated benefits were made as of January 1, 2025 and 2024. Had the valuations been performed as of December 31, there would be no material differences.

Deposit Administration Contract

The deposit administration contract (the Fund) is the CUNA Mutual Guaranteed Account Fund for the years ended December 31, 2024 and 2023.

Participants ordinarily may direct the withdrawal or transfer of all or a portion of their investment at contract value. Contract value represents contributions made to the Fund, plus earnings, less participant withdrawals and administrative expenses. The Fund imposes certain restrictions on the Plan, and the Fund itself may be subject to circumstances that impact its ability to transact at contract value, as described in the following paragraphs. Plan management believes that the occurrence of events that would cause the Fund to transact at less than contract value are not probable.

Restrictions on the Plan - Participant-initiated transactions are those transactions allowed by the Plan, including withdrawals for benefits, loans, or transfers to noncompeting funds within a plan, but excluding withdrawals that are deemed to be caused by the actions of the Plan Sponsor. The following employer-initiated events may limit the ability of the Fund to transact at contract value:

- A failure of the Plan or its trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.
- Complete or partial termination of the Plan or its merger with another plan.

Deposit Administration Contract - Continued

Circumstances that Impact the Fund – CUNA Mutual Group invests the underlying assets of the Fund. The assets in the unallocated general account support the guarantees of principal and interest. Although the Plan assets are not investing directly in this general account, CMFG Life Insurance Company provides contractual protection against a change in the participant’s account value due to interest rate volatility and, therefore, has a financial obligation to repay principal and interest to participants.

There are certain events that may limit the ability of the Plan to transact at contract value with the issuer and participants. These events may include: premature termination of the contract by the Plan, layoffs, Plan termination, bankruptcy, mergers, and early retirement incentives. In the event of contract termination, outside of the normal course of business, it is CMFG Life Insurance Company’s policy to charge a market value adjustment on the deposit administration contract.

Payment of Benefits

Benefit payments to participants are recorded upon distribution. Benefit payments, subject to certain restrictions, can be made in lump-sum distributions or through annuities.

NOTE 3 - INFORMATION CERTIFIED BY THE CUSTODIANS

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the custodians, CMFG Life Insurance Company and Matrix Trust Company, have certified that the following data included in the accompanying financial statements and supplemental schedules is complete and accurate:

- Investments at fair value and contract value, included in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and net appreciation in fair value of investments, included in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- The schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024, included in the supplemental information.
- The schedule H, line 4j - schedule of reportable transactions for the year ended December 31, 2024, included in the supplemental information.

The Plan’s independent accountants did not perform auditing procedures with respect to this information, except for comparing such information with the related information included in the financial statements and supplemental schedules.

NOTE 4 - RELATED PARTY TRANSACTIONS

Plan investments are managed by CMFG Life Insurance Company and Matrix Trust Company, the custodians of the Plan and, therefore, these transactions qualify as party-in-interest transactions.

NOTE 5 - FUNDING POLICY

The Sponsor's funding policy is to make annual contributions to the Plan as determined by the Plan's independent actuary. No employee contributions are permitted. Dividends received on investments for the Plan and forfeitures of participants' non-vested benefits derived from employer contributions shall be applied to reduce future Sponsor contributions. As of December 31, 2024 and 2023, the Sponsor's contributions exceeded the minimum funding requirements of ERISA.

NOTE 6 - RISKS AND UNCERTAINTIES

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Plan contributions are made and the actuarial present value of accumulated Plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

NOTE 7 - PLAN TERMINATION

In the event the Plan terminates, participants will become fully vested in their accrued benefits as of the date of complete or partial Plan termination. Upon complete termination of the Plan, no further employees will become participants, and no further contributions will be made except as required by any governmental agency to which the Plan's termination is subject. Participants' recourse to full and complete satisfaction of their accrued benefits shall be limited to the assets of the Plan plus any amounts provided by the Pension Benefit Guaranty Corporation (PBGC).

Plan assets available to provide benefits upon termination will be allocated as prescribed by ERISA and its related regulations, generally, to provide the following benefits in the order indicated:

- a. Annuity benefits that former employees or their beneficiaries have been receiving for at least three years, or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would have been payable under the Plan provisions in effect at any time during the five years preceding Plan termination.
- b. Other vested benefits insured by the PBGC.
- c. All other vested benefits. (Vested benefits not insured by the PBGC.)
- d. All non-vested benefits.

Whether all participants receive their benefits, should the Plan be terminated at some future time, will depend on the sufficiency, at that time, of the Plan's net assets to provide those benefits, the priority of those benefits to be paid, and the level and type of benefits guaranteed by the PBGC at that time. Some benefits may be fully or partially provided for by the then existing assets and the PBGC guaranty while other benefits may not be provided for at all.

NOTE 8 - FAIR VALUES

The following is a description of the valuation methodology used for assets measured at fair value. There were no changes in the methodology used during the years ended December 31, 2024 or 2023.

- *Mutual funds:* Valued at the net asset value of shares held by the Plan at year end.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 9 - TAX STATUS

The Internal Revenue Service has determined and informed the Plan Sponsor, in a letter dated March 22, 2021, that the Plan is qualified and the trust established under the Plan is tax-exempt under the appropriate sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Tax positions are recognized in the financial statements when it is more likely than not that the position will be sustained by the tax authorities.

As of December 31, 2024 and 2023, the Plan had no uncertain tax positions that qualify for either recognition or disclosure in the financial statements for open tax years based on an assessment of many factors including experience and interpretations of tax laws.


