### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of Chr. Hansen Investment and Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024,, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Chr. Hansen Investment and Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### Note 1: Description of Plan

The Chr. Hansen Investment and Retirement Plan (the Plan) is a participant-directed defined contribution plan sponsored by Chr. Hansen, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### Eligibility

Employees of the Company and any authorized affiliates who are citizens of the United States, paid on the Company's U.S. payroll, and 18 years of age or older, are eligible to participate in the Plan.

#### Contributions

Participants can contribute to the Plan up to 80% of their compensation subject to limits set by the Internal Revenue Service (IRS). Participants, unless they elect otherwise, are automatically enrolled in the Plan at a deferral rate of 6%. The Plan allows participants over age 50 to make catch-up contributions. Participants may also contribute distributions from other qualified plans (Rollovers).

The Company makes a safe harbor employer basic contribution for each participant equal to 4% of the participant's plan eligible compensation for the pay period. The Company also makes matching contributions at the rate of 66-2/3% of each participant's contribution up to 6% of their compensation. Certain hourly culture plant participants receive additional safe harbor employer basic and matching contributions. The Company may also, at its sole discretion, make supplemental contributions. The Company made no supplemental contributions in 2024.

#### Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions along with an allocation of the Company's basic, matching, and supplemental contributions and charged with an allocation of expenses that are paid by the Plan. Earnings (losses) of the Plan are allocated based upon the relationship of a participant's account balance to the total of all account balances for each investment option. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Payment of Benefits

On termination of service due to death, disability, separation or retirement, a participant (or their beneficiary) may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants may receive distributions at retirement, or if the balance in the account exceeds \$7,000, they may defer payment. Participant accounts with values of less than \$1,000 will be paid in a lump-sum distribution as soon as administratively feasible after termination of employment. If the participant account is greater than \$1,000, but is less than \$7,000, and the participant has not elected a rollover into an eligible retirement plan or a cash distribution, the plan administrator will distribute the balance into an individual retirement account as soon as administratively feasible after termination of employment. The Plan allows for participants to take hardship distributions if all requirements, as defined, are met.

#### Vesting

Participants are immediately fully vested in their contributions and earnings thereon. The vesting schedule for the Company matching account and safe harbor employer basic account (except that portion of the employer account attributable to safe harbor employer basic contributions made for periods after December 31, 2012) are as follows: 20% after one full year of service, 40% after two full years, 60% after three full years, 80% after four full years, and 100% after five full years.

The vesting schedule for safe harbor employer basic contributions made to the employer account for periods after December 31, 2012, are as follows: 0% less than 2 full years of service and 100% after 2 full years of service.

#### Forfeitures

Forfeitures arise as a result of participants who terminate service before becoming 100% vested in the Company contributions. Forfeited non-vested amounts can be used to reduce future Company contributions or to pay plan administrative expenses. Matching contributions were reduced by \$374,287 in 2024 by allocating forfeited non-vested accounts. Administrative expenses were reduced by \$10,495 in 2024 by allocating forfeited non-vested accounts. Unallocated forfeitures were \$36,426 and \$86,991 as of December 31, 2024 and 2023, respectively.

#### Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50% of their account balances. Notes are repaid over a period not to exceed ten years for primary residence loans and five years for all other loans. The notes are secured by the balance in the participant's account and bear interest at a commercially reasonable fixed interest rate. The interest rates on all notes outstanding at December 31, 2024 ranged from 4.25%-9.50%. Principal and interest are paid ratably through payroll deductions.

### Note 2: Summary of Significant Accounting Policies

#### Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### Use of Estimates in Preparation of Financial Statements

The preparation of the accompanying financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results may differ from these estimates and are subject to change in the near term.

#### **Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan Administrator deems the participant to be in default, the participant loan balance is reduced and the benefit payment is recorded based on the terms of the Plan documents.

#### **Payment of Benefits**

Benefit payments to participants are recorded when paid.

#### **Plan Expenses**

Plan administrative expenses and investment advisory fees are paid by the Plan. The amount allocated to each participant is dependent upon the participant's account balance and investment mix. Professional fees, and certain other expenses incurred in conjunction with the Plan, are paid by the Company and are not included in these financial statements.

#### **Subsequent Events**

Subsequent events have been evaluated through July 16, 2025, which is the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

GAAP specifies a three-tier fair value hierarchy, which prioritizes the inputs used in estimating fair value. These tiers include Level 1, defined as observable inputs such as quoted market prices in active markets; Level 2, defined as inputs other than quoted market prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore, requiring an entity to develop its own assumptions.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust:* Fair value is estimated using the NAV per unit by the issuer of the collective trust and is based on the fair value of the underlying investments held by the collective trust. The objective of the Stable Pooled Fund is to provide a moderate level of stable income without principal volatility. The collective fund seeks to maintain safety of principal while obtaining consistent, low volatility return superior to other high quality alternatives over a full interest rate cycle. Investments in the collective trust can be purchased and sold continuously. Plan level redemptions occur at NAV following a 12-month notice period. The Plan has no obligation to buy additional units.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **Note 5: Income Tax Status**

The IRS has determined and informed the Plan by a letter, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

### **Note 6: Risks and Uncertainties**

The Plan's investment securities are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 7: Related-Party and Party-In-Interest**

Transactions involving funds administered by the custodian, or affiliates of the custodian, notes receivable from participants, and administrative expenses qualify as party-in-interest transactions. These transactions are not considered prohibited under ERISA.

### **Note 8: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right to terminate or partially terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.
