## **INDEPENDENT AUDITOR'S REPORT**

To the Administrative Committee and Participants of  
The Honey Baked Ham Company, LLC 401(k) Plan and Trust

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of The Honey Baked Ham Company, LLC 401(k) Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (the financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements is complete and accurate.

### **Opinion**

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of the report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. ### 1. Description of Plan

The following description of The Honey Baked Ham Company, LLC 401(k) Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan and is sponsored by The Honey Baked Ham Company, LLC (the Company). The Plan allows all employees, other than those classified as seasonal, to participate in the Plan upon obtaining six months of service and attainment of age 18. Employees classified as seasonal are eligible to participate in the Plan upon attainment of age 21 and completion of 1,000 service hours during the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The following business units of the Company participate in the Plan:

- The Honey Baked Ham Company, LLC
- The HBH Gifting Company, LLC
- The HBH Franchise Company, LLC
- The Franchise Holding Company, LLC
- HBH California, LLC

#### Contributions

Participants may make pre-tax and/or Roth contributions of up to 50% of their eligible compensation as defined by the Plan document, not to exceed a maximum of \$23,000, plus an additional \$7,500 for participants at or above age 50, in 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Employees are automatically enrolled in the Plan upon meeting eligibility requirements at a rate of 1% of eligible compensation, unless the participant elects otherwise. This automatic contribution rate will increase by 1% annually, up to a maximum of 5% of eligible compensation, unless the participant elects otherwise.

The Company makes a matching contribution in an amount equal to 100% of participant deferral contributions, not exceeding 3% of eligible compensation contributed to the Plan and 50% of the next 2% of eligible compensation contributed to the Plan, up to a maximum matching contribution of 4% of the participant's eligible compensation. This contribution is made every pay period.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions, rollovers, the employer matching contribution and earnings and losses on the investments in their account, and is charged with certain participant transaction fees and an allocation of administrative expenses based on participant pro-rata account balances. Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are immediately vested in all contributions, plus actual earnings thereon. Participants who previously participated in the Plan may be subject to different vesting schedules.

### **Notes Receivable from Participants**

Participants may borrow from their accounts up to the lesser of \$50,000 or 50% of the participant's vested balance reduced by the highest outstanding loan balance from the participant's account during the prior twelve-month period. Loans are typically made for a period not exceeding five years, or ten years if used for the purchase of a primary residence. The loans bear interest at the prime rate plus 1% and are secured by the balance in the participant's account. The interest rate on the loans outstanding at December 31, 2024 ranged from 4.25% to 9.50%. Principal and interest are paid through payroll deductions or by other means as specified in the participant's loan agreement. Each participant is limited to one outstanding loan at any time. Notes receivable from participants also qualify as party-in-interest transactions.

### **Payment of Benefits**

At the time of retirement, death, disability, or termination of employment, a participant or their beneficiary may receive the payment of the vested interest in their account in a lump sum distribution. Participants may also elect to receive distributions under a systematic withdrawal plan. If the account balance is \$1,000 or less, the Plan may, upon termination of service, pay the benefits owed in a lump sum. In-service withdrawals are also permitted for participants who have attained age 59½. Participants' account balances between \$1,000 and \$7,000 will be automatically rolled over to an individual retirement account, unless the participant elects otherwise. Participants are eligible to receive hardship withdrawals when certain conditions are met.

#### **Administrative Expenses**

Certain administrative expenses may be paid by the Company. The Company does not expect reimbursement from the Plan for these expenses. Those administrative expenses not paid by the Company are allocated pro-rata amongst the accounts of all Plan participants based on participant account balances. Transaction fees related to specific participant transactions are charged directly to the specific participant account. Administrative fees of \$43,966 were charged to participants during the year ended December 31, 2024. These expenses are paid to service providers of the Plan and therefore qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net change in fair value of investments as they are paid through revenue sharing rather than a direct payment.

#### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited accounts totaled \$2,399 and \$1,353, respectively. These accounts shall be used first to reduce administrative expenses, then employer matching contributions, and then allocated to participants. During 2024, the Plan used \$699 of forfeitures to pay for administrative expenses.

## **2. Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The financial statements of the Plan are presented on the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### **Contributions**

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The employer matching contributions are considered payable to the Plan when the related participant's contributions are payable to the Plan.

#### **Valuation of Investments**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net change in fair value of investments includes interest, dividends and realized and unrealized gains and losses on those investments. Interest income is recorded when received.

#### **Notes Receivable from Participants**

Notes receivable from participants are carried at their outstanding balance. Interest income is recognized when received, primarily every payroll period. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded as a deemed distribution.

#### **Payment of Benefits**

Benefit payments are recorded when paid.

#### **Subsequent Events**

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through July 30, 2025, which is the date the financial statements were available to be issued.

### **3. Information Certified by the Qualified Institution**

All information in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and the net change in fair value of investments and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company (Fidelity), a service provider to the Plan.

### 4. Investments

Plan investments include certain mutual funds and a money market fund managed by Fidelity. Fidelity is the service provider as defined by the Plan; therefore, transactions in these investments qualify as party-in-interest transactions. Revenue sharing related to the Plan's investments in mutual funds is credited to net change in fair value of investments.

Investments are exposed to various risks, such as market, currency, interest rate and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include healthcare crises, such as a pandemic, international conflicts, supply chain disruptions, global monetary policy decisions, significant exogenous economic influences, significant cybersecurity attacks, and other similar events. It is at least reasonably possible that changes in their fair value will occur in the near term and that such changes could materially affect participants' account balances.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs.

The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices in active markets for similar securities

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in mutual funds and the money market fund are stated at quoted market prices for the identical security in an active market (Level 1).

Beginning in 2024, the Plan also invests in a stable value fund, which is primarily invested in fully benefit-responsive guaranteed investment contracts (GICs), which are general obligations of the insurance companies that issue the contracts, and security-backed contracts. The stable value fund trades at net asset value (NAV), which is based on the contract value of the underlying GIC investments. Participants transact at NAV daily (Level 1). There are no restrictions on withdrawal of these funds, except that if the Company were to remove this investment option from the Plan, they would have to provide twelve months' notice prior to liquidating this investment.

### 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### 6. Income Tax Status

In September 2021, the Plan that was based on a Volume Submitter Profit Sharing Plan with CODA (volume submitter plan) sponsored by Fidelity Management & Research Co. (FMRC) moved to a Non-Standardized Pre-Approved Profit Sharing Plan with CODA (pre-approved plan) sponsored by FMR LLC (doing business as Fidelity Institutional Asset Management). The IRS has opined and informed FMR LLC by letter dated June 30, 2020, that the pre-approved plan is designed in accordance with the applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the FMR LLC opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by taxing authorities and may change upon examination.

## **INDEPENDENT AUDITOR'S REPORT**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

# The Honey Baked Ham Company, LLC 401(k) Plan and Trust

### 1. Description of Plan

The following description of The Honey Baked Ham Company, LLC 401(k) Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan and is sponsored by The Honey Baked Ham Company, LLC (the Company). The Plan allows all employees, other than those classified as seasonal, to participate in the Plan upon obtaining six months of service and attainment of age 18. Employees classified as seasonal are eligible to participate in the Plan upon attainment of age 21 and completion of 1,000 service hours during the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The following business units of the Company participate in the Plan:

- The Honey Baked Ham Company, LLC
- The HBH Gifting Company, LLC
- The HBH Franchise Company, LLC
- The Franchise Holding Company, LLC
- HBH California, LLC

#### Contributions

Participants may make pre-tax and/or Roth contributions of up to 50% of their eligible compensation as defined by the Plan document, not to exceed a maximum of \$23,000, plus an additional \$7,500 for participants at or above age 50, in 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Employees are automatically enrolled in the Plan upon meeting eligibility requirements at a rate of 1% of eligible compensation, unless the participant elects otherwise. This automatic contribution rate will increase by 1% annually, up to a maximum of 5% of eligible compensation, unless the participant elects otherwise.

The Company makes a matching contribution in an amount equal to 100% of participant deferral contributions, not exceeding 3% of eligible compensation contributed to the Plan and 50% of the next 2% of eligible compensation contributed to the Plan, up to a maximum matching contribution of 4% of the participant's eligible compensation. This contribution is made every pay period.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions, rollovers, the employer matching contribution and earnings and losses on the investments in their account, and is charged with certain participant transaction fees and an allocation of administrative expenses based on participant pro-rata account balances. Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are immediately vested in all contributions, plus actual earnings thereon. Participants who previously participated in the Plan may be subject to different vesting schedules.

### **Notes Receivable from Participants**

Participants may borrow from their accounts up to the lesser of \$50,000 or 50% of the participant's vested balance reduced by the highest outstanding loan balance from the participant's account during the prior twelve-month period. Loans are typically made for a period not exceeding five years, or ten years if used for the purchase of a primary residence. The loans bear interest at the prime rate plus 1% and are secured by the balance in the participant's account. The interest rate on the loans outstanding at December 31, 2024 ranged from 4.25% to 9.50%. Principal and interest are paid through payroll deductions or by other means as specified in the participant's loan agreement. Each participant is limited to one outstanding loan at any time. Notes receivable from participants also qualify as party-in-interest transactions.

### **Payment of Benefits**

At the time of retirement, death, disability, or termination of employment, a participant or their beneficiary may receive the payment of the vested interest in their account in a lump sum distribution. Participants may also elect to receive distributions under a systematic withdrawal plan. If the account balance is \$1,000 or less, the Plan may, upon termination of service, pay the benefits owed in a lump sum. In-service withdrawals are also permitted for participants who have attained age 59½. Participants' account balances between \$1,000 and \$7,000 will be automatically rolled over to an individual retirement account, unless the participant elects otherwise. Participants are eligible to receive hardship withdrawals when certain conditions are met.

### **Administrative Expenses**

Certain administrative expenses may be paid by the Company. The Company does not expect reimbursement from the Plan for these expenses. Those administrative expenses not paid by the Company are allocated pro-rata amongst the accounts of all Plan participants based on participant account balances. Transaction fees related to specific participant transactions are charged directly to the specific participant account. Administrative fees of \$43,966 were charged to participants during the year ended December 31, 2024. These expenses are paid to service providers of the Plan and therefore qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net change in fair value of investments as they are paid through revenue sharing rather than a direct payment.

### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited accounts totaled \$2,399 and \$1,353, respectively. These accounts shall be used first to reduce administrative expenses, then employer matching contributions, and then allocated to participants. During 2024, the Plan used \$699 of forfeitures to pay for administrative expenses.

## **2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are presented on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### **Contributions**

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The employer matching contributions are considered payable to the Plan when the related participant's contributions are payable to the Plan.

#### **Valuation of Investments**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net change in fair value of investments includes interest, dividends and realized and unrealized gains and losses on those investments. Interest income is recorded when received.

#### **Notes Receivable from Participants**

Notes receivable from participants are carried at their outstanding balance. Interest income is recognized when received, primarily every payroll period. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded as a deemed distribution.

#### **Payment of Benefits**

Benefit payments are recorded when paid.

#### **Subsequent Events**

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through July 30, 2025, which is the date the financial statements were available to be issued.

### **3. Information Certified by the Qualified Institution**

All information in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and the net change in fair value of investments and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company (Fidelity), a service provider to the Plan.

### 4. Investments

Plan investments include certain mutual funds and a money market fund managed by Fidelity. Fidelity is the service provider as defined by the Plan; therefore, transactions in these investments qualify as party-in-interest transactions. Revenue sharing related to the Plan's investments in mutual funds is credited to net change in fair value of investments.

Investments are exposed to various risks, such as market, currency, interest rate and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include healthcare crises, such as a pandemic, international conflicts, supply chain disruptions, global monetary policy decisions, significant exogenous economic influences, significant cybersecurity attacks, and other similar events. It is at least reasonably possible that changes in their fair value will occur in the near term and that such changes could materially affect participants' account balances.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs.

The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices in active markets for similar securities

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in mutual funds and the money market fund are stated at quoted market prices for the identical security in an active market (Level 1).

Beginning in 2024, the Plan also invests in a stable value fund, which is primarily invested in fully benefit-responsive guaranteed investment contracts (GICs), which are general obligations of the insurance companies that issue the contracts, and security-backed contracts. The stable value fund trades at net asset value (NAV), which is based on the contract value of the underlying GIC investments. Participants transact at NAV daily (Level 1). There are no restrictions on withdrawal of these funds, except that if the Company were to remove this investment option from the Plan, they would have to provide twelve months' notice prior to liquidating this investment.

### 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### 6. Income Tax Status

In September 2021, the Plan that was based on a Volume Submitter Profit Sharing Plan with CODA (volume submitter plan) sponsored by Fidelity Management & Research Co. (FMRC) moved to a Non-Standardized Pre-Approved Profit Sharing Plan with CODA (pre-approved plan) sponsored by FMR LLC (doing business as Fidelity Institutional Asset Management). The IRS has opined and informed FMR LLC by letter dated June 30, 2020, that the pre-approved plan is designed in accordance with the applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the FMR LLC opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by taxing authorities and may change upon examination.
